| | | | | | <p>B.A. #1205 –Pilot Travel Centers, Request for Height Variance for the Pilots Pole Sign.</p> <p>Landon Lane stated they were requesting a height variance for a 50ft sign. He states they are at a disadvantage and hardship with the Love’s Truck Stop sign across them is 42 ft tall and would block their sign if they put in a 30ft sign. They would like the city to consider their request. They are not asking the city to change the ordinance but just to consider their request and hardship. Bringing in a Pilot’s Travel Center to Andrews would bring in 40-50 jobs and sales tax. They need to be able to put up a sign that would be tall enough for the public to see their price and compare to Love’s Truck Stop. Gail stated we the city of Andrews would really like to have their business but we have ordinances and restrictions that we have to follow. Druex Garrett (Code Enforcement Officer) stated the Sign Code changed in 2014 after Love’s put up their sign. Before they put up their sign there were no restrictions on height on signs. They are non-conforming and we are working on talking to Loves’ about considering lowering their sign. Druex stated his fear is that other businesses will also start requesting height variances as well and creating a bigger problem and setting a precedence. Druex asked Landon to maybe consider placing a monument sign or a billboard to advertise their business and prices. Druex also advised the board to consider approval with a condition that Love’s lowers their sign. Gail stated we do not want to exceed height in order to maintain the integrity of our city. In business we like to follow the law and do not want to go against the code. Rufus stated he stands with Gail and if we allow them to exceed height then more businesses will want the same allowance. The board advised Landon to table the request until we make contact with Loves’ and request them to conform to the code and lower their sign. We will come back May 20, 2019 meeting.</p> |
