On August 14th the Canvassers requested that the Central Lake Township Clerk with her Inspectors bring election results – such as ballot containers/applications to vote and poll book.

The meeting was called to order at 9:00 a.m. by the Chairperson, Janet Olach.

The County Clerk spoke of the process in which the canvassers were proceeding with the canvass of the Central Lake Township results.

The inspectors matched the seals number and proceeded to break the seals to open the ballot container. Counted in sets of 25 and counted two (2) times to verify number counted totaled 663. The tabulator was cleared and set up to re-tabulate the VAT ballots processed. Totals matched to counts provided by the inspectors on election night. Duplicated/Spoiled/Absentee Ballots/Unreturned Absent Ballots/Not signed Absentee Ballots all accounted for and addressed in notes. The Poll Book total was reported 664 Tabulator total 663. One (1) Absentee Voter was listed in the paper Poll Book but did not return his ballot it was destroyed by accident. The same voter appeared to vote in person on Election Day and his name was again entered into the paper Poll Book.

The Board of Canvassers agreed that they are satisfied with the Central Lake Township Poll Book Total 663 and Tabulated total 663 and therefore, certified the results.

The election inspectors and the Central Lake Clerk resealed all containers and placed new seal number onto all poll books and canisters. All materials were returned to the local clerk.

The Canvassers took a break at 11:45 a.m. and returned to continue their canvass on those townships not canvassed on August 8, 2018

The Board of Canvassers certified all Townships and signed all certificates.

The meeting adjourned at 4:00 p.m.
