#### 4. Approval of Minutes

#### 6. Northern Lakes Economic Alliance (NLEA) Update

Andy Hayes, NLEA President, announced that Janet Koch has moved on from NLEA to Wexford County as the County Administrator. Mr. Hayes said they are still committed to reporting to the EDC. He distributed an inflow and outflow count sheet for job distribution. The sheet shows how many people come to Antrim County to work, live and work in Antrim County, and those who live in Antrim but leave.

Mr. Hayes updated the Corporation on the efforts to bring broadband to Antrim County. He said the smaller population of the County makes it difficult to attract private investment from companies. He indicated there is fiber that is currently available to government, schools, and hospitals. He said they have found a way to tap in to the fiber's backbone, which could be used for business because of NLEA's economic development non-profit status. Mr. Hayes spoke about the Broadband Consortium agreement, which is progressing with member counties joining.

Rachel Krino asked about TruStream and how the NLEA Broadband Consortium works. Mr. Hayes said that GLE is running a pilot in Emmet County to provide internet to rural areas. Currently, the internet will be accessible only to Great Lakes Energy (GLE) Customers, while the Consortium may be able to help others.

Ms. Comben asked about the NLEA's sustainability now that Emmet County has withdrawn their support. Mr. Hayes said Emmet County's decision came down to money, but they are still in negotiations. He also indicated the NLEA had a reserve fund, which will help. Mr. Hayes said they have learned to be more informative at the County level.

Hannah Sanderson, NLEA Business Attraction and Growth Specialist, spoke about the NLEA summer internship program. She said the interns will be working on marketing packages for "shovel ready" development sites, some of which are in Antrim County. Ms. Sanderson also provided information on an "entrepreneurial tool kit." This has much information to help new businesses develop.

Seth Gernot, one of the winners of the 2018 Pitch Night, spoke to the Corporation about the winning pitch for Yoga Bellaire.

#### 7. 2018 EDC Annual Report

#### 1. Call to Order

The meeting was called to order at 9:00 by Mike Allison.

#### 2. Public Comment

Mr. Allison said he was happy to see so many people at the meeting.

#### 3. Approval of Minutes

Motion by Dave Heeres, seconded by Kathy Peterson, to approve the minutes of February 16, 2019 as presented.

**Motion passed - unanimous** 

#### 4. Northern Lakes Economic Alliance (NLEA) Update

Andy Hayes, President of the NLEA, introduced Buck Love to the committee. Mr. Hayes gave a brief presentation showing what the NLEA is and what it does for the member counties. He told the committee that they will continue to update the EDC on a quarterly basis. Jessica Lovey, NLEA Grant Administrator, will be at the July meeting to talk about how the NLEA works with its member counties on grant writing. Mr. Hayes indicated that he would be presenting the organization's annual report to the Board of Commissioners at their April 18, 2019 meeting.

Buck Love spoke to the committee about the NLEA's work to assist base employers located in member counties with business retention. They are also working with smaller companies dealing with potential expansion and growth. Mr. Love also touched on the NLEA's collaborative effort with North Central Michigan College that resulted in a mobile computer numeric control (CNC) lab. The lab travels to various locations throughout the member counties, including high schools, as part of an effort to assist companies with recruitment and expansion.

Dave Heeres asked about the status of the NLEA situation with Emmet County. Mr. Hayes indicated an ad hoc committee has been put together to consider a solution that will work for Emmet County and the NLEA. If an agreement cannot be reached, Emmet County will not be a member county. The ad hoc committee meets on April 16.

#### 5. Area Chambers of Commerce

At the February meeting, there was discussion about the possibility of the EDC joining local area chambers of commerce. Rachel Krino expressed surprise at the cost of membership for the East Jordan Chamber. Pete Garwood, County Administrator, said there was nothing in the 2019 budget for memberships, but it was possible to look at the budget and possibly shift monies around. Ms. Krino said she was interested in considering memberships for the 2020 budget.

Mr. Allison expressed interest in inviting area chambers in to talk to the committee. Veronica Welter asked how becoming a chamber member would relate to the mission statement of the EDC, to "retain, expand, and promote County-wide growth and stability" and if there was a possibility of having chamber executives come to EDC meetings on a regularly scheduled basis. Ms. Krino indicated that is something that she does as a Bellaire chamber staff member with other organizations.

Ms. Krino said she would contact the East Jordan Chamber regarding the cost of membership for the EDC.

Mr. Allison tabled the discussion until more information can be gathered. This topic will be put on the May agenda.

#### 6. Request for Letter of Support: Affordable Housing Study

Mr. Allison requested a letter of support from the EDC for an affordable housing study in the Village of Mancelona. The Village has received a number of grants that will be put toward the cost of the study.

Motion by Sherry Comben, seconded by Rachel Krino to direct the Administration Office to write a letter of support for an affordable housing study in Mancelona. Motion passed - unanimous

Mr. Garwood asked that Mr. Allison provide his office with more information on the study.

#### 9. Various Matters

#### Facilities Master Plan Forum

Ms. Krino said the Village of Bellaire is working with the Bellaire Downtown Development Authority (DDA) and they have developed a committee, the Bellaire Economic Development Committee (BEDC), that would like to come to a future EDC meeting. It was the consensus of the committee to invite the BEDC to attend a meeting. Ms. Krino will have a representative of the BEDC contact the Administration Office.

Mr. Garwood reminded the committee about the Facilities Master Plan forum on April 23<sup>rd</sup> at Meadowbrook Medical Care Facility in Bellaire. Ms. Krino indicated the BEDC will be attending the forum.

#### Road Map Update

Mr. Garwood updated the committee on the status of the Antrim County road map. He indicated there will be more parks featured on the map.

#### **10. Public Comment**

Mr. Boettcher spoke to the committee on the issue of affordable housing. He said it was important to consider transportation in discussions related to affordable housing.

Ms. Krino indicated the Chamber of Commerce has hired a new executive director. She will be introduced to the public at the annual chamber dinner on May 14, 2019. The current executive is retiring. Ms. Krino also said a representative from the Pure Michigan campaign will be coming to Bellaire to do a training session with chamber members on May 20, 2019 at Shanty Creek Resort in the Cedar River Hotel.

John Meeske said he is concerned with the number of golf courses that are currently closing around the country. Given the number of courses in the area, he said there is a very real possibility of area home values being negatively affected.

Ms. Peterson said the Elk Rapids Chamber of Commerce is holding a Business After Hours at 7:00 pm on April 18, 2019 at the Blue Heron Gallery.

Mr. Allison said a grant has been submitted to the Michigan Department of Natural Resources (DNR) for upgrades to Palmer Park. He said the Redevelopment Ready process continues.

Motion by Dave Heeres, seconded by Veronica Welter to adjourn the meeting. Motion passed - unanimous

#### 1. Call to Order

The meeting was called to order at 9:00 by Mike Allison, President.

#### 2. Public Comment

Mike Allison informed the group he would need to leave by 10:30.

#### 3. Approval of Minutes

Motion by Dave Heeres, seconded by Rachel Krino, to approve the minutes of May 20, 2019 as presented.

**Motion passed - unanimous** 

#### 4. Bellaire Economic Development Committee – David Schulz

David Schulz, Village President, spoke to the committee about the Bellaire Economic Development Committee (BEDC), a shared committee between the Village of Bellaire and the Bellaire Downtown Development Authority (DDA). The goal of this new committee was to foster continued communications between the County, the Village, and the DDA. Mr. Schulz encouraged all present to read through the Facilities Master Plan survey report that was included in the June 20, 2019 Board of Commissioners agenda packet, the Administrator's Report which is also included in the 6/20 Board packet, and the new Bellaire Master Plan (link here).

Mr. Schulz indicated the BEDC had originally planned on presenting two potential Antrim County campus options, both of which focus on economic development and operational efficiency (see attached pgs. 3-22). He said in light of the results of the Networks Northwest survey report, he would instead be discussing the survey report. Mr. Schulz noted the survey results showed Antrim County residents were most concerned about whether new facilities would increase taxes but residents also expressed interest in the cost of new facilities and how new facilities would encourage economic development.

Mr. Schulz indicated the costs presented by Byce & Associates for the various proposed options did not take into consideration a number of factors including:

- Lower maintenance costs associated with newer facilities;
- New efficiencies associated with newer facilities;
- An increase to County coffers of approximately \$33,000 annually;

- Proceeds from the sale of the building and/or property would offset the cost of building new facilities;
- Presented costs did not include the cost of modular buildings for temporary office space during construction; moving all offices at the same time to new facilities would mitigate that cost.

Mr. Schulz asked the committee to consider relocating the facilities an investment in economic development in one of the County's constituent villages, citing the Elk Rapids Tax Increment Financing (TIF) plan, the tax abatement offered by Warner Township to the new EJ facilities, and the tax abatement offered by the Village to Crusecom as examples of successful collaborations between public and private entities. Mr. Schulz asked members to read the survey report, the Village Master Plan, and the BEDC requests, and consider how they are consistent with the EDC's mission statement. He reminded the committee the ideas presented by the BEDC were only conceptual and should not be considered definitive requests.

Dave Heeres asked Mr. Schulz to keep in mind Bellaire is the County seat and is the driving force behind decisions made regarding the Facilities Master Plan.

Mr. Schulz noted water mains under Broad Street are being replaced due to a state mandate regarding lead pipes. He said it would help the Village plan for this project if it knew whether new municipal facilities should be taken into consideration. He also indicated the current wastewater treatment facilities are run on a seasonal schedule. Plans for new governmental facility could turn the facility into a year-round need.

#### 5. Presentation: Chambers of Commerce

Elk Rapids – Tom Kern and Laura Savoie (attached pg. 23)

Tom Kern, Executive Director of the Elk Rapids Chamber of Commerce (ERCC), and Laura Savoie, Director of Membership, provided membership information to the committee (see attached). Mr. Kern spoke to the committee on the ERCC and how a membership would benefit the EDC. He indicated the ERCC is aligned with Traverse Connect, rather than the Northern Lakes Economic Alliance (NLEA), because Elk Rapids is economically tied more closely to the Traverse City area more than the northern part of Antrim County or the four county members of the NLEA. Mr. Kern said two of the main goals for the ERCC are:

- Working with agencies to bring broadband fiber optics to Elk Rapids to encourage entrepreneurship, draw more businesses, and increase the number of year-round residents; and
- Bring more affordable housing to Elk Rapids in order to draw more people to the area. The ERCC is currently taking an inventory of the area to determine what vacant properties are available for housing development.

Ms. Savoie said the County has had a complimentary Chamber membership for a number of years, though the County may not be aware of it. This membership was meant to keep the County up to date on what is happening economically on the west side.

Mancelona – Joanie Moore, Donna Gundle-Krieg (attached pg. 24)

Joanie Moore, Executive Director, introduced Donna Gundle-Krieg, Chamber Secretary, to the group. Ms. Moores said the Mancelona chamber focuses on the assets the inland village has to offer such as the 131 Corridor, a number of recreational parks, and a number of opportunities for hunting, fishing, and snowmobiling. Ms. Moore highlighted popular chamber events that take place in Mancelona, such as the Mancelona Buck Pole, the White Pine Stampede, and the Bass

Festival. She indicated the Buck Pole is heavily supported by local businesses and was voted the most popular "buck pole" in Michigan.

Ms. Gundle-Krieg said she has been talking with people on affordable housing. She said the biggest hurdle to overcome is the lack of infrastructure. She noted a number of housing developers have been working to make Mancelona a bedroom community to Traverse City and Gaylord. Ms. Gundle-Krieg indicated people are wanting to invest in Downtown Mancelona, though current building owners are hesitant to sell their buildings.

#### 1. Call to Order

The meeting was called to order at 9:00 by Mike Allison, President.

#### 2. Public Comment

None.

#### 3. Approval of Minutes

Bonnie Robbins noted the misspelling of Joanie Moore's name at the bottom of page two (2).

Motion by Dave Heeres, seconded by Veronica Welter, to approve the minutes of June 18, 2019 as corrected.

**Motion carries - unanimous** 

#### 4. Presentation: East Jordan Chamber of Commerce

Due to an emergency, the presenter from the East Jordan Chamber of Commerce cancelled the presentation scheduled for the August 20 meeting. The presentation will be rescheduled for the September meeting date.

#### 5. Discussion: Antrim County Business Park Property

Travis Youatt, Deputy Administrator, outlined the request from Alan Kostrzwa, the representative from Heritage Energy Solutions, to purchase the Antrim County Business Park property in Mancelona Township.

Sherry Comben, Antrim County Treasurer, said the first thing the County should do is get an appraisal. Ms. Comben also noted there is currently no policy in place to guide sale of County-owned property. She indicated there have been plans in the past to develop but there was no financial support to do so. Ms. Comben said there had not been any incentive to develop the property over the last several years.

Mr. Allison informed the members that Heritage Energy Solutions recently purchased easements from Community Resource Development (CRD) along adjoining property on Elder Road. He indicated purchased 20-acre parcels at Elder & Johnson roads for purpose of a wind farm and have also agreed to an option to purchase two (2) remaining lots around Tar Lake. Mr. Allison proposed clear-cutting the property and leasing to Heritage for twenty (20) years. He said if the

deal did not benefit the County after the lease expired, there would be no financial loss to the County.

Mr. Allison noted the property is currently unimproved, indicating it is too far away from city sewer for residential development. He suggested it would be worth getting the property surveyed and appraised to determine actual financial value to the property.

Rachel Krino said it was not uncommon for solar farms to offer incentives to local entities and residents for energy usage as a way to help lower usage bills for area residents. She said a potential increase in property value would benefit the County by increasing the amount of money back on tax rolls. She also said showing those looking to do business in Antrim County that the County is serious about renewable energy would help encourage businesses to relocate, bringing jobs with them. Ms. Krino said the property should be activated for economic development if it has been sitting vacant for so long.

Dave Heeres said the Board of Commissioners did not believe the offer was high enough to warrant selling the property. He agreed the vacant property was not generating money for the tax rolls.

Veronica Welter said the Board should consider how many jobs selling the property would bring into the County. Mr. Allison said the presence of renewable sources of energy is a draw to the younger generation in the workforce and could potentially increase the population of the County.

Motion by Veronica Welter, seconded by Rachel Krino to recommend the Board of Commissioner have the Antrim County Industrial Park property appraised and surveyed, and direct the Administration Office to research any deed restrictions and mineral rights restrictions prior to considering any sale to the property.

**Motion carries – unanimous** 

Ms. Krino asked Commissioner Heeres to encourage the Board of Commissioners to consider what role Antrim County can play in the growth of the region in terms of workforce housing.

#### **6.** Various Matters

#### Wetzel Lake

Mr. Youatt informed the committee he was contacted by a representative of the Department of Natural Resources (DNR) regarding any future plans for improving property surrounding Wetzel Lake in Mancelona Township. Mr. Youatt said the agreement with the State of Michigan included two development phases. The County did not complete the development of a trail and overlook phase of the agreement. He indicated the Board directed the Administration Office contact the North Country Trail Association (NCTA) to inquire about redirecting the current trail to include Wetzel Lake. Mr. Allison said the CRD would be interested in the development of the trail at Wetzel Lake. He will approach CRD board to gauge their feelings on trail development.

Ms. Comben suggested it could it be worth considering resurrecting the committee that considered the Wetzel Lake lease. She said it would be beneficial to the County to consider a joint effort on the east side of the county, similar to that which governs Glacial Hills Natural Area.

#### Road Map Update

Ms. Krino told the committee the printer that printed past maps no longer does topographical printing. Administration Office was directed to contact Burt Thompson with the Antrim County Road Commission regarding this issue.

#### 2019 Housing Summit

Kathy Peterson, Bonnie Robbins, Dave Heeres, Mike Allison, and Veronica Welter expressed interest in attending the October event. The Administration Office will register the members.

#### 7. Public Comment

Ms. Peterson told the committee that the Northern Lakes Economic Alliance (NLEA) is hosting a forum on short-term rentals at 10:00 a.m. on August 26, 2019 at The House Next Door in East Jordan.

Ms. Krino said the Bellaire Chamber of Commerce received three (3) calls from businesses interested in commercial property to purchase in Bellaire area. She let the members know the annual Rubber Ducky festival was a success.

Ms. Comben told members she recently sat down with Sara Lucas from Housing North, Elise Craft from Statecraft, and Pete Garwood regarding land banks. She said more information is needed before moving forward.

Mr. Allison said the ribbon cutting for the new sidewalk in Mancelona will be held on August 28.

Commissioner Heeres asked that mission statement be added to the agenda template as a reminder of the focus

John Henderson Former Mayor, City of Ludington

#### "Keeping the Big Picture in Mind"

Change is never easy and it often takes the right person to implement it. In 2001, John Henderson, a then 34-year-old county commissioner, was elected mayor of the City of Ludington by a narrow margin. His goal was to get the city moving again in a positive direction and make Ludington a fun place to live, work, and visit.



After officially taking office in January 2002, Henderson quickly set his sights on the revitalization of downtown Ludington as a top priority His leadership, along with many other capable staff and partners kept pushing the boundaries, asking the tough questions and were never afraid to do the hard work.

Downtown Ludington's vitality today can be credited to the foundation set by the work Henderson did. Notable events like Friday Night Live and the New Year's Eve Ball Drop, centerpieces in our community such as the North James Street Plaza, and the development of the Downtown Ludington Board are just a few of the legacies Henderson left when his 12 years as Mayor came to close due to term limits. 

#### 4. Antrim County Business Park Update

Pete Garwood, County Administrator, noted the results of the appraisal ordered by the Board on the Antrim County Business Park property in Mancelona. He indicated the appraisal came back with a property value of \$76,000. The Board of Commissioners voted to sell the property to Heritage Energy Solutions for the offered amount, retaining the mineral rights. Rachel Krino noted while this purchase may not add to the tax rolls, the perception of a green community would be attractive to people considering a move to Antrim County.

#### 5. Road Map Update

Mr. Garwood noted the EDC will have to recommend a 2020 budget amendment once the map has been printed.

Motion by Kathy Peterson, seconded by Veronica Welter to recommend the Board of Commissioners approve a 2020 budget amendment for \$4,035 for the portion of the cost of the County road map.

Ms. Krino expressed concern about the cost of printing. Mr. Garwood said he would contact Burt Thompson with the Road Commission to get a breakdown of what is covered by the cost. Mr. Garwood indicated the map would be bigger than the current version, include more information, and have a web version. Ms. Krino indicated the original design will not fit on the current specifications provided by the road commission.

Motion withdrawn.

Motion by Mike Allison, seconded by Dave Heeres to recommend the Board of Commissioners approve a 2020 budget amendment in the amount of \$2,500 for the County's portion of printing road maps.

**Motion Carries - unanimous** 

#### **6.** Various Matters

Ms. Krino noted multiple winners of the Antrim Pitch Night competition were primarily from the Mancelona area. She announced the installation of a charging station for electric cars at Shanty Creek Resorts. Shanty Creek was given a large rebate from Consumers Energy for the construction of the station, which is also the first of its kind in Northern Michigan. Ms. Krino also mentioned Paddle Antrim is close to their goal of \$275,000 to fund the water trail. Signage for the trail will start to be placed in the spring.

Mike Allison informed the committee he just signed two grants – one from Rotary Charities, the other from MISHDA – for the Village of Mancelona that will help with rehabilitating homes in the village. The MISHDA grant will help rehabilitate at least five homes. Mr. Allison also showed the group a marketing piece for Explore 131 North. He said the campaign has successful in spreading information on the area. The piece is available online.

Mr. Allison told members Community Resource Development hosted a meeting on local land banks and brownfield properties. Sherry Comben, County Treasurer, recommended a land bank establish a clear mission that a county Board of Commissioners can support in order to create funding for the program. She noted that the State land bank is more actively looking to work with local units.

Kathy Peterson told members that it was just announced the largest number of millennial millionaires is located in Traverse City.

Veronica Welters announced the ribbon cutting for the Town Club in Elk Rapids will be this coming Friday.

#### 7. Public Comment
