

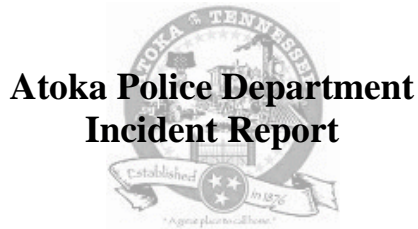

with Selling alcoholic beverages / beer to a minor. (Officer C. Hutcheson – citing officer APD)

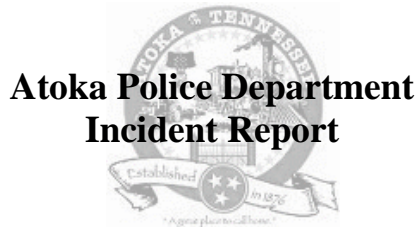

This was all witnessed by undercover agent Clark of the Tennessee Alcohol Beverage Commission. Teri R. King was charged with Selling Alcoholic Beverages / Beer to a Minor & Failure to ID. (Officer L.
