If any statement is found to be false the applicant shall forfeit its permit and shall not be eligible to receive any permit for a period of ten (10) years, in accordance with TCA 57-5-105(d).

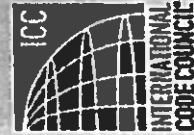
