A small portion of the levy within a predefined area of the City of Hastings and Village of Middleville shall be disbursed to those respective entities DDA's and LDFA's. This amount comes from a predefined area within the City of Hastings and Village of Middleville only.

The current police millage will expire with the 2024 levy.

RUTLAND TOWNSHIP PROPOSAL**Road Millage Renewal**

Shall the expiring previous voted 1.0 mill (\$1.00 per \$1,000 of taxable value) increase in the authorized charter millage of Rutland Charter Township approved by the electors in 2020 for levy in 2020-2024, as reduced to 0.9867 mills (\$0.9867 per \$1,000 of taxable value) by required millage rollbacks, be renewed at and increased to 1.0 mill (\$1.00 per \$1,000 of taxable value) on all taxable real and personal property in the Township for five years in 2025 through 2029 inclusive, for disbursement of such additional millage to Rutland Charter Township for the purpose of maintaining and/or improving public roads in Rutland Charter Township, which renewed 1.0 mill increase and levy will raise an estimated \$193,750.00 in the first year the millage increase is levied?

THORNAPPLE TOWNSHIP PROPOSAL**FIRE AND EMERGENCY SERVICES MILLAGE PROPOSAL**

Shall the constitutional total tax rate limitation on general ad valorem taxes in Thornapple Township, Barry County, Michigan be increased by 2.25 mills (\$2.25 per \$1,000 of taxable value) for six (6) years, 2024 through 2029, inclusive, and shall the Township levy such new additional millage annually on all taxable property within the Township for the purpose of providing fire protection and emergency services and funding the purchase of fire and emergency services equipment raising an estimated \$993,565 in the first year of the levy?

To the extent required by law, a portion of the revenues from this millage will be captured within the district of and disbursed to the Village of Middleville Downtown Development Authority.
