Approval of Agenda

Per Chairman Fiala, will proceed with agenda as presented.

Approval of Minutes

Motion to approve the November 5th, 2021 meeting minutes made by Patricia Rayl, seconded by Jay VanStee and the minutes were approved by a unanimous vote.

Chairman Comments

Per Chairman Fiala, the Recycling Coordinator contract expires in May or June 2022 and when we have service providers (which he considers this to be a service), he had the impression that we can just chose to select the vendor that we wanted to provide the service as opposed to going out for another Request For Proposal (RFP). He feels like it just wouldn't make a lot of sense to go out for another RFP and potentially bring in a brand new person to have to plow through all the ground that we have already done; it just doesn't logically make sense to him. However, he is only one (1) of 12 people on this committee, so he would like to discuss on how this committee thinks we should proceed. Per Jay VanStee, from his perspective, we need to whatever it takes to keep this going as the current Recycling Coordinator has made way more progress than this committee has been able to make in the past; he feels Rachel Frantz is doing a fantastic job and he couldn't be happier. So, the question that needs to be answered then is do we (this committee) have to do an RFP. Chairman Fiala will discuss this with Michael Brown sometime before next

month's meeting and this will be included as an agenda item for that meeting so the committee can discuss further at that time.

Budget/Trial Balance Update (Pattie Rayl)

Per Patricia Rayl, she brought a few copies of the most current SWOC Budget/Trial Balance Report to share with the committee. As of the end of October 2021, we have used 47.62% of the committee's budget, so we are doing very well. Chairman Fiala stated that year-to-date income from tipping fees is about \$71,000.00 and this was confirmed by Patricia Rayl. She also confirmed that the current fund balance is around \$217,000.00. **Motion to approve the October 2021 Trial Balance/Revenue Status Report as presented by Patricia Rayl made by Bruce Campbell, seconded by Jay VanStee and the report was approved by a unanimous vote.**

Household Hazardous Waste Dates 2022 - Drug & Laboratory New Contract Fee Summary (Jodi Pessell)

Jodi Pessell stated that she requested the dates of May 7th & September 17th, 2022 with Drug & Laboratory and they sent back something for us to sign (forwarded to Frank Fiala & Rachel Frantz), which had a \$1,500.00 site fee that we have never seen before in there. Jodi Pessell inquired about what this new site fee of \$1,500.00 is for and Drug & Laboratory said that the site fee is a set-up fee to help absorb the transportation and labor costs associated with the event. Drug & Laboratory said they had to charge this to all the counties do to the high cost of fuel and associated transportation costs. So, she needs to know if the committee wants to go ahead and move forward with Drug & Laboratory for the HHW events for next year. Jay VanStee expressed that Drug & Laboratory runs a pretty tight ship, they have been pretty easy to work with and we have used them several times in the past so they know what they are doing. Jodi Pessell also expressed that they book there events in advance, so if we aren't going to go with them, then we are going to have to really look into another company as soon as possible. Chairman Fiala and the rest of the committee members were in agreement to proceed with Drug & Laboratory for now and we'll just keep an eye on the expenses because it seems they keep increasing every year. Jodi Pessell stated she also been in touch with the Barry County Expo Center to check on these dates as well, but she is still waiting to hear back from them with confirmation. **Motion to authorize Jodi Pessell to finalize the tentative dates of May 7th & September 17th, 2022 and to continue to use Drug & Laboratory for the two (2) events for 2022 made by Frank Fiala, seconded by Sarah Nelson and approved by a unanimous vote.**

 - Tire collection has been very successful, residents have noticed a decrease in tires laying around. People have been picking up tires off the side of the road to bring them to collection events

 - Bronson Hospital partnered with Dart (CARES Program) for polystyrene recycling and installed densifier onsite. However, when larger styrofoam comes in it cannot be densified so they have to get sent back to Dart which takes more space and money.
 - Dart recycles Expanded Polystyrene (EPS). EPS is not the same as Styrofoam which is Dow Chemical trade name for building insulation which is not recyclable due to the fire retardant in it.
 - Mostly food trays, cups
 - Dart is a manufacturer, recycling is secondary to that.
 - Dart has EPS recycling facility in Indianapolis
 - There are grants available for foam recycling programs, baler, densifier, education, etc. from Foam Recycling Coalition
 - City of Kalamazoo has existing solid waste millage that funds bi-weekly curbside recycling
 - EGLE Recycle Program NextCycle Micros grant - no match grant \$10K

 - Response from Jennifer Kosak, Kalamazoo: Would not be able to provide staff or mobile operation at the event. Could potentially provide cubic yard boxes and pallets which we would have to properly pack and then deliver. One box can hold 700 lbs, would have to contact MDOT/EGLE about transporting hazardous waste.

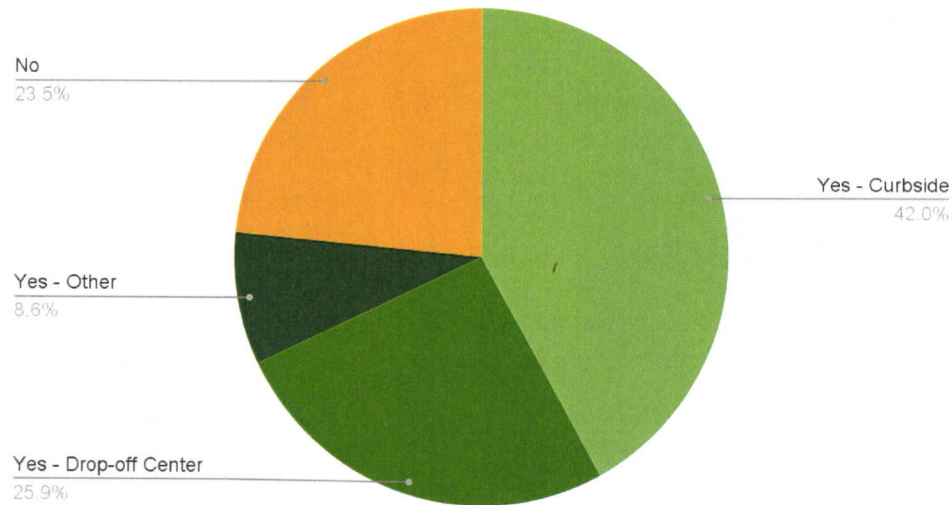
