Behavioral Health Service Definitions

*Behavioral Health examines how behaviors impact someone's health physically and mentally.

MH = Mental Health
SUD = Substance Use Disorder

<u>Consultation</u>- A formal and systematic exchange of information to improve conditions that adversely affect one's behavioral health.

<u>Crisis Services</u>- Provides assistance in an urgent behavioral health situation to safely de-escalate an individual or situation, determine appropriate treatment services, and coordinate the follow through to minimize any psychological trauma.

<u>Employment Support</u>- Promotes recovery to obtain and maintain employment by providing training and skill development that is goal-oriented, ability-based, and increases self-sufficiency.

Guardianship- Services available to a client deemed incompetent by the Butler County Probate Court, age 18 and older. To be eligible for a guardianship, a medical doctor, psychiatrist, or psychologist must complete an expert evaluation deeming a client incompetent.

<u>Housing (MH)</u>- Characterized as a safe and healthy living environment that promotes mental health recovery and stability.

<u>Information & Referral</u>- A point of contact that assists in providing information regarding behavioral health services available in Butler County including services offered, where services are located, and agency contact information.

<u>Iustice Related Services</u>- Programs that support individuals who are court-involved or who are currently incarcerated including assessments, drug or mental health courts, as well as access to treatment and recovery support services.

<u>Medication Assisted Treatment (MAT)</u>- The use of medication(s) in combination with counseling and behavioral therapies to provide both a whole patient and best practice approach to the treatment of substance use disorders.

<u>Peer Support</u>- Community-based services provided by a certified support specialist for individuals with a behavioral health disorder. Consists of activities that promote recovery, self-determination, self-advocacy, well-being and independence.

<u>Prevention/Education</u>- Formal presentations focused on preventing and reducing the incidence, prevalence, and/or severity of specific types of behavioral health disorders.

<u>Psychiatric Medication</u>- Used to stabilize and reduce mental health symptoms with the goal of improved mental health functioning and quality of life. Best practice suggests medication is likely more effective when used in conjunction with other behavioral health services such as counseling.

<u>Recovery Housing (SUD)</u>- Characterized as a safe and healthy living environment that promotes abstinence from alcohol and/or illicit drugs.

<u>Residential Treatment (MH)</u>- Therapeutic services provided at a live-in facility to an individual with mental health disorder(s) who require supervision and support with the goal of transitioning into independent living in the community.

<u>Residential Treatment (SUD)</u>- Therapeutic services provided at a live-in facility to an individual with substance use disorder(s) who require supervision and support with the goal of transitioning into independent living in the community.

<u>Social Recreation</u>- Includes structured and non-structured activities and supports to enhance the quality of life of the person served.

<u>Outpatient Mental Health</u>- Structured individual and group mental health activities and services that are provided by a certified treatment program. Services include, but are not limited to, the following: assessment, counseling, psychiatric medication services, and case management.

<u>Outpatient Substance Use Disorder</u>- Structured individual and group substance use disorder activities that are provided at a certified treatment program. Services can include, but are not limited to, the following: assessments, counseling, MAT, and case management.

<u>Withdraw Management (SUD)</u>- Medically managed SUD services to discontinue alcohol and/or illicit drug use to become medically stable.

Youth & Young Adults- Specialized services that are offered to transitional aged youth (ages 16-24).

All Addiction Recovery Services Offered:

Substance Use Treatment (Adults): It is the philosophy of this program that individuals benefit most from a holistic biopsychosocial approach to care which includes attention to physical, emotional, social, interpersonal, and spiritual well-being. All of our groups encourage 12 step group participation; coordination with a physician for medical care; random drug screens; encourage family participation; referrals to other appropriate community resources as needed; and individual case management to monitor progress in all major life areas along with abstinence from all mood-altering chemicals. Target populations are 18 and older.

Substance Use Treatment (Adolescents) The Seven Challenges ®: The program is designed specifically for adolescents with substance use disorder, to motivate a decision and commitment to change – and to support success in implementing the desired changes. The Program simultaneously helps young people address their drug problems as well as their co-occurring life skill deficits, situational problems, and psychological problems. The Seven Challenges is listed as an evidenced-based program in the SAMHSA National Registry of Evidenced Based Programs and Practices (NREBPP).

Regional Harm Reduction Collaborative (RHRC): The mission of RHRC is to introduce, support implementation of, and expand harm reduction strategies and services throughout Butler, Brown, Clermont, Clinton, and Warren Counties to improve the health of individuals and communities by reducing the negative impacts associated with substance use. RHRC seeks to reduce overdose-related deaths, infectious diseases, physical health impacts, mental health impacts, trauma, stigma, barriers, vulnerability/victimization. www.ohiorhrc.com

All Mental Health Services Offered:

<u>Dialectical Behavior Therapy (DBT)</u>: This approach has a focus on helping clients increase their ability to self-regulate their emotional and cognitive triggers. It also helps to assess which coping skills to apply in the sequences of events, thought, feelings, and behaviors to help avoid undesired reactions and consequences.

Mental Health Court Grant: Partnered with the Butler County criminal justice court system, this provides outreach, engagement, and early intervention for individuals with mental health needs. The goal is to connect clients with appropriate clinical treatment and support services needed for recovery. This partnership includes involvement with the Butler County Area Courts where a certified mental health court has been established 9 in Area III Court along with active outreach and engagement in the City of Middletown Municipal Court and Middletown City Jail.

<u>School Based Treatment:</u> On-site mental health therapy in various schools, including but not limited to Middletown elementary, middle and high schools and Monroe elementary, middle and high schools.

<u>Play Therapy:</u> This form of therapy is utilized to treat a multitude of behavioral health disorders in adolescents. It is also used to help children process difficult life circumstances.

All Specialized Services Offered:

<u>Co-Occurring Treatment:</u> The purpose and goals of this program is to provide specialized intensive outpatient treatment for clients (adolescents and adults) that are diagnosed with both a mental health condition and a substance use disorder.

<u>Cognitive Processing Therapy</u> (CPT): CPT is a cognitive-behavioral treatment for posttraumatic stress disorder (PTSD) and related problems. The overall goals of CPT are to reduce PTSD symptoms, and associated symptoms such as depression, anxiety, guilt and shame. It also aims to improve day-to-day living; CPT consists of 12 individual (one-on-one) therapy sessions. Each session lasts 50 to 60 minutes. If conducted in a group, the 12 sessions will last 90 minutes each. In these sessions, participants will learn about the symptoms of PTSD and why some people develop them.

<u>Eye Movement Desensitization and Reprocessing</u> (EMDR): EMDR is an evidence based integrative psychotherapy approach that has been extensively researched and proven effective for the treatment of trauma. EMDR is a set of standardized protocols that incorporates elements from many different treatment approaches.

<u>New Life Mission:</u> Access Counseling Services, in partnership with New Life Mission are working to focus on outreach, engagement, and early intervention for individuals with mental health and/or substance use treatment needs into the appropriate clinical treatment and support services needed for recovery. This partnership includes Access staff at new Life Mission 4 days per week (Monday –

Thursday 8 am – 2 pm) to offer services such as education and prevention, community resources for areas such as housing and food, diagnostic, assessment, therapy, psychiatry, case management, groups, and other clinically appropriate services to empower the individuals who are served.

<u>Serve City:</u> Located in Hamilton, Ohio, Access Counseling has staff on site to provide a variety of services including mental health and addiction assessment and therapy, and case management which assists the clients in finding stable housing, attaining income / benefits, and scheduling needed appointments. We also provide psychiatric care with both a nurse and doctor.

<u>YWCA:</u> Located in Hamilton, Ohio, Access Counseling has staff on site to provide a variety of services including mental health and addiction assessment and therapy. Trauma services are also offered, including EMDR. Case management is available to assist clients in finding stable housing, attaining income/benefits, and scheduling needed appointments. We provide psychiatric care with both a nurse and prescriber in Hamilton so residents do not have to travel to Middletown to see their Access Counseling prescriber.

<u>"Structured Sensory Interventions for Traumatized Children, Adolescents and Parents"</u> (SITCAP): SITCAP ® is an evidence-based, structured sensory program utilizing interventions that teach how to apply mind body skills while focusing on the primary themes of trauma including safety, worry, hurt, fear, anger, revenge and moving from victim to survivor thinking. Helping clients understand how trauma impacts brain functions of memory, emotional regulation, behavior, and learning.

<u>Incredible Years Program:</u> The program is designed to promote emotional and social competence and to prevent, reduce, and treat aggression and emotional problems in young children 0 – 12 years old.

At Upper Valley Medical Center and Atrium Medical Center's Behavioral Health Pavilion, we treat alcohol and chemical dependency only as they affect a client's mental health disorder. Withdrawal management is not provided

All Mental Health Services Offered:

Inpatient Treatment Units: Provides those experiencing a behavioral health crisis with a safe, welcoming atmosphere and well-tested therapies to help them get through the crisis and return safely home. Patients work with a team of psychiatrists, nurses, and social workers. They will assess and assist client in setting goals for a healthier, more balanced mindset.

All Addiction Recovery Services Offered:

<u>Substance Use Treatment</u>: Adult Inpatient withdrawal management from substances. Includes psychiatric and medical evaluations, therapeutic and recreational groups, social services and discharge coordination. May include medication assisted treatment.

Residential Treatment: 21-30 day program for adults with substance use disorder. Includes psychiatric and medical evaluation, intensive daily group therapies, relapse prevention planning, social services, and discharge coordination. May include medication assisted treatment. (Not covered by all insurance payers.)

<u>Partial Hospitalization</u>: Intensive group therapy 5-6 days a week, for 5-6 hours per day. Offered for both adults and adolescents. Includes psychiatric evaluation within 48 program hours and weekly psychiatric appointments. Typically, 10-15 sessions. Youth program includes an academic support component.

Intensive Outpatient Treatment: Intensive group therapy 3-5 days a week for 3 hours a day. Offered for both adults and adolescents. Includes psychiatric evaluation within 48 program hours and monthly psychiatric appointments. Typically, 18-20 sessions. Adult programming offered during the day or evening.

All Mental Health Services Offered:

<u>Inpatient MH Treatment</u>: Inpatient treatment for adults in a secure hospital for mental health evaluation, safety, and stabilization. Includes psychiatric and medical evaluations, therapeutic and recreational groups, social services and discharge coordination. <u>Partial Hospitalization</u>: Intensive group therapy program that is 5-6 days a week for 5-6 hours per day. Offered for both adults and adolescents. Includes psychiatric evaluation within 48 program hours and weekly psychiatric appointments. Typically, 10-15 sessions. Youth program includes academic support component.

<u>Intensive Outpatient Treatment</u>: 3-5 days a week intensive group therapy for 3 hours per day. Offered for both adults and adolescents. Includes psychiatric evaluation within 48 program hours and monthly psychiatric appointments. Typically, 18-20 sessions.

Specialized Services Offered:

<u>Help for Heroes Inpatient</u>: Inpatient mental health/substance use treatment for first responders, active duty military personnel, and veterans. Programming is geared toward the unique occupational cultures of this population. Includes collaboration as needed/desired with command/employer/peer support groups.

<u>Help for Heroes Outpatient</u>: Partial Hospitalization/Intensive Outpatient groups for mental health/substance use treatment for first responders, active duty military personnel, and veterans. Programming is geared toward the unique occupational cultures of this population. Includes collaboration as needed/desired with command/employer/peer support groups. Includes psychiatric evaluation within 48 program hours and weekly (PHP) or monthly (IOP) psychiatric appointments. Typically, 18-20 sessions. Offered in afternoons to accommodate typical shifts.

Children who are facing adverse situations from ages 6-18.

Volunteers need to be over the age of 15 if mentoring in a school setting and over 18 if mentoring in the community.

All Specialized Prevention Services Offered:

<u>Community-based Mentoring</u>: One-to-one evidenced based mentoring relationships to children who are facing adversity.

This program provides screening and training of the volunteer mentors as well as ongoing support for the children, volunteers and family members who are involved in the program.

While children are waiting to be matched with a volunteer mentor they are encouraged to attend our *Club of Unmatched Littles* (COUL) activities. These occur every two weeks in the summer and bi-monthly during the school year. All activities are at no cost and designed to be fun and enriching.

<u>Big Futures</u>: One-to-one evidenced based mentoring relationships for high school aged youth. This program is focused on relationship building, goal setting and career exploration. It also includes monthly field trips to local businesses and organizations.

Side Based Mentoring: One-to-one evidenced based mentoring relationships with children in need after school. Mentors are matched 1-1 with a child but meet as a group at the school with children. A staff member is present during mentoring activities.

All Mental Health Services Offered:

<u>Crisis Consultation & Intervention (CCI)</u>: The purpose of the CCI program is to provide a safety-net for any individual in the county who is experiencing an acute mental health emergency.

Mobile Response and Stabilization Services (MRSS): Families with youth and young adults up to the age 22 who are experiencing difficulties or distress can receive assistance within 60 minutes after contacting MRSS. MRSS services are also available for up to 45 days of intensive, in-home services and linkage to ongoing supports.

Health Now Integrated Care Management: Designed to improve the physical and behavioral health of children, adolescents and adults with behavioral health disorders. Health Now staff supplements the behavioral health and medical services each client receives in order to promote excellent care coordination among providers, to advocate for state-of-the-art medical care, to teach each client health self-management skills and to promote healthy lifestyle choices. Note: Health Home services are limited to individuals with qualifying diagnoses and who are current recipients of Ohio Medicaid.

<u>Uplift Senior Services</u>: An evidence-based program designed for adults (60+) experiencing symptoms of depression and anxiety. Uplift consists of eight one-on-one sessions that take place in the comfort of home over the course of 5-6 months. Uplift utilizes the PEARLS model (Program to Encourage-

Active, Rewarding Lives). Focus is on development of problem-solving skills and activity planning to help improve overall mental health.

<u>WINGS Intensive Home-based Treatment</u>: Intensive Home-Based Treatment program to improve the psychological functioning of youth ages 0-18 years old that are at risk of out-of-home placement and facilitate their continued placement with their family and their inclusion in mainstream community & school life. Serves as a step-up for youth who fail to benefit from outpatient behavioral programs. Serves as a step-down from residential programs. Offers intensive, non-traditional services with frequent therapeutic interventions per week and a team of providers who have low caseloads.

<u>Workplace Associates Program</u>: Helps individuals 16 and over who have behavioral health disorders to both gain and retain employment. Provides supported employment services including career assessment, job try-outs, individualized job placement, job coaching (at or away from the work site), and job retention services for adults.

<u>Harbor House Social Club</u>: Harbor House Social Club aims to improve the quality of life of adults with behavioral health disorders by helping them to expand their social support and community living skills.

<u>Outpatient Mental Health Services</u>: Structured individual and group mental health activities and services that are provided by a certified treatment program. Services include, but are not limited to, the following: assessment, counseling, psychiatric medication services, and case management.

<u>Early Childhood Mental Health Consultations</u>: Provides consultations for childcare centers, staff and families to support the mental health needs of children ages 0-5.

<u>Outpatient Counseling</u>: Spanish and English language counseling offered both in-person and via telehealth.

<u>Outpatient Psychiatry</u>: Spanish and English language psychiatric and medication management services offered out of Cincinnati office.

Specialized Services Offered:

<u>Immigration Legal Services</u>: Professional legal counsel for immigration cases. Case management services for recently arrived immigrant families through Refugee Settlement Services and Su Casa Hispanic Center. Also offers clinical evaluations for immigration court.

<u>AccuracyNow Language Services</u>: Professional language interpretation and translation services.

<u>Parent education</u>: Classes to support parenting skills and healthy families.

<u>Senior Companion Program</u>: Supportive senior services to help seniors remain in their home.

<u>Foster Grandparents Program</u>: Mentoring program for seniors serving vulnerable children.

<u>Caregiver Assistance Network</u>: Education and support groups for caregivers.

All Addiction Recovery Services Offered:

Ambulatory Detox: This program offers detox services to clients with opiate use disorders on an outpatient basis. This program assists clients with opiate withdrawals utilizing over-the-counter and prescribed medications in a comfortable outpatient setting. Treatment typically lasts 5 to 7 days.

<u>Partial Hospitalization</u>: This outpatient program meets 5 days a week for 4 hours a day. Client therapeutic treatment utilizes evidence-based interventions and curriculum. Clients also receive individual counseling, case management, and urinalysis testing within this treatment program.

Intensive Outpatient (IOP): The groups meet 3-4 times a week for 2-3 hours a day, depending on the severity of client's illness. Client therapeutic treatment utilizes evidence-based interventions and curriculum. Clients also receive individual counseling, case management, and urinalysis testing within this treatment program.

<u>Outpatient Treatment:</u> The groups meet 2 times a week for 2 hours. Client therapeutic treatment utilizes evidence-based interventions and curriculum. Clients also receive individual counseling, case management, and urinalysis testing within this treatment program. Safety and cognitive behavioral treatment focus groups are available.

Relapse Prevention: This group meets 1 day a week for 2 hours. Clients learn relapse prevention strategies based on evidence-based interventions and curriculum. Clients also receive individual counseling, case management, and urinalysis testing within this treatment program.

<u>Jail Services</u>: Offers assessment, IOP, individual, and case management services to inmates located at the Butler County jail.

<u>Jail Outreach Program</u>: A program that helps with re-entry for individuals with substance use disorders coming out of the jail system. The program will focus on linkage to services back in the community.

<u>Treatment Alternatives for Safer Communities</u>: Offers assessment, case management, and linkage services to clients who are chemically dependent and involved in the legal system.

<u>Peer Support Services</u>: Provide peer support services to individuals referred for services or transitioning out of the jail system to help adjust and connect in the community

<u>The Teen Intervention Program (TIP):</u> Focuses on the mental health and substance use disorder needs of youth under the age of 18. The program can include individual therapy, family counseling, substance use disorder outpatient group that meets twice a week for two hours, SUD individual sessions, case management, and urine analysis as appropriate. The client's therapeutic treatment utilizes evidence-based interventions and curriculum.

All Mental Health Services Offered:

<u>Mental Health Counseling Services</u>: A program designed to treat clients with mental health disorders utilizing evidence-based interventions, such as cognitive behavioral therapy, client-centered therapy, solution-focused therapy and Dialectical Behavioral Therapy skills (DBT). Mental Health counselors also provide couples and family therapy sessions.

<u>Case Management Program</u>: A voluntary program that serves adults ages 18 and over by providing services for those with persistent, chronic, and severe mental health disorders. Many case management clients have co-occurring problems with substance use. Case Managers primarily serve clients in community settings.

<u>Connections</u>: Provides a short-term program to assist Butler County residents with accessing mental health care. The program assists Butler County residents accessing a long-term mental health provider or re-connecting them to a prior provider. Often these individuals are being discharged from a hospital or released from jail. The goal of Connections is to ensure Butler County residents have access to their psychiatric medications to prevent decompensation. To accomplish this goal, Connections provides interim medication management and case management while identifying and connecting the client with appropriate long-term mental health services.

<u>Mental Health Housing</u>: Offers apartments throughout Butler County for individuals who have mental illness, are receiving case management services, and have the ability to pay rent.

<u>Probate Monitor</u>: Provides clinical oversight and court liaison services for adults who are civilly probated to the Butler County Mental Health and Addiction Recovery Services Board by the Butler County Probate Court.

<u>Forensic Monitor</u>: Provides clinical oversight and court liaison services for consumers involved with the criminal court and, due to their mental health status, are found to be incompetent to stand trial or cannot be convicted due to their mental status at the time of the criminal defense.

<u>Sex Offender Individuals and Group Program</u>: This program provides evidence-based treatment to clients with a history of sex offense charges.

Specialized Services Offered:

<u>Men and Women's Anger Management</u>: This group is for clients who have difficulty managing their anger, and who may have previous arrests caused by anger responses. This program provides group education for a length of time, depending upon each client's individualized recommendation. Education consists of evidence-based interventions and curriculum. Individual sessions are offered in conjunction with group sessions. These groups are gender specific.

<u>Batterer's Intervention Program</u>: This program is for clients with a history of physical abuse towards an intimate partner. This program provides group education for a length of time, depending upon each client's individualized recommendation. Individual sessions are offered in conjunction with group session. These groups are gender specific.

<u>New Perspectives</u>: This program is for victims of domestic violence. The program provides group education for a length of time depending on individual client needs. The program utilizes evidence-based interventions and curriculum. These groups are gender specific.

<u>Corrective Thinking Group</u>: This program is for clients with a history of criminal or antisocial thinking patterns. The program lasts for a period of six weeks with each session lasting one and one-half hours. Group sessions consist of evidence-based curriculum, True Thought.

<u>Theft Group</u>: This group provides evidence-based interventions and curriculum for clients with a history of stealing or theft. This is a seminar lasting 4 hours. If recommended, clients will then attend corrective thinking group focused on specific criminal thinking patterns that correlate to stealing.

<u>Substance Use Education</u>: This program is for clients who do not meet diagnostic criteria for a substance use disorder or who have a mild substance use disorder. Services are provided in the form of a group and/or individual for a length of time based upon client need. Clients are drug screened and monitored for signs and symptoms of more severe substance use during attendance.

<u>Parenting Class</u>: This program is for both men and women who are trying to achieve bettering parenting skills and build healthier relationships with their children. Program is 7 weeks.

<u>Diversion Program</u>: Is a program is geared toward misdemeanor offenses such as open container violations, underage consumptions, and drug paraphernalia. The course consists of a screening and one class.

<u>Community Presentations</u>: Provide presentations to community groups to increase understanding of addiction/ mental health conditions and their impact on the community, business, families, and individuals. Developed for the needs of your group around 4 pillars of prevention: Substance Abuse, Gambling, Violence, and Suicide.

Specialized Services Offered:

<u>Camp Mariposa</u>: An overnight program offered year-round for youth (ages 9-12) and teens (ages 13-16) impacted by a family member's substance use. Family activities are held bimonthly (during off camp months).

Intensive Outpatient Services: Offered several days per week and include a combination of individual and group counseling totaling around 10 hours per week. Outpatient services are offered at Dayton St., University Blvd., and High St. locations. All of which are in Hamilton, Ohio.

<u>Partial Hospitalization</u>: Services are offered several days per week and include a combination of individual and group counseling totaling over 20 hours per week. Counseling services are utilized in partnership with addiction medicine, psychiatry, case management and peer recovery services based on individualized needs and goals.

<u>Individual Counseling</u>: An in-person or telehealth encounter with the purposes of assisting the individual in achieving treatment goals through exploration of their substance use and mental health and the impact on their lives.

<u>Case Management</u>: Case management is a service that aids individuals in gaining access to needed medical, social, and educational resources. Case management services may involve family members and other professionals such as medical providers and educators. Case Management can be done inperson or via telehealth.

<u>Group Counseling</u>: In group counseling, treatment objectives are achieved through group discussions of attitudes and feelings, possible solutions, and sensible decision-making. Group Counseling may be done in-person or via telehealth.

<u>Family Counseling</u>: Family Counseling is an in-person or telehealth encounter between an individual, family members, and a counselor. The purpose of family counseling is to create an open, honest dialogue between the client and family members.

<u>Recovery Housing</u>: Recovery Housing supports individuals continuing outpatient treatment services while working on finding employment and affordable long-term housing. Recovery Housing provides residents with opportunities to practice recovery skills in an independent living environment with a safety net.

<u>Residential Services</u>: Comprehensive substance use residential treatment services to address substance use and mental health in a structured and safe setting for those at high risk for continued use without an intensive supportive living environment and withdrawal management. Residential patients also have access to primary care and psychiatry through Sojourner's on-site clinic. Sojourner offers family units and on-site childcare for mom's and their children at two residential locations.

All Mental Health Services Offered:

Psychiatric and mental health services are a core component of Sojourner's comprehensive behavioral health continuum and play a key role in improving the individual's quality of life. Clients receive individualized treatment for co-occurring mental health and substance use needs.

Specialty Services Offered:

<u>Court Outreach</u>: Individualized behavioral health services for court involved and/or incarcerated individuals. The goal is transition to appropriate treatment settings. Complete on-site assessments at the Butler, Clinton, Preble, and Warren county jails by request. We also have the ability to conduct walk in assessments at our office on University Blvd. Sojourner participates in several Specialty Court Programs in Butler County. We are the dedicated treatment provider for Butler County's Drug Court Docket. We have clinicians and a case manager that provide individualized services for these participants throughout their entire journey in this program. Additionally, we offer residential and outpatient treatment services for individuals participating in the other Specialty Courts: Substance Abuse and Mental Illness (SAMI) Court, Family Treatment Drug Court, Felony Non Support (FNS) Court, and Veteran's Treatment Court (VTC).

<u>MAMAS</u> (<u>Motherhood and Maternity Addiction Services</u>): Sojourner's MAMA's program provides educational, healthcare, and recovery housing services for pregnant women and women with young children who are struggling with a substance use disorder. Patients participate in outpatient treatment services, case management services, and have access to our medical and psychiatric practitioners as needed to meet their goals in achieving long term sobriety. The program collaborates with multiple social service agencies to provide additional support and resources for clients.

Opioid Treatment Program - Medication Assisted Treatment

Medications like Methadone, Suboxone and Vivitrol help provide relief from painful and uncomfortable withdrawal symptoms. These medications are safe for long-term use and are part of a comprehensive approach to treatment that involves individual counseling, group counseling and case management. With the combination of medication and behavioral counseling this approach provides both the whole patient and best practice approach to the treatment of substance abuse disorder.

Assessment: Comprehensive assessments for behavioral health to identify individual needs and guide treatment options. Walk-in assessments are available at the Hamilton and Middletown locations and via telehealth. Please call 513-863-6383 for a Telehealth Assessment. Walk-In Hours are available from 8:00 am to 12:30 PM Monday through Friday, at both locations. You may also call and schedule an appointment if you prefer.

<u>Case Management</u>: These services address individual needs to help improve functioning and reach personal goals to live successfully in the community. Case management activities may include ongoing assessment of needs, assistance in managing basic needs, development of daily living skills, coordination of services, assistance with accessing support systems, linkages to community services and supports, symptom monitoring, education and training and behavioral interventions.

<u>Counseling and Therapy</u>: Counseling services are designed to address a variety of mental health and/or addiction challenges which may interfere with a person's ability to effectively function at home, school or in the community. Individual, group and family counseling and psychotherapy is available inperson at Hamilton and Middletown locations or via telehealth.

<u>Psychiatry Services</u>: Designed to support individuals to enhance quality of life, reduce symptoms, and restore or improve functioning. Medical providers evaluate and prescribe medication based on the individual needs of each client to address mental health concerns. Nursing staff assist in providing education, support and coordination of care. Services are available in-person at Hamilton and Middletown locations or via telehealth.

<u>Homeless Outreach (PATH)</u>: The PATH Program (Projects for Assistance in Transition from Homelessness) provides outreach and engagement to individuals who are homeless or at high risk of becoming homeless who have mental health needs. The PATH Program provides education on available services and resources in the community and works to connect individuals. They help link to food pantries, job assistance, education assistance, housing opportunities and medical resources. Referrals to PATH can come from anyone.

<u>Court Outreach</u>: Designed to support the recovery of individuals in the community who have severe and persistent mental health needs who have been charged with misdemeanor crimes. Individuals are referred to the program through judges, family members, attorneys, probation departments, and police departments. This program works in partnership with the Fairfield Municipal Treatment Alternative Court, as well as other local courts.

<u>Employment Success</u>: The Employment Success Program is a collaborative partnership with Butler County Job and Family Services and multiple local agencies with the purpose of removing barriers to employment and helping individuals achieve meaningful employment. Our service coordinators work with individuals to make connections to services to address mental health and substance use treatment needs. Service Coordinators also assist with navigating community systems, help to get basic needs met and assist in educational or vocational needs.

<u>Forensic Jail Services</u>: The Mental Health Forensic Team provides a variety of mental health supports to inmates and corrections personnel as indicated or requested in the Butler County Jail. These services are primarily prevention education, consultation, crisis intervention and linkage services. Inmates who present with overt problematic or concerning symptoms, histories of mental illness and/or behavioral challenges, active or recent suicidal or homicidal ideation or actions, are referred to the Mental Health Forensic Team for further crisis assessment and mental health support services within the jail. This program works in partnership with the Butler County Sheriff's Department.

<u>Residential Mental Health</u>: Residential mental health services are 24/7 and available to those individuals with mental health needs, which severely impact their ability to live and function independently in the community. The goal of residential treatment is to stabilize functioning, reduce symptoms, and improve independent living skills so that the individual can live independently in the community.

YWCA Hamilton Goodman Place: Offers low-Income housing tax credit apartments with permanent supportive housing services (24/7 staffing, including on site social workers and client support specialist) for individuals with chronic homelessness and disabilities.

<u>YWCA Hamilton Dove House</u>: Offers a protective emergency domestic violence shelter, crisis hotline with case management, healthcare, and treatment referrals.

YWCA Hamilton Racial Justice program: Offers free cultural competency/DEI training to providers, partners, and the wider community. Primary areas of focus are increases in Health Equity, Youth Development & Empowerment and Community & Civic Engagement within historically marginalized communities.

YWCA Hamilton Youth program: Offers FIERCE Youth Program (Fearless, Independent, Educated, Resilient, Confident and Engaged) in Hamilton City Schools and local community centers. There is a specific emphasis on BIPOC youth and providing social emotional learning with a trauma informed care philosophy. The curriculum focuses on educating youth on safe and healthy relationships. The programs are evidence-based, culturally responsive, trauma informed, gender-expansive, and strengths-based.
