## **Request for Proposal**

**Propane  
Bid No. 22-21**

The Bedford County Department of Finance is requesting proposals on **Propane**. Sealed bids will be received until **2:00 p.m., Tuesday, September 14, 2021**, in the office of the Bedford County Department of Finance and will be opened publicly at that time. The Department of Finance reserves the right to reject any and all bids and waive any irregularities for the purpose of ensuring that the award given is in the best interest of Bedford County. Any bids received after the scheduled closing time for receipt of bids will be returned to the bidder unopened.

## GENERAL BID TERMS AND CONDITIONS

Proposals from all responsible bidders will be considered. To qualify as a responsible bidder, the proposal submitted must:

1. Meet or exceed the minimum requirements specified.
2. Furnish all documents requested by the representative of the Bedford County Department of Finance prior to and following the bid opening.
3. Submit their completed bid prior to the bid opening date and time.
4. Have bid name and bid number placed on the outside lower left corner of the sealed envelope containing the bid form. (Facsimile bids will not be considered.)

### Award

A purchase order from the Bedford County Department of Finance will be issued to the successful bidder acknowledging the award. A copy of these terms and conditions, specifications and the vendor's proposal form will become a part of the purchase order.

Prospective bidders may contact the School Maintenance Department at 931- 684-6961 for any questions as to the specifications of the bid.

Lowest and/or best bid will be awarded. Also, Bid may be awarded separately for larger and smaller tanks.

Bid prices shall be for the entire fiscal year ending June 30, 2022.

Tanks shall not be filled to more than 80% capacity at the start. Notification of starting delivery date will be from the School Maintenance Department. Tanks are not to be topped off at the end of the heating season. **Auxiliary power plant tanks are to be filled only by request.**

Bidder must quote bid price as per gallon. The bid price established and accepted may fluctuate with the market, but should not exceed \$.15 above the bid price for the contract period for the smaller tanks. Transport gas is subject to market fluctuation based on the Mt. Belveau index as published in the "Wall Street Journal". Propane grade shall be HD5.

Propane must be delivered to small tanks within 36 hours of notification.

Propane must be delivered to large tanks within 48 hours of notification that tank has reached 30% or less and at no time will large tanks be allowed to drop to less than 20% unless scheduled and approved by the Facilities Director.

Driver upon delivery shall contact the Building Engineer and furnish that individual **with receipt of the delivered amount and obtain signature to verify delivery** of the invoice

amount. **Deliveries must be made during regular working hours, 7:00 a.m. to 3:30 p.m. of the School Maintenance Department.**

### **Other Considerations**

Bedford County Department of Finance reserves the right to purchase only those bid items and quantities that conform to overall budgetary, functional, and performance constraints.

The terms of this bid will be extended to other local government agencies, other municipalities, and Boards of Education. Bedford County is responsible only for purchases made and received by Bedford County.

Bedford County of Tennessee ensures compliance with Title VI of the Civil Rights Act of 1964; 49 CFR, part 26; related statues and regulations to the end that no person shall be excluded from participation in or be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance from the U.S. Department of Transportation on the grounds of race, color, sex or national origin.

## **INSTRUCTIONS TO BIDDERS**

All Proposals are to be made on the Proposal Form provided. **Bids must be delivered in hand or by a mail service in a sealed envelope marked on the outside lower left corner, Bid No. 22-21 Propane. Bids will be received and opened at **2:00 p.m., Tuesday, September 14, 2021**. Any bids received after the scheduled closing time for receipt of bids will be returned to the bidder unopened.**

**Proposal shall be made upon Proposal Forms prepared by the Department of Finance.** All Proposals are to be made complete in every detail as required and called for by said Proposal Form. Proposals that are incomplete, conditional contain irregularities of any kind, or which are not in accord with the Instructions to Bidders and Proposal Form furnished by the Department of Finance may be rejected as informal.

The submission of a proposal will signify that the Bidder has thoroughly familiarized himself with all conditions and that he fully understands what will be expected of the successful bidder.

The Department of Finance reserves the right to accept or reject in whole or in part any or all proposals submitted, without liability whatsoever, and waive informalities therein, or deemed by the Department of Finance in their best interest to do so.
