### **Communication Equipment Shelter Move and Install Bid No. 22-31**

The Bedford County Department of Finance is requesting proposals for a Communication Equipment Shelter - Move and Install. Sealed bids will be received until **2:00 p.m., Wednesday, February 16, 2022**, in the office of the Bedford County Department of Finance and will be opened publicly at that time. The Department of Finance reserves the right to reject any and all bids and waive any irregularities for the purpose of ensuring that the award given is in the best interest of Bedford County. Any bids received after the scheduled closing time for receipt of bids will be returned to the bidder unopened.

## GENERAL BID TERMS AND CONDITIONS

Proposals from all responsible bidders will be considered. To qualify as a responsible bidder, the proposal submitted must:

- 1. Meet or exceed the minimum requirements specified.**
- 2. Furnish all documents requested by the representative of the Bedford County Department of Finance prior to and following the bid opening.**
- 3. Submit their bid, complete, prior to the bid opening date and time.**
- 4. Have bid name and bid number placed on the outside lower left corner of the sealed envelope containing the bid form. (Facsimile bids will not be considered.)**

### **Award**

A purchase order from the Bedford County Department of Finance will be issued to the successful bidder acknowledging the award. A copy of these terms and conditions, specifications and the vendor's proposal form will become a part of the purchase order.

The terms of this bid will be extended to other local government agencies, other municipalities, and Boards of Education. Bedford County is responsible only for purchases made and received by Bedford County.

Proposals that are incomplete, conditional, contain irregularities of any kind, or which are not in accord with the Instructions to Bidders and Proposal Form furnished by the Department of Finance may be rejected as informal.

includes dirt work and gravel

Set building and anchor to concrete

Run electrical connection underground from transformer pole to building with new meter  
on building

Permitting

Ground ring installation with ground rods, cadwelds and wire

Provide and install 40 ft ice bridge post tied to ground ring

Site cleanup/seed and straw

Crane – building transported to site

Dozier and equipment to pull truck and building to site

Crane mobilization and to offload building
