## **Request for Proposal**

### **Early Literacy District Support Services Bid No. 22-49**

The Bedford County Department of Finance is requesting proposals for Early Literacy District Support Services. Sealed bids will be received until **2:00 p.m., Monday, June 27, 2022**, in the office of the Bedford County Department of Finance and will be opened publicly at that time. The Department of Finance reserves the right to reject any and all bids and waive any irregularities for the purpose of ensuring that the award given is in the best interest of Bedford County. Any bids received after the scheduled closing time for receipt of bids will be returned to the bidder unopened.

## GENERAL BID TERMS AND CONDITIONS

Proposals from all responsible bidders will be considered. To qualify as a responsible bidder, the proposal submitted must:

- 1. Meet or exceed the minimum requirements specified.**
- 2. Furnish all documents requested by the representative of the Bedford County Department of Finance prior to and following the bid opening.**
- 3. Submit their bid, complete, prior to the bid opening date and time.**
- 4. Have bid name and bid number placed on the outside lower left corner of the sealed envelope containing the bid form. (Facsimile bids will not be considered.)**

### **Award**

A purchase order from the Bedford County Department of Finance will be issued to the successful bidder acknowledging the award. A copy of these terms and conditions, specifications and the vendor's proposal form will become a part of the purchase order.

Lowest and/or best bid will be awarded.

Bid shall be for a period of one year with an option to renew for an additional one year period.

### **Other Considerations**

Bedford County Department of Finance reserves the right to purchase only those bid items and quantities that conform to overall budgetary, functional, and performance constraints.

The terms of this bid will be extended to other local government agencies, other municipalities, and Boards of Education. Bedford County is responsible only for purchases made and received by Bedford County.

Proposals that are incomplete, conditional, contain irregularities of any kind, or which are not in accord with the Instructions to Bidders and Proposal Form furnished by the Department of Finance may be rejected as informal.

## **SPECIFICATIONS**

1. The vendor will collaboratively partner with Bedford County Schools to provide targeted early literacy support aligned with the district's needs.
2. The vendor will support district and school leaders in developing their knowledge and understanding of what excellent reading foundational skills instruction looks like, using the TN Foundational Skills Instructional Practice Guide (IPG) as a tool.
3. The vendor will support district and school leaders to review and reflect on key early literacy data points through instructional walkthroughs to continuously improve the district's early literacy strategy.
4. The vendor must be on the State approved Early Literacy Support vendor list.

## Purpose of Form

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
  - Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)

  - Form 1099-S (proceeds from real estate transactions)
  - Form 1099-K (merchant card and third party network transactions)
  - Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
  - Form 1099-C (canceled debt)
  - Form 1099-A (acquisition or abandonment of secured property)
