## **Request for Proposal**

### **Canopy for Bedford County Health Department Bid No. 23-27**

The Bedford County Department of Finance is requesting proposals for a Canopy for the Bedford County Health Department. **Sealed bids will be received until 2:00 p.m., Wednesday, March 29, 2023**, in the office of the Bedford County Department of Finance and will be opened publicly at that time. The Department of Finance reserves the right to reject any and all bids and waive any irregularities for the purpose of ensuring the award is in the best interest of Bedford County. Any bids received after the scheduled closing time for receipt of bids will be returned to the bidder unopened.

## GENERAL BID TERMS AND CONDITIONS

Proposals from all responsible bidders will be considered. To qualify as a responsible bidder, the proposal submitted must:

1. **Meet or exceed the minimum requirements specified.**
2. **Furnish all documents requested by the representative of the Bedford County Department of Finance prior to and following the bid opening.**
3. **Submit their completed bid prior to the bid opening date and time.**
4. **Have bid name and bid number placed on the outside lower left corner of the sealed envelope containing the bid form. (Facsimile bids will not be considered.)**

### Award

A Purchase Order from the Bedford County Department of Finance will be issued to the successful bidder acknowledging the award. A copy of these terms and conditions, specifications and the vendor's proposal form will become a part of the purchase order.

Lowest and/or best bid will be awarded.

## INSTRUCTIONS TO BIDDERS

**All Proposals are to be made on the Proposal Form provided. Bids must be delivered in hand or by a mail service in a sealed envelope marked on the outside lower left corner, Bid No. 23-27 Canopy at Health Department. Bids will be received and opened at 2:00 p.m., Wednesday, March 29, 2023. Any bids received after the scheduled closing time for receipt of bids will be returned to the bidder unopened.**

Proposals are to be made complete in every detail as required and called for by said Proposal Form. Proposals that are incomplete, conditional, contain irregularities of any kind, or which are not in accord with the Instructions to Bidders and Proposal Form furnished by the Department of Finance may be rejected as informal.

The submission of a proposal will signify that the Bidder has thoroughly familiarized himself with all conditions and that he fully understands what will be expected of the successful bidder.

The Department of Finance reserves the right to accept or reject in whole or in part any or all proposals submitted, without liability whatsoever, and waive informalities therein, if deemed by the Department of Finance in their best interest to do so.

Bedford County is bidding a two lane canopy for the Bedford County Health Department, 140 Dover Street, Shelbyville, TN. This is to protect staff and patients in poor weather conditions when the Health Department is delivering drive through services. A site visit is recommended.

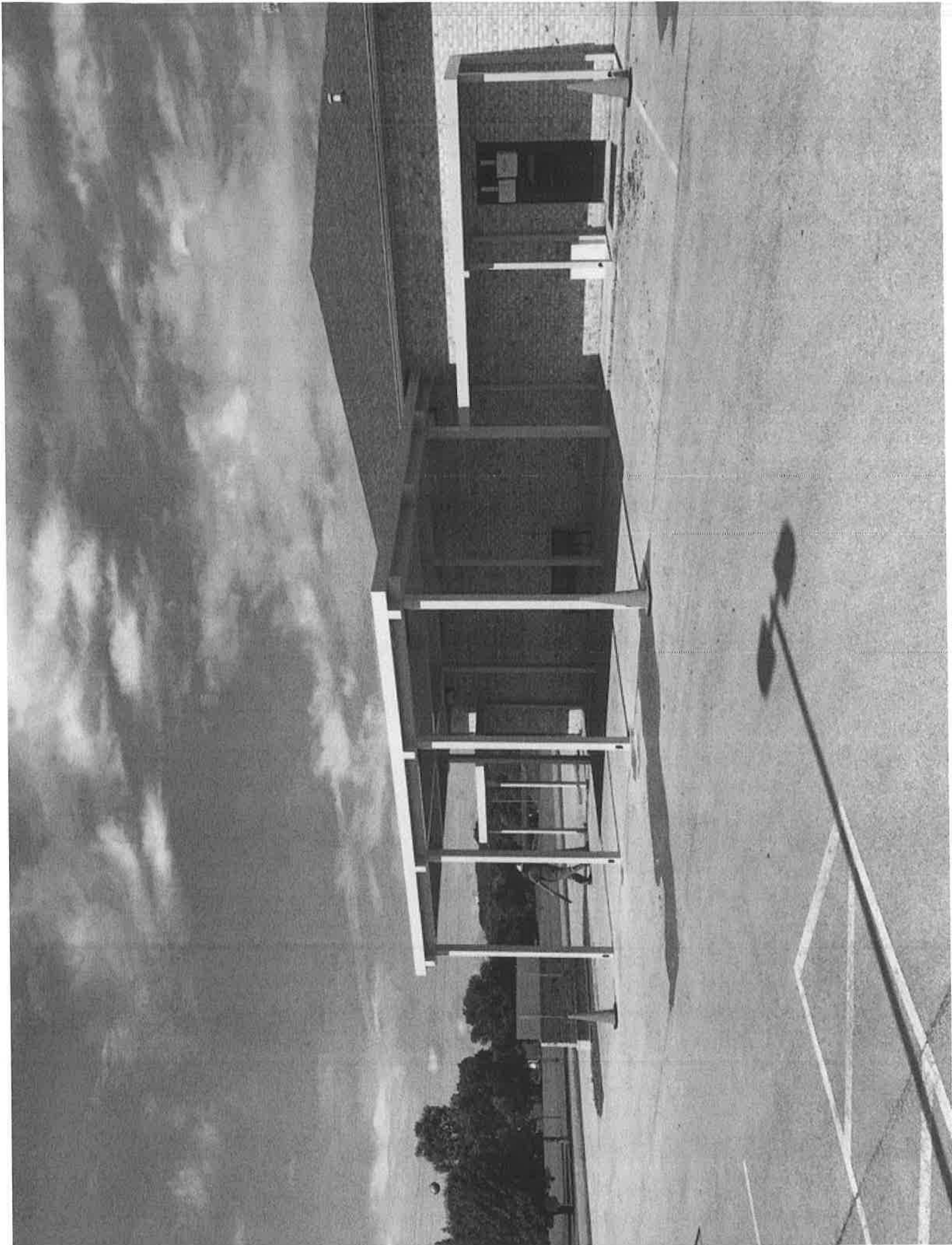
Columns – 6” x 6” minimum .220 thickness

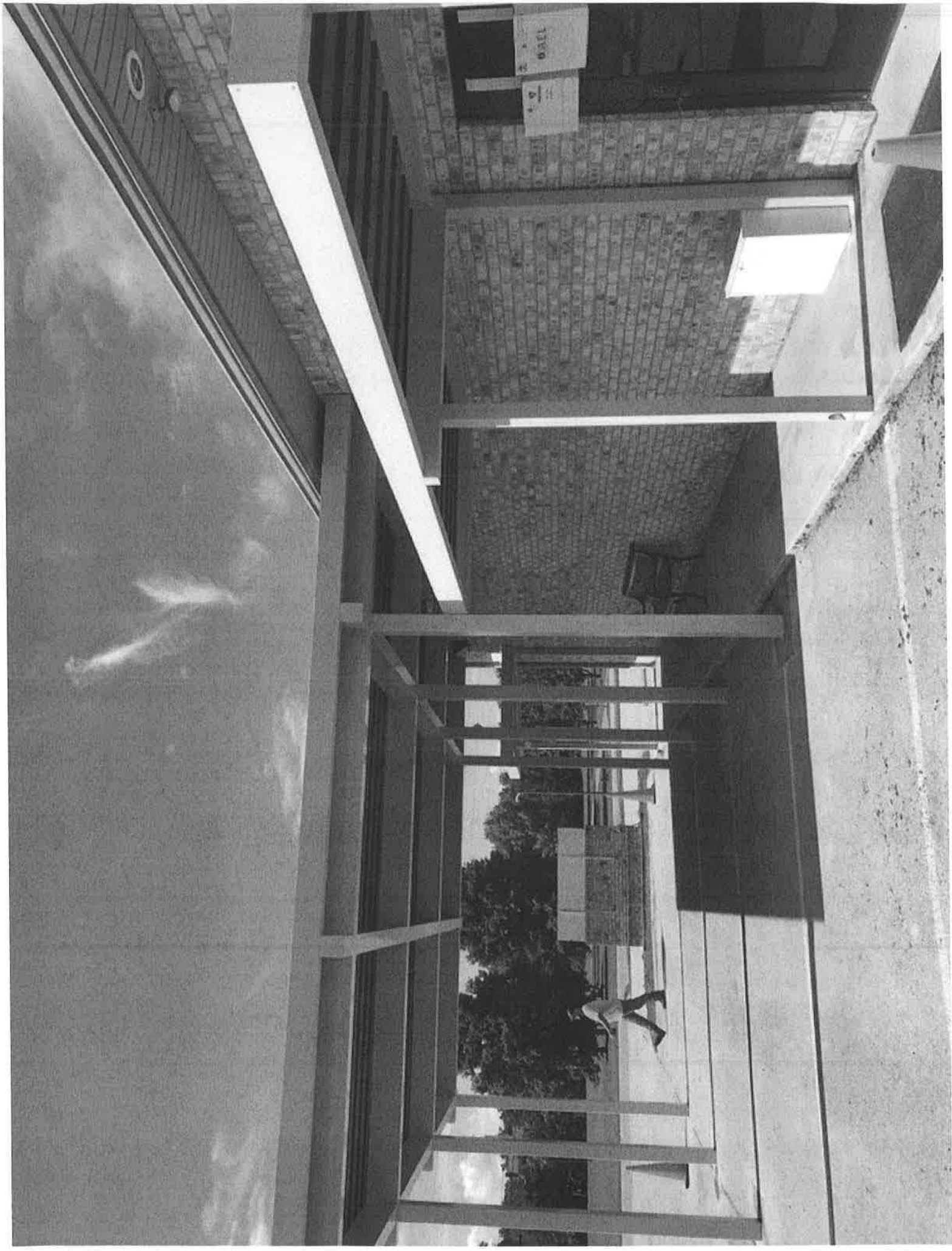
Beams – 6” x 12” minimum .250 thickness

Fascia – 8” profile with 4 1/8” x 4 5/8” gutter minimum .125 thickness

Decking – 6” x 3” Pan & Cap minimum .062 thickness

### Purpose of Form

  - Form 1099-K (merchant card and third party network transactions)
