CEQA: The actions in adopting the Resolutions and Ordinance are exempt from environmental review under the California Environmental Quality Act (California Public Resources Code §§ 21000, et seq., "CEQA") and CEQA Guidelines (14 California Code of Regulations §§ 15000, et seq.) pursuant to CEQA Guidelines § 15303, Class 3 (New Construction or Conversion of Small Structures) and § 15315, Class 15 (Minor Land Divisions). The proposed project involves expansion of an existing dwelling unit and construction of a new dwelling unit in an urbanized area and division of real property in an urbanized area zoned for residential use into two parcels. The project complies with the Bellflower General Plan and zoning regulations in the Bellflower Municipal Code ("BMC"); no variances or exceptions are required; all services and access to the proposed parcels to local standards are available; the parcel was not involved in a division of a larger parcel within the previous two years; and the parcel does not have an average slope greater than 20 percent.

Recommendation to City Council: 1) Waive further reading and adopt Ordinance No. 1406; or 2) Alternatively, discuss and take other action related to this item.
