- Dr. Trey Dobson, SVMC Medical Director, did the following presentation:
- Vermont is seeing a steady number of cases over the last 6 weeks with 35-40 patients hospitalized each day.
- There are more cases and less hospitalization.
- In Vermont, for every 100 people tested, 3 of them are positive, whereas nationally, it's
 6 out of every 100.
- There are trials currently taking place for an oral antiviral treatment.
 - Treatment must be administered in the early stages of the disease and will never take the place of vaccination.
 - The vaccine will be available for the 5-11 year olds in the beginning of November, and the 3rd shot is available now to those that qualify for it.
 - The 3rd shot will be available to everyone in the beginning of November that received their 2nd shot 6 months ago regardless of whether or not your first 2 shots were Pfizer or Maderna.
- There is additional explanation of the 3rd shot on the SVMC website.
- Most people are going about life more normally.
- Masks can be removed when we get a much lower incidence of the virus.
- 52 Board questions and comments answered by Dr. Dobson:
- Mr. Carroll: Will the 3rd shot be the same as the other two? Yes, at this time with potential
- 54 changes in the future.
- Mr. Carroll: Why not only give one shot? Because it is how our systems react to the disease.
- Mr. Carroll: How is hospital staff reacting to mandatory vaccination? Anyone working with the
- 57 patients must be vaccinated and the employees not vaccinated due to religious or other
- 58 exemptions will be working where there is no patient contact.
- Mr. Carroll: Are there any new variants on the horizon? Not right now.
- Ms. Conner: Is it OK to get the booster and the flu shot at the same time? Yes.
- Ms. Conner: Should you bring your vaccination card when going for the booster? Yes, but we
- 62 can make another one for you if necessary.
- 63 Ms. Conner: Is it more important this year for children to get a flu shot? Yes.

- Mr. Corey: What percent of the 3% that tested positive were vaccinated or unvaccinated? The
- vaccinated that tested positive is higher than it used to be and the unvaccinated that tested
- 66 positive is 4 times higher.
- 67 Public questions and comments answered by Dr. Dobson:
- Susan Plaisance: Are we closing in on herd immunity in Vermont? Herd immunity is ~90% and we are closing in on that.

5. PUBLIC COMMENT

The following Public Comment Practices to make the experience for all involved a productive and informative use of the Public Comment period at Select Board meetings was placed on the podium for those that wish to make Public Comments to reference:

- Public Comment is to allow residents an opportunity to share information or make announcements that benefit the community at large.
- 2. The topic should **not** be related to an agenda item. If a member of the public wants to comment on an agenda item they can do so during the discussion of that item.
- 3. Comments should be 3 minutes or less.
- 4. You are required to state your real name and town of residence.
- 5. Sharing comments, announcements and concerns are encouraged rather than asking questions. Public Comment is not a time for discussion. If you have specific questions it is best to call the Town Manager to get a full explanation and accurate information.
- 6. If the topic requires much discussion the item will be considered as an agenda item at a future meeting.

Wendy Morse from the Department of Labor and Wendy Callard from Creative Workforce Solutions stated that they are having their first Job Fair in 2 years at the State Office Complex on October 20th from 11:00am-2:00pm with October 22nd as a rain date. Sponsors beside the Department of Labor are Creative Workforce Solutions, Vocational Rehabilitation, and the SWVT Chamber of Commerce. There is no better time for a job seeker with 18,000 jobs available statewide. The Department of Labor is open Monday-Thursday with walk-in hours Tuesdays from 9:00am-11:00am and Wednesdays from 1:00pm-3:00pm. The Department of Labor's number is 802-442-6376 or 802-343-4726 for employers.

6. DISCUSSION ON DOWNTOWN FUNDING STRUCTURE

Gary Corey owns property downtown and recused himself from this agenda item.

Ms. Jenkins noted the Downtown Walk-Abouts that she has done recently with Congressman Peter Welch, Lt. Governor Molly Gray, and White and Burke. The excitement

they expressed about the changes and vibrancy they were seeing "was good to hear" as was her experience volunteering at the downtown Welcome Center hearing the many different reasons why people are frequenting Bennington. Kudos to all who have worked to make the Downtown a destination point as was discussed 10 years ago. "What is good for the Downtown is good for the entire community."

Better Bennington Corporation (BBC) President, Susan Plaisance, and Interim Executive Director, Michael McDonough, did the following presentation:

- > The Mission of the BBC is "To lead and support the public in private efforts that promotes and enhances our Downtown as a vital, commercial, and cultural heart of our community".
- The center of our Town is Putnam Square.
 - > The landscape of the Downtown has changed and there is a new vitality that is feeding the entire community.
 - > There are more people living downtown, accessing services and shopping which attracts new businesses and promotes and sustains population growth.
 - > There is a critical relationship between the Downtown core and everyone in the community.
 - ➤ We are requesting that the Board look at whether or not Downtown businesses should continue to pay the 2nd tax or if that burden should be consumed by everyone within the General Fund tax of the Town.

Mr. Hurd explained that the 2^{nd} tax, or the Downtown Improvement District (DID) tax, is created by Charter that assesses a tax on the commercial properties, and not the residential properties, in the Downtown. We have the Grand List of the properties and the budget that is presented by the BBC. The current approved amount is \$82,000 and the current tax rate is $^{2.20}$ 100 of value that is calculated in a similar way as are the other town taxes.

- 125 Board questions and comments answered by Ms. Plaisance and Mr. McDonough:
- Mr. Carroll: What would be that tax structure for all of the property owners if the change is
- approved? Mr. Hurd answered that it would be \$8.00/\$100,000 of value. The BBC would
- present to the Board at budget time as do the other agencies that are line items within the
- town budget. And, it would free up dollars for the Downtown businesses to then put back into
- 130 their businesses.

- Mr. Hurd: If this comes to fruition, would the BBC then spread out beyond the Downtown
- District? We would help decorate, for example, the rest of the town as much as we could with
- 133 current staff. We currently serve the Downtown beyond the Downtown District and it would
- be an expectation that even more of the town could be part of that. This could be discussed at
- the town budget meetings.
- 136 Ms. Conner: Do you feel this would be beneficial in drawing new businesses? Yes.

B. PROCEDURES POSTING

 - The Working Group will be meeting soon to see that the second set of procedures are also ready to post.

8. STOCKLEE LANE SOLAR SITE

Mr. Monks reported the following:

- The Allco Renewable Energy Limited and the Melone's have reached a settlement with the Apple Hill Subdivision.
 - Allco has acquired the preferred site on Stocklee Lane and have filed a petition with the Vermont Public Utility Commission (PUC) to approve the relocation of the Chelsea and Apple Hill Solar projects to there.
 - Allco is requesting that the Select Board support this petition which, would be expected, because the Select Board has already accepted Stocklee Lane as a preferred site.
 - ❖ However, the Select Board has no say in the acceptance, or not, of the pricing.
 - ❖ The Apple Hill Association has submitted a letter of support for the project.
 - The perimeter will still need to be screened and they will still need to abide by all of the other site criteria requirements.
 - The PUC has exclusive authority over renewable energy generation.
 - This may, or may not, take a long time to come to fruition.

Bruce Lee-Clark moved and Sarah Perrin seconded for the Town to send a Letter of Support for the Allco Renewable Energy Limited Petitions 21-3191 and 21-3192 as requested subject to final review of the project based on our Town Plan. The motion carried unanimously.

9. MANAGER'S REPORT

Mr. Hurd reported the following:

✓ <u>SVC Fields Use and Recommendation</u> - Staff are recommending a continuation of the maintenance and use agreement currently in place. We currently maintain the baseball field, soccer field, and their adjacent parking areas.

Sarah Perrin moved and Bruce Lee-Clark seconded to continue the Maintenance and Use Agreement that we currently have with the SVHC for up to two (2) years. The motion carried unanimously.

- ✓ <u>Citizen Survey</u> Will be launched on October 12, 2021 and available online at <u>www.benningtonvt.org/survey</u>, by mail upon request to 442-1037, or in person at Town Offices, the Community Center (Rec Center), and the Senior Center on Pleasant Street. The survey will close on November 3, 2021.
- ✓ <u>Mandatory Vaccination/Testing for All Town Employees</u> Effective November 1, 2021, all Town employees must be vaccinated or submit to weekly testing. This will allow some to begin the vaccination regime before the deadline. Both the Public Works and Police Union agreed with the mandate.
- ✓ <u>Coffee with the Seniors</u> Spent an hour at the Center on Wednesday talking with 20-25 seniors. Many of the questions and comments focused on senior safety on the streets including bike riders on sidewalks, skateboarders on sidewalks, panhandlers, and loud mufflers. Many are concerned about the possible move to the Benn High building, we need

FY 2023 Budget Schedule Attached please find the proposed budget schedule. You will note the Board's first work session is January 3, a Monday evening. I didn't think you'd want to meet on Saturday January 1, 2022.

Action requested By consensus accept this schedule.

<u>Vicious Dog Complaint and Hearing Date</u> We have a formal complaint and request for hearing. The earliest date available to hold said hearing is November 1, 2021. I am suggesting we meet at 5 pm at the Fire Facility public space to hear this complaint. If you all agree and a quorum is available, I will set the meeting room up.

Action requested Agree to set the hearing date as recommended.

INFORMATIONAL

Economic Development Strategy Update We await the report and recommendations of White and Burke, the firm contracted to analyze the projects provided by Town departments, BCRC staff, BBC staff, and the Select Board's Economic Development and Infrastructure subcommittee Available funding sources may be the \$3.9 million ARPA funds, the TIF and other grants. Once this work is completed, public input will be sought.

Stormwater Permits and Homeowners Associations Three existing stormwater permits now facing renewal require some changes due to regulatory action. We have been maintaining the stormwater in municipal rights of way. However, private residences with paved driveways and other spaces generate stormwater that must be managed under the law. We can comply by controlling what residents do on their properties (not an ideal situation) or we can, with the Sate's assistance, seek to have these developments form Homeowners Associations and through that authority manage their own stormwater. I've attached a letter of explanation. We should place on a future agenda to discuss.

<u>Public Works projects</u> Paving should be completed this week weather permitting. PFOA related water line extensions are essentially finished as is the south end water system improvements to increase pressure in higher elevations. Lead line removal efforts will continue for a time in those neighborhoods where lead service lines have been identified and remain.

Re: Review of Town stormwater permits

Dear Mr. Hurd,

MSK Engineers has reviewed the existing 9010 stormwater permits for the following subdivisions.

Country Terrace Subdivision #4135-9010.R
Barney Road Subdivision #3629-9010.R
Holt Springs Subdivision #6277-9010.R

The Country Terrace Subdivision permit covers Bradley Drive, Justin Avenue, and Laura Lane; The Barney Road permit covers Garbrooke Drive and Able Drive; and the Holt Springs permit covers West Street, Center Street, and East Street.

These permits quantify the impervious area within each development and specify what stormwater infrastructure is used to treat runoff. Each permit requires yearly inspections and for stormwater infrastructure to be maintained. For each of these developments, the permits cover runoff from surfaces both within public rights-of-way and on private parcels.

Because the State of Vermont has superseded the 9010 stormwater permit with the 9050 stormwater permit, all three subdivisions must have their 9010 permits renewed as 9050 permits when the current permits expire. The Country Terrace Subdivision permit expired on 01/03/2021 and was subsequently granted a 120 day application deadline extension, with a new application deadline of October 29th, 2021. The Barney Road Subdivision permit expires on 02/14/2023, and the Holt Springs permit expires on 01/27/2021.

MSK's records review of these permits indicates that each development was originally permitted by its developer. After each site was developed, the Town of Bennington assumed ownership of roads and right-of-ways and began acting as permittee for each site's stormwater permit.

Thus far the Town has acted in good faith by maintaining stormwater infrastructure within the right of way, however, as these permits cover private parcels as well, if the Town wishes to continue acting as permittee it must attain the authority to keep both public and private lands in compliance for each subdivision. This entails ensuring no new impervious surfaces are constructed within these developments on private land and maintaining any stormwater infrastructure on private land.

Alternatively, the Town can request (with the assistance from the state of Vermont) the residents of each development form a homeowner's association to act as co-applicant on these permits. In this case, the homeowner's association would ensure permit compliance on private parcels, and the Town of Bennington would continue to ensure permit compliance within right of ways. If this option is selected, the Town would apply for a Municipal Roads General Permit, permitting access roads and associated stormwater conveyance systems within the town right of way.

Town Manager Report to the Select Board October 2021

Chief Paul Doucette and Lt. Camillo Grande were accepted and will be attending the FBI-LEEDA Executive Leadership 5-day training program in November. Upon successful completion of this course, the Town of Bennington will be reimbursed by the Vermont League of Cities and Towns for costs associated with the training program.

The new statewide use of force policy took effect on October 1, 2021. The Use of Force Policy has been updated at the Bennington Police Department and placed on our website. We have been meeting with community partners in reference to this new policy and will be working together in an effort to better understand needs of other agencies and a combined response.

Members of the Bennington Police Department participated in the following community events during the month of October: SOCKTOBER – collection of socks for persons in need. Active shooter training at the Vermont State Employees Credit Union. Cancer awareness – PINK PATCH DISPLAY. Drug Take Bag with the Drug Enforcement Administration.

The Bennington Police Department received an award from Climate Advocates Bennington as a result of the purchase and use of hybrid police vehicles and electric patrol bicycles. The award was presented to Chief Doucette at CAT-TV on October 13, 2021. The police department shares this award with members of the Bennington community that supported our efforts to obtain these vehicles. We are looking forward to changing our fleet to all hybrid vehicles over the next four years.

Chief Doucette and Lt. Grande have been working with Jennifer Holley at Websites and More enhancing and adding information to our existing website. We have also been working with Jonah Spivak, Communications Director, with promoting the police department.

The Bennington Police Department continues working with United Counseling Service in order to bring Mental Health First Aid training to law enforcement officers in the area. Three members of the Bennington Police Department have been identified as potential instructors. Once trained, the members will present mental health first aid training programs to law enforcement officers in the area.

Lt. Grande and Chief Doucette instructed CJ101 to members of the Safety and Equity Task Force. The presentation was well received and we are looking forward to working with members of the task force in the future.

The new recruits completed Level 1 training and have been working with Field Training Officers at the Bennington Police Department. All four recruits passed the physical agility testing at the Vermont Police Academy and have headed off to the 19-week Level III training program. We anticipate successful completion of training by the end of February 2022.

Corbin Dean accepted a position as a dispatcher at the Bennington Police Department and began training this month. He will be participating in training on all three shifts. Much of the first month has been taken up with meeting with each of the department heads in the town and becoming familiar with where information is stored and how it is all handled.


Citizen Outreach:

I've met with, emailed, or spoken with 21 citizens on a wide variety of concerns or questions. I feel strongly that my role requires me to be present in the community as much as possible and my goal is to have at least one citizen interaction per day. When the interaction includes complaints I work to address those immediately whenever possible.

Business Outreach:

I've stopped by or emailed with the following businesses to hear their concerns or ideas: Gift Garden, Fiddleheads, Bennington Armory, Garage Distillery, Bennington Bookshop, Bennington Museum, Spice and Nice, and Bringing You VT. When possible, I follow up immediately (ie: new bike racks for Bennington Bookshop), and I'm recording more long term concerns to share with the appropriate departments.

Social Media / Facebook Report - First Month




Non-Profits and Community Groups:

These organizations often our partners in engaging with the community and I've made an effort to connect with a number of them early on and will continue to do so. Those include the SVSU, BCRC, CAT TV, and the Bennington County Coalition for the Homeless.

Facebook and Social Media:

Outreach via Facebook is currently our only significant social media platform. I plan to add Instagram in the future to increase engagement with different target audiences that are not using Facebook as much. I've expanded our postings to include more items of general interest to increase overall engagement and so far the results have been very good which indicates a strong interest in this type of information from the community.

Town Departments, Boards, Commissions, and Task Forces:

The Town has ten departments, plus the Senior Center and Bennington Community Center (Rec Center). I have met with each of those departments and have begun work coordinating with those departments as appropriate.

The Police Department is one that I expect will be a growing part of my work which also includes working with the Safety and Equity Task Force and associated efforts to share with the public progress and developments.

I've also worked with updates for the Historic Preservation Commission, the Energy Committee, the Town Clerks Office, and Collections.

Website Updates:

A major revamp of the town website is needed. The town has over 120 pages of information and over 1,300 posts of content. I've started doing research on other town websites and will be looking at our traffic logs to determine ways to improve navigation as part of preparing for an RFP to implement the update. My plan is complete this work and have a RFP ready to put out by the end of November.

Cyber Security / IT:

I've joined the town team that is charged with reviewing cyberse-curity and IT security. While I am not an expert in this regard, I am hopeful that my background experience in this area will be useful to the team and provide another set of eyes to help navigate this very complicated and ever changing landscape.

Current and Recent Projects:

One of the first projects to hit my desk was organizing an award ceremony for Climate Advocates Bennington (CAB) to present an Environmental Achievement Award to the Bennington Police Department. The ceremony involved coordinated with CAT TV, the Energy Committee, the BPD and Select Board members. A Bennington Banner photographer was in attendance as well. The result was a videotaped ceremony that is on CAT TV, You Tube, and has been shared on Facebook.

I'm currently working on a ribbon cutting event to celebrate the completion of the Orchard Village – Willowbrook Pathway. This upcoming event will be open to the public and will also be recorded. We will have an official date for this event by the time of this next Select Board meeting.

250th Planning:

Bennington has long been a leader in celebrating our local history and the 250th Anniversary of the Founding of Vermont and the Battle of Bennington is coming in 2027. We have continously celebrated the Battle since 1778 and several of those celebrations were of historic proportions in and of themselves — with the creation of the Bennington Battle Monument our greatest reminder of what is possible. What "big thing" will we do as our mark on posterity?

To that end I am active on the newly created Vermont 250th Anniversary Commission, and am the only commissioner representing Southern Vermont. I also serve on the Vermont 250th Education Sub-committee and I am happy to report that we are just

now beginning a collaboration with the SVSU that will help inform our work at the state level. I am also part of the Vermont delegation to the Federal America 250th commission.

I am also working on the creation of a local committee to interface with the State and Federal commissions to focus specifically on Commemoration efforts for Bennington. I will report on this further in November.

Citizen Survey:

Another initial project has been the creation of a citizen survey, based on surveys that have been done in 2016 and 2018. The survey launched on October 12 and will be running through the week of November 2. Currently we have 322 responses and a 73% completion rate. Average time to fill out the survey is 15 minutes. The survey is promoted on social media, stories in the paper, and we have purchased ads in the Bennington Banner.

Future Proactive Outreach:

I'm interested in creating an advisory team of local business leaders, do outreach to fraternal orders and social clubs, and create paths for citizen involvement and listening.;

Town of Bennington Bike/Ped Projects Update October 2021

Orchard Village (formerly Applegate) to Willowbrook Path

<u>Project Description</u>: Pathway to connect Orchard Village, Willowbrook Apartments, and Molly Stark Elementary School.

<u>Status:</u> Construction of the pathway is complete. A ribbon cutting ceremony will occur in November.

Ninja Trail

<u>Project Description</u>: The proposed path is 2.12 miles. It begins on Hicks Avenue at the existing pedestrian bridge and ends at the intersection of VT Route 67A/College Drive/Silk Road/Matteson Road. From there, pedestrians and cyclists can reach the Village of North Bennington via Bennington College's paths and low-speed roads. The path varies between wooded areas, open fields, and roadside facilities. It crosses streams, goes under an overpass, and crosses a highway.

Status: \$1 Million in State/Federal Grants have been secured. An update of the cost estimate using current pricing indicates that significant additional funding will need to be secured to complete the entire project, but it is hoped that by splitting the project into phases construction may commence before all of the funding is secured. Additional grant opportunities are being explored. Segments of paved path between Hicks Avenue and Harmon Road (behind Walmart) and between Bennington College entrance and the Hampton Inn have been constructed. An interim path (dirt and gravel) between the two completed segments had been open for use, but the temporary bridge over the Furnace Brook has been closed due to rotting supports. The Dept. of Buildings and Grounds is considering options for repairs to the temporary bridge as we await construction of the permanent bridge. Preliminary plans for the construction of the remainder of the paved path have been approved by the State. The Town has now obtained all of the easements required for the project. Construction of the first phase of the project is scheduled for 2022 subject to State permits being issued in a timely fashion.

Bennington Pathway – Rail/Trail

<u>Project Description</u>: Shared use path (bike path) along Railroad Right-of-Way from Bennington Station to Emma Street (off of Northside Drive). The portion of the path from Bennington Station

to Orchard Road will be paved. The remainder of the path will be gravel.

Status: State/Federal Grant for 90% of cost has been secured. A local match of \$100,000 is being held in a reserve account. An additional \$80,000 match is necessary and will impact the FY 22 budget. The Town has contracted with Markowski Excavating to construct the project. Clearing of vegetation has been completed and removal of the rails and excavation of stumps has begun. Construction will likely conclude in September of 2022.

Benmont Avenue Bike/Ped Improvements

Project Description: Improvements to make Benmont Avenue safer and more attractive for pedestrians, cyclists, and drivers, including significant changes to the Hunt Street intersection. The improvements will act as an extension of the Ninja Trail into Downtown Bennington.

Status: A total of \$559,000 in State/Federal Grants have been awarded. The Town match will be approximately \$140,000. All easements have been obtained. Additional funds may need to be sought. The Town DPW will likely construct the planned improvements to the Hunt Street intersection to keep costs down. Grant funds will be used to construct the remainder of the project. Final plans are complete and will be submitted to the State for review and approval next month. Project scheduled to be put out to bid in Spring of 22. Construction is scheduled for 2022-23.
