Mrs. Gomes also reported that she had put the Bristol County Northern Registry of Deeds building roof at 11 Court Street out to bid. The FY '22 department budgets have been sent out with a return date of May 10th. She asked the County Commissioners if they wished to choose a date for the Priority Deeds Budget Hearing.
