A communication dated August 16th from members of the Massachusetts General Court representing different areas of the County was received, requesting a per capita distribution of ARPA funds to the cities and town within the County.

A motion was made by Commissioner Saunders, seconded by Commissioner Mitchell to receive and place on file.

A motion was made by Commissioner Saunders, second by Commissioner Mitchell to take the items of #11 out of order.

Upon motion of Commissioner Mitchell, second by Commissioner Saunders it was voted to authorize the County Treasurer to submit the first quarterly reports through August 31, 2021 to the US Treasury regarding the ARPA Funds that have been received by Bristol County.

Motion approved.

Upon motion of Commissioner Mitchell, second by Commissioner Saunders it was voted to engage the legal services of **Mintz**, **Levin Cohn**, **Ferris**, **Glovsky and Popeo** to advise Bristol County on matters involving the American Rescue Plan Act ("ARPA") in accordance with the <u>Engagement Letter dated August 20, 2021</u>. This agreement will include the counties of Plymouth and Norfolk. Said agreement to be signed by County Commissioner Chairman Kitchen.

Motion approved.

Commissioner Saunders asked Treasurer Christopher Saunders if he had a conflict with CLA. He responded that he had no conflict since it was the County Commissioners who would vote to hire them.

Upon motion of Commissioner Saunders, second by Commissioner Mitchell it was voted to engage the accounting firm Clifton Larson and Allen ("CLA") as the <u>primary</u> accounting firm to advise and assist Bristol County on matters involving the American Rescue Plan Act ("ARPA") in accordance with their Letter of Engagement dated August 19, 2021, and allow the Chairman to sign the letter of engagement. This agreement will include the counties of Plymouth and Norfolk.

Motion approved.

Commissioner Mitchell explained that as part of Bristol County's collaboration with Plymouth and Norfolk County, all three counties would use the same accounting and law firms to develop, review and assist with administering the ARPA funds. A second accounting firm had been added to assure additional review of the application process.

Upon motion of Commissioner Saunders, second by Commissioner Mitchell it was voted to engage the accounting firm of Powers & Sullivan LLC as the supplemental review firm to assist with the American Rescue Plan Act ('ARPA') as explained in their letter of engagement draft provided on August 23, 2021. Motion approved.

Upon motion of Commissioner Mitchell, second by Commissioner Saunders it was voted to authorize and designate the Bristol County Treasurer to apply for, accept and administer all federal funds available to the County of Bristol through the American Rescue Plan Act ("APRA"), and to design and implement a plan for the expending of such funds contingent on the County Commissioners approving such program. The Commissioners will be the authorized approval to release ARPA funds.
