**OATH OF OFFICE FOR NEW POLICE OFFICER**

At its June 8 meeting, the Board of Fire and Police Commissioners approved an offer of employment to applicant Brandon Valentino, contingent upon his successful completion of a psychological exam, physical exam and drug screen. Mr. Valentino successfully completed these requirements and will be sworn in as a probationary Patrol Officer at this meeting.

**A. Stratis Family Stormwater Award**

The Burr Ridge Stormwater Committee has long been an advocate of private investment in the stormwater systems in Burr Ridge. Our community has over 100 detention basins, as well as many miles of streams, rivers, and regulated floodplain. The vast majority of these systems are under the ownership and maintenance of private parties, primarily homeowners, businesses and homeowners associations. In this regard, the Stormwater Committee wishes to acknowledge and commend those parties who improve a portion of the stormwater system on their property, which serves not only the benefit of the immediate property owner, but the larger community as well.

The Stratis property includes a stream which had experienced significant erosion and sedimentation. The Stratis family proposed to remove the sediment from the stream, construct a pedestrian bridge, and to remedy erosion through natural plantings and stream bank stabilization methodologies. Since the project would take place within the floodplain, permits were required from both DuPage County and the Village of Burr Ridge. Mr. Stratis employed Engineering Resource Associates to prepare the design plans and to permit the project; the construction was performed by Encap, Inc. The plantings which were installed include a variety of native plants, which will stabilize the stream and protect against further erosion. This project is an excellent example of the use of natural methodologies to control erosion in an attractive and sustainable fashion. The work was performed in autumn, 2010.

The Stormwater Committee wishes to congratulate the Stratis family on completing this project and to present them with a "Pond and Stream Beautification Award". This project will be acknowledged by presentation of a framed Resolution of Recognition from the Board of Trustees (see attached), a notation on a plaque in the Village Hall foyer and by a granite award marker at the site. Congratulations!

**It is our recommendation:** that the Resolution be adopted.

## **8. CONSIDERATIONS**

### **A. Repair of Village Hall Chiller**

The Village Hall HVAC system has experienced a major failure during the recent heat. A primary compressor in the Village Hall chiller, which is original to the building, has failed and requires replacement. Currently, the Village Hall chiller is operating on a secondary compressor. The cost of the repair is estimated at \$12,765, which includes \$9,949 in parts (78% of cost) and \$2,816 in labor (22% of cost). The work will be performed by Alliance Mechanical Services at the approved labor rates subject to the Village Hall maintenance agreement currently in place. Although this is not a budgeted item, there is \$5,000 set aside in the current budget for HVAC repairs to help offset some of the cost of this emergency expenditure.

**It is our recommendation:** that the Board authorize repair of the Village Hall chiller in an amount not to exceed \$12,765.

### **B. Contract for Engrg. Services (Garfield Street & Madison Street LAPPs)**

The Village has been awarded \$450,000 in STP grant funding to improve Garfield Street between 59<sup>th</sup> and 63<sup>rd</sup> Streets, and Madison Street between 79<sup>th</sup> and 91<sup>st</sup> Streets. Since these projects are federally funded, they must comply with complex State and Federal documentation, design and specification regulations in order for the project to be permitted for construction. The Madison Street LAPP is scheduled for construction in the 2013 construction season and the Garfield Street LAPP is scheduled for construction in the 2014 construction season.

The Village has solicited proposals from qualified professionals in accordance with the State QBS (Qualification Based Selection) statutes. Since this project is federally funded, it was particularly important to identify whether applicants had adequate experience processing similar federally-funded projects. The Village solicited proposals from five qualified candidates: Burns & McDonnell, Engineering Resource Associates, Trotter and Associates, Strand Associates and Christopher B. Burke Engineering. Four proposals were received, from Burns & McDonnell, Trotter & Associates, Engineering Resource Associates and Strand Associates.

Based upon review of the proposals and interviews with each firm, the most qualified consultant was determined to be Engineering Resource Associates, which also proposed the lowest fee for each of the projects. The ERA proposals include a not-to-exceed fee of \$21,878 for the Garfield Street project, and a not-to-exceed fee of \$35,528 for the Madison Street project; the fee for each project is below the amount budgeted in the FY 12-13 Capital Budget. Summary proposals which provide detailed scope are enclosed.

**It is our recommendation:** that Professional Services Contracts be awarded to Engineering Resource Associates for the Madison Street LAPP, in an amount not to exceed \$35,528, and for the Garfield Street project, in an amount not to exceed \$21,878.

**C. Raffle License (C.O.P.S.)/Hosting Facility License (BR Park District)**

Cpl. Mike Barnes is submitting an application from the Illinois Chapter of Concerns of Police Survivors (C.O.P.S.) to conduct a raffle on August 11, 2012, as part of their fundraising event at the WB/BR Chamber of Commerce's Cruisin' 66 festival, as well as a letter requesting waiver of the fidelity bond requirement. Also, the Burr Ridge Park District is submitting a letter requesting that they be issued a hosting facility license to allow them to hold this event at their Harvester Park location.

**It is our recommendation:** that a Raffle and Chance License be issued to the Illinois Chapter of C.O.P.S. for its August 11 raffle, with the fidelity bond waived, and that the Burr Ridge Park District be licensed to host the event.

**D. Approval of Vendor List**

**RECOMMENDATION TO HIRE PART-TIME LABORER TO REPLACE VINCENT MONACO** The Board, under the Consent Agenda by Omnibus Vote, authorized the Public Works Director to hire a part-time laborer to replace Vincent Monaco.

**ADOPTION OF RESOLUTION ADOPTING THE PREVAILING WAGE RATE FOR LABORERS, WORKERS AND MECHANICS EMPLOYED IN PUBLIC WORKS OF THE VILLAGE OF BURR RIDGE, COOK AND DUPAGE COUNTIES, ILLINOIS** Village

Administrator Steve Stricker explained that the Village is required by the State Labor Department to annually approve, each June, the wage rates for laborers employed in Public Works projects. He stated the employees must be paid at the prevailing wage rates for construction workers in Cook and DuPage Counties.

Trustee Paveza inquired about the source of the prevailing wage rates and in response, Mr. Stricker explained that the wage rate is mandated by the state and has been in place for many years.

The Board discussed the significance of the wage rates and the monetary effects to the Village.

Mr. Stricker explained that the unions monitor contractor payments to ensure the prevailing wages are being paid.

Trustee Sodikoff suggested the prevailing wage rates be published for the general public and also that Village Counsel opinion be obtained regarding the requirement to pay prevailing wage rates.

Motion was made by Trustee Sodikoff and seconded by Trustee Paveza to adopt the Resolution adopting the Prevailing Wage Rate for Laborers, Workers, and Mechanics employed in Public Works of the Village of Burr Ridge, Cook and DuPage Counties, Illinois.

**REQUEST FROM MAYOR GRASSO FOR REIMBURSEMENT FOR ATTENDING THE ICSC CONFERENCE** Mayor Grasso explained that he attended the three-day International Council of Shopping Centers Annual Convention in Las Vegas with representatives from DuPage Mayors and Managers. While in attendance, Mayor Grasso worked at the “Choose DuPage” booth

providing information about communities, including Burr Ridge. In addition, Mayor Grasso visited other booths to discuss restaurant and entertainment opportunities in Burr Ridge and had meetings in

the evening with developers, including Scott Rolston of Mid America/Opus. Mayor Grasso did not realize that the Village reimbursement policy for elected officials requires that out-of-state conferences be pre-approved by the Village Board and requests Board approval for reimbursement of some or all of his expenses for the conference.

Trustee Grela noted that it is stated in the Village Reimbursement Policy that the Mayor and each Trustee is provided an amount not to exceed \$200 for attendance at Village-related social functions and questioned if the \$1,000 is an aggregate amount. Village Administrator Steve Stricker responded that the Mayor is allowed \$1,000 and \$200 is permitted for the Trustees.

Motion was made by Trustee Paveza and seconded by Trustee Grela to approve the reimbursement for Mayor Grasso's expenses for his attendance at the International Council of Shopping Centers Annual Convention in Las Vegas in the amount of \$1,000.00.

**COMMUNITY SURVEY QUESTION & ANSWER** Mayor Grasso addressed the question; I never see a squad car in my neighborhood. Can the Village increase patrols?

Mayor Grasso explained that the Village is divided into four areas called "patrol beats" covering approximately 7.5 miles and officers patrol these beats over an eight-hour shift. In addition to patrol duties, officers respond to calls for service in their beat, patrol school zones when students are arriving and departing, write reports, conduct criminal investigations, and process arrestees.

Mayor Grasso provided statistics supporting the Burr Ridge Police Officer activities and explained that if specific problems are brought to the attention of the Police Department, additional patrols may be present in those areas. Mayor Grasso emphasized that residents should call 9-1-1 for concerns requiring immediate attention or residents may call the non-emergency number.

## ***Project Understanding***

The Village of Burr Ridge desires to construct a functional overlay along Garfield Street between 59<sup>th</sup> Street and Countryside Court including the installation of curb and gutter and storm sewer on the west side of Garfield Street throughout the project limits as well as the east side of Garfield Street between 59<sup>th</sup> and 60<sup>th</sup> Streets. 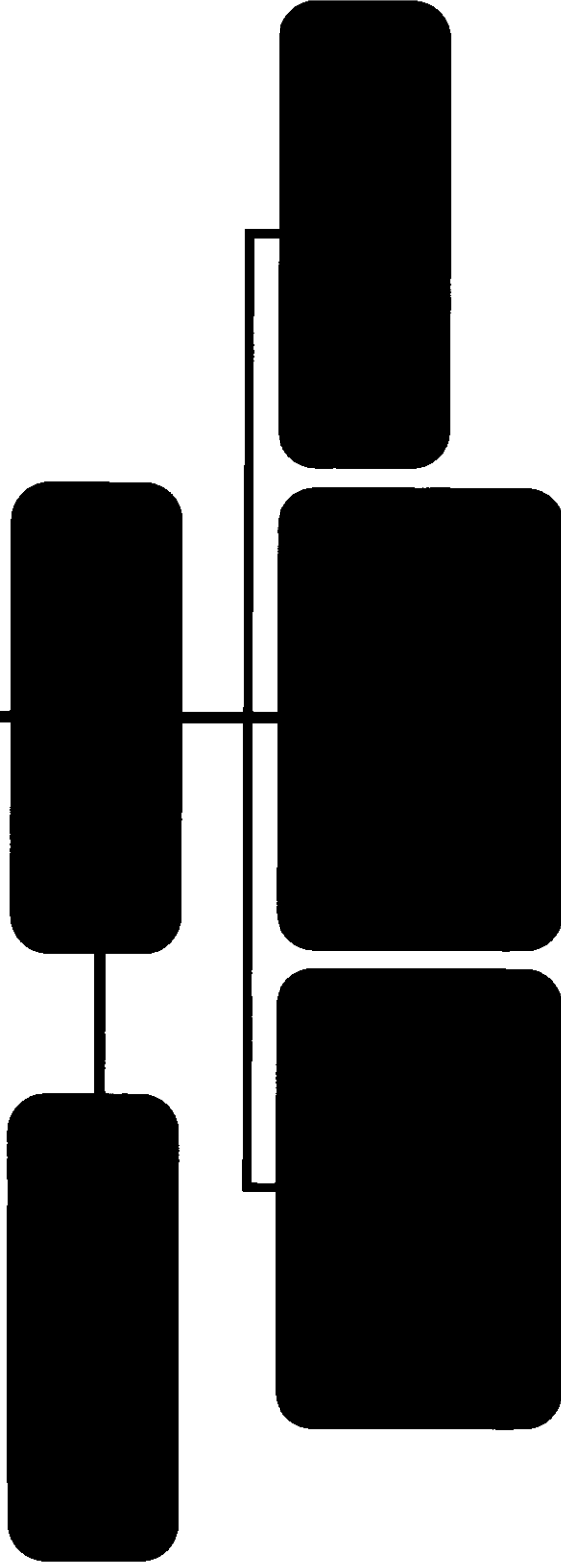
