#### A Message from the Mayor:

Improvements, upgrades, enhancements. Whatever you want to call them, this has certainly been the year for all that in Burr Ridge. The almost year-long process of reconstructing the County Line Road bridge has come to an end, as far as the major construction goes. Landscaping, lights, and signage will be completed in the spring. New windows and storefront preparations in the Village Center have been ongoing since this summer, and will continue as they ready themselves for new businesses and stores to open in the Village Center. New housing developments have been started, and others have been finished. The expansion project at St. Mark Coptic Church is coming along nicely, and the build out of Global Luxury Imports is complete. Both the Quality Inn and the Spring Hill Suites hotel properties have undergone extensive remodeling, with wonderfully appealing results. Patti's Sunrise Café' took on the challenging task of remodeling and upgrading a favorite Village breakfast and lunch spot. A cost saving measure to upgrade the Village Board to tablets for the dissemination of materials and information has been completed, with ongoing training as needed.

All of these projects have a running theme throughout them - improvement. Without constantly working to improve things, they become stale, stagnant, and out of date. Things fall apart, they work inefficiently, and nothing flows as well as it should.

Burr Ridge has seen a great deal of improvements going on in the Village this year, and we intend to keep the forward momentum going. With the Village elections coming up in April, there will be an opportunity for three Trustee positions to be filled. New chances for more ideas, input, and visions to come to light.

These improvements and upgrades are all contingent on the times. We strive to keep up with them, and continue to change. All the while wanting to remember and honor who we are, and where we came from. Burr Ridge has a rich, long history of families and businesses in the area with deep roots. ### County Line Road Bridge Reconstruction Nears Completion

The major construction phase of the bridge reconstruction project is complete. Utilizing an ITEP grant of \$1.45 million, the bridge structure was redone this spring/summer/fall. Construction remained on schedule, with all lanes open by year end. Final improvements of electrical enhancements and new landscaping will be installed in the spring. The Village's portion of these enhancements are being paid for 100% by the Hotel/Motel Tax Fund. Again, many thanks to Senator Christine Radogno and State Representative Jim Durkin for their efforts with this project.

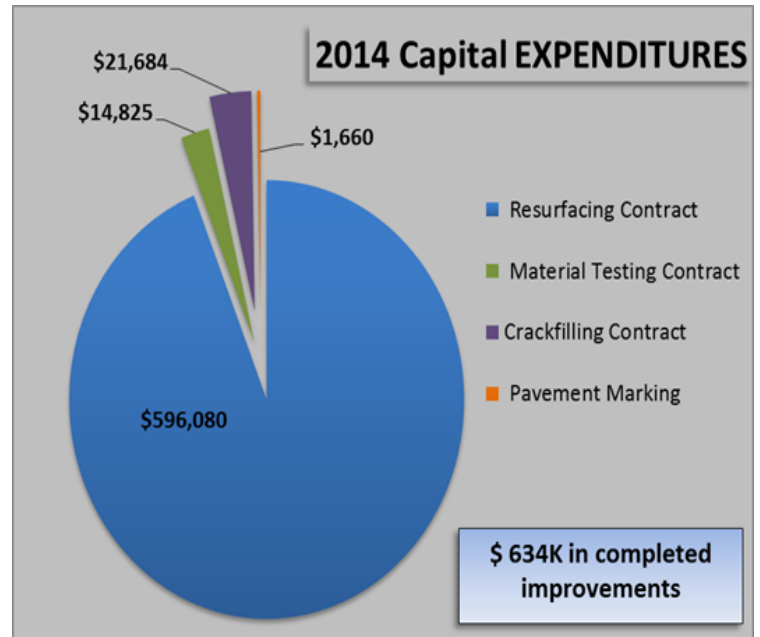

### 2014 Capital Improvements Program

This year's Capital Program was completed under three budget category areas: resurfacing, crack-filling, and pavement marking. Overall, these projects were completed on time and under budget as follows:



**Resurfacing:** The resurfacing program was budgeted in the amount of \$668,300 and was awarded to low-bidder Central Blacktop. The project included patching costs, resurfacing of the Fieldstone subdivision, the West Babson Park subdivision, Madison Ridge subdivision, and Veteran's Boulevard. The overall completion cost was \$596,080 - 10.8% under budget.

**Crack-filling:** The budget amount for this was \$20,000. Preventative crack-filling was handled by Patriot Pavement Maintenance, the DuPage County MPI low bidder. Total cost for crack filling was \$21,684.

**Pavement Marking:** \$15,000 was budgeted for pavement marking, the contract was awarded to the Suburban Purchasing cooperative low bidder of Superior Pavement Marking. Due to the truncated construction season, a minimal amount of pavement marking was performed in the amount of \$1,659.

As a whole, the 2014 Capital projects were completed on time and under category budgets. \$634,000 worth of work was completed on the Village's transportation system at 11.7% under budget. The Village will use a portion of these funds to sealcoat the Village Hall and Department of Public Works parking lots prior to the end of the fiscal year. This is a project estimated at \$10,000. Staff is currently soliciting prices for this work at the direction of the Street Policy Committee. This sealcoating work is to be completed prior to May 1, 2015.



**Election Day - April 7, 2015**

Residents may vote in the upcoming General Election for the open positions of three Village Trustees. The Village Hall and the Police Department will be open from the hours of 6:00 a.m. until 7:00 p.m. for residents to vote. Seven Burr Ridge residents have filed for the three open Trustee positions, all are for four year terms. All those interested in running for election were required to file their candidacy petitions with the Village by 5:00 p.m. December 22nd. Those filing candidacy petitions were: Albert J. Paveza, Paula Murphy, Antonio Schiappa, Mary T. Praxmarer, Robert A. Grela, Jimmy Haimann, and Jim Broline. The Trustee positions of John Manieri, Al Paveza, and Len Ruzak are up for election. **Armed Forces Day Celebration Focuses on All Military Branches, Grants Second Patriot Award to Walter H. Bergenthal**

Attendees of the Fourth Annual Armed Forces' Day were treated to yet another spectacular aerial flyover to open the celebration, as well as patriotic songs by the Marmion Academy Military Band. Prefaced by a signal performance of "Reveille", three antique military planes flew in formation over the Veterans Memorial, with the "missing man formation" as the final flyover. Held at the site of the Veterans' Memorial in Burr Ridge on Saturday, May 17th guests were enthralled by stories of canines in the military known as "War Dogs" and their historical significance from guest speaker Lieutenant Colonel (retired) Terrence J. Benshoof of Glen Ellyn. This year's Patriot Award was awarded to Walter H. Bergenthal, a resident of Western Springs and charter member of the local VFW 10778. Mr Bergenthal also served as an interpreter during the entire European Campaign and the Nuremberg Trials.

An invocation and benediction was given by Trinity Lutheran Church Pastor and veteran Robert Geaschel, and a closing rendition of "Echo Taps" was played before guests enjoyed a reception at the Village Hall. Special thanks to the Veterans Memorial Committee members, which include Len Ruzak, Jack Schaus, John Moskal, John Curin, Cody Curin, Russell Smith, Ken Thompson, and Mickey Straub.

**Hotel & Restaurant Committees Continue Use of Creative, Fresh Marketing Ideas**

Working with Boost Communications, the Restaurant and Hotel Marketing Committees continued their efforts to reach a broader audience and increase their market share of the hotel/restaurant business in the greater Chicago area. Through the use of creative and catching ad campaigns in select magazines and newspaper ads, the Committees have been establishing Burr Ridge as a "Destination" location, where you can shop, dine, be entertained, and stay in luxury hotels all at the same place. The Committees have also been branching out to reach specialized markets such as meeting planners, conference organizers, and ethnic wedding planners through select trade publications to increase their appeal in these niche markets. The Second Annual Restaurant Week was held in September this year, with a coupon mailer sent to Burr Ridge residents to entice them to try a new restaurant. Reusable tote bags were again given out at a few of the concerts to further promote both the Restaurants and Hotels. **Police Department Reports Decrease in Serious Crimes**

The Police Department reported a 30% decrease in serious crimes, Part I Offenses this year, with a total of 107 major crimes reported. While Part II Offenses, lesser crimes, stayed relatively unchanged. Since this past fall, Burr Ridge has been hit with a string of burglaries by a multi-ruse burglary crew. Surveillance cameras have been very helpful as evidence in these burglaries, and officers have been vigilant in their patrols, leading to the capture of one suspect and identification of others. Several officers were also honored this past year for their efforts in combating driving under the influence of alcohol and drugs. Five officers were awarded the "Top Cop Award" by the Alliance Against Intoxicated Motorists for showing a dedication to traffic safety by arresting impaired drivers.

Two new officers were added to the Police Department this year. Officers John Booras and Matthew Overton successfully graduated from the Police Academy and completed their Field Training Programs. Two long-standing members of the Police Department Administrative staff retired this year; Rayette Norlock and Barb Gerald both retired with 35 and 20 years of service, respectively. Officer Angie Wilhelmi was honored by the Illinois D.A.R.E. Officers Association for her 24 years of service, Officer Michele Glosky was promoted to Corporal, and Corporal Michael Barnes was promoted to Sergeant.

### **Police Community Relations Events Foster Involvement -**

The Police Department will hold their 17th Annual Citizens' Police Academy (CPA) from January 22 to March 26th, giving participants an interactive and behind the scenes look at police operations. The Police Department participated in several fundraisers this year, raising over \$900 this year in the annual "Cop on the Roof Top" event for Special Olympics; \$360 was raised to help a local needy family purchase food and gifts for the holidays through the annual Village Chili Cook Off ; and with \$1,250 raised, ten local children were able to participate in the "Shop With A Cop" event sponsored by DuPage County Sheriff's Office. Additionally, the 7th Annual "Night Out Against Crime" was held in Harvester Park early in August and was very well attended.

### **Community Development Department Reports Significant Increase in Building Permit Activity - Again! -**

Building permit activity was up again in 2014, with the month of August having the greatest number of permits issued. Permits were issued for 31 new homes, compared to 33 new homes in 2013 with a construction value of approximately \$18 million.. Residents again invested heavily in existing homes with 55 permits issued for residential additions and alterations with an estimated construction value exceeding \$2.9 million, compared to 54 permits issued at over \$5 million in 2013. Construction values for non-residential permits reached nearly \$20 million in 2014, as compared to \$10 million in 2013.

### **Economic Development Committee**

New businesses opened in the Village Center this year, including Two Bostons - a pet supply boutique, Francesca's - a clothing and accessory boutique, and national women's clothing retailer J.Jill. Plans for women's clothing store EverEve, and wood-fired pizza restaurant Stix & Stones to open in 2015 were also solidified this year. Additionally, Chase Bank opened its doors at 150 Burr Ridge Parkway in February and a "Business Appreciation Breakfast" was hosted by the Economic Development Committee in April. At the breakfast, MARS Chocolate was awarded the first Community Appreciation Award for all their contributions to the Village. Business owners were networking and connecting with each other, and talk of developing a Burr Ridge Business Group has been heard. The Economic Development Committee has been examining ways in which the PACE bus routes servicing Burr Ridge might be utilized to further promote Burr Ridge as a great location to live and work, with easy transportation options to Chicago. Economic Development Committee members include Mayor Mickey Straub, Trustees Len Ruzak and John Manieri, Bhagwan Sharma, Zach Mottl, Sheryl Kern and Mike Donahue.

### **Plan Commission/Zoning Board of Appeals -**

2014 was a busy year for the Plan Commission/Zoning Board of Appeals, with 16 Plan Commission public hearings and 12 Zoning Board hearings. Construction for expansion began at St. Mark's Coptic Orthodox Church at 79th and Garfield Streets, Global Luxury Imports completed its build out in their new location on the Northeast Frontage Road, construction of the new Chase Bank

on Burr Ridge Parkway was completed in February, and ground has been broken near 75th street and south frontage road for the new Anthem Memory Care center. Approvals were also given this year for sidewalk café's for Wok N' Fire and Red Mango. A big thank you to the current members of the Plan Commission/ Zoning Board of Appeals for all their hard work. Committee members are: Chairman Greg Trzupek and Commissioners Mike Stratis, Dehn Grunsten, Luisa Hoch, Bob Grela, Greg Scott, and Mary Praxmarer.

**Pathway Commission** - Six meetings were held for the Pathway Commission this year. New sidewalks were planned for the north side of 79th street between Burr Oak Lane and Chasemoor Drive, reconfiguration of the accessible sidewalk ramp at the S.E. corner of 79th and Woodside Lane; future maintenance or replacement of asphalt sidewalks, and review and approval of an updated street and pathway map. Pathway Commission members include Pat Liss, Marilou McGirr, John Pacocha, Todd Davis, and Luisa Hoch.

**Village Partners With Indian Prairie Public Library** - The Village of Burr Ridge has partnered with the Indian Prairie Public Library to increase awareness of their services and benefits to residents of Burr Ridge. Each year, residents ask why Burr Ridge doesn't have its own library. Due to boundaries, taxes, and location it's not feasible. The Indian Prairie Public Library offers library cards/memberships to Burr Ridge residents at the reasonable price of \$186 dollars per year. With that comes access to hundreds of programs each year, thousands of books, videos, tapes, and more, as well as reciprocity with other community libraries nearby. Check out the IPPL!



**Special Events and Concerts on the Green** - The Village Special Events were well attended this year, with larger turnout crowds for the concerts than ever before. The Friday night "Concerts on the Green" brought musical groups representing all different types of music - contemporary, big band, country, rock, pop, and more. Residents continued to enjoy the evenings in Ravinia-style, with lawn chairs and blankets spread out across the Village Green. Local businesses sponsored individual concerts and were given the opportunity to really highlight their business at those concerts!

**Run The Ridge 5k** - This was the 10th Anniversary of the "Run the Ridge" race. Once again, runners and walkers lined up near County Line Square to raise funds for this year's race beneficiary, Pro Active Kids. Mike Adamle was the guest emcee and led the crowd out of the starting blocks.
