Village Highlights and Updates

- **IDOT Project to Start in Early September on Madison Street under I-55:** The Illinois Department of Transportation has advised that starting in early September, a two-month-long detour for southbound Madison Street under I-55 will be necessary. Northbound Madison Street will be unaffected; however, southbound Madison Street will be detoured to southbound IL Route 83, then Central Ave/South Frontage Road, and end on South Frontage Road/79th Street. This will allow IDOT's contractor to repair the bridge piers and beams that carry Interstate 55 over Madison Street. The Village will push out notifications when exact dates have been determined and as the work progresses.
- **Tollway Project on Plainfield Road to Include Nighttime Demolition:** The Illinois Tollway has sent the attached letter to residents near the Plainfield Road bridge regarding their work anticipated to intermittently occur overnight, and which includes concrete breaking at least three nights next week. Attached is a letter to residents in the area notifying them of the upcoming intermittent overnight work. - **Concerts on the Green:** We had another successful evening for our Thursday concert series. Billie Elton received overwhelmingly positive feedback from residents at the show, with many requesting the band return in the future. Next Thursday, look forward to the Chicago Experience, celebrating the legendary band "Chicago."
- **New Police Vehicles:** The Police Department has received four new, 2021 Chevy Tahoes. These squad vehicles replace aging Ford Explorers and are both significantly safer for our officers and roomier for training purposes, as well as better equipped - all at a lower overall cost than previous models. Dear Resident:

The Illinois Tollway's Central Tri-State Tollway (I-294) Project is underway to reconstruct and widen the roadway from Balmoral Avenue to 95th Street. The project will replace old infrastructure and provide congestion relief to meet future transportation demands and address regional needs. The project began in 2018 and is scheduled to be complete in 2026.

As we shared with you previously in our July 1, 2021, letter the Plainfield Road Bridge over I-294 and Flagg Creek is being removed and reconstructed to accommodate the roadway reconstruction. Work on this project has begun and the new bridge is scheduled to be complete in spring 2023.

The Plainfield Road Bridge will remain open to traffic during construction as the contractor is working on one half of the bridge at a time.

While the majority of construction work is taking place during daytime hours, some activity, including breaking of concrete and removal of portions of the bridge structure, will require intermittent nighttime work. This activity is scheduled due to allowable lane closures on the Tollway that are needed to provide a safe work zone for workers and traffic. We recognize this may be an inconvenience so we are proactively working with the contractor minimize night work to the fullest extent practicable.

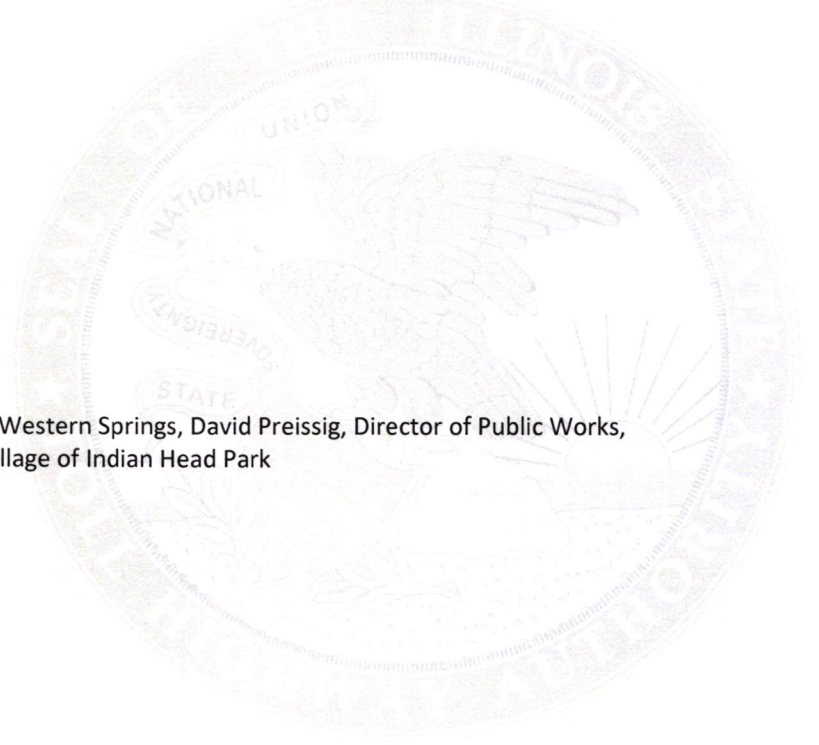

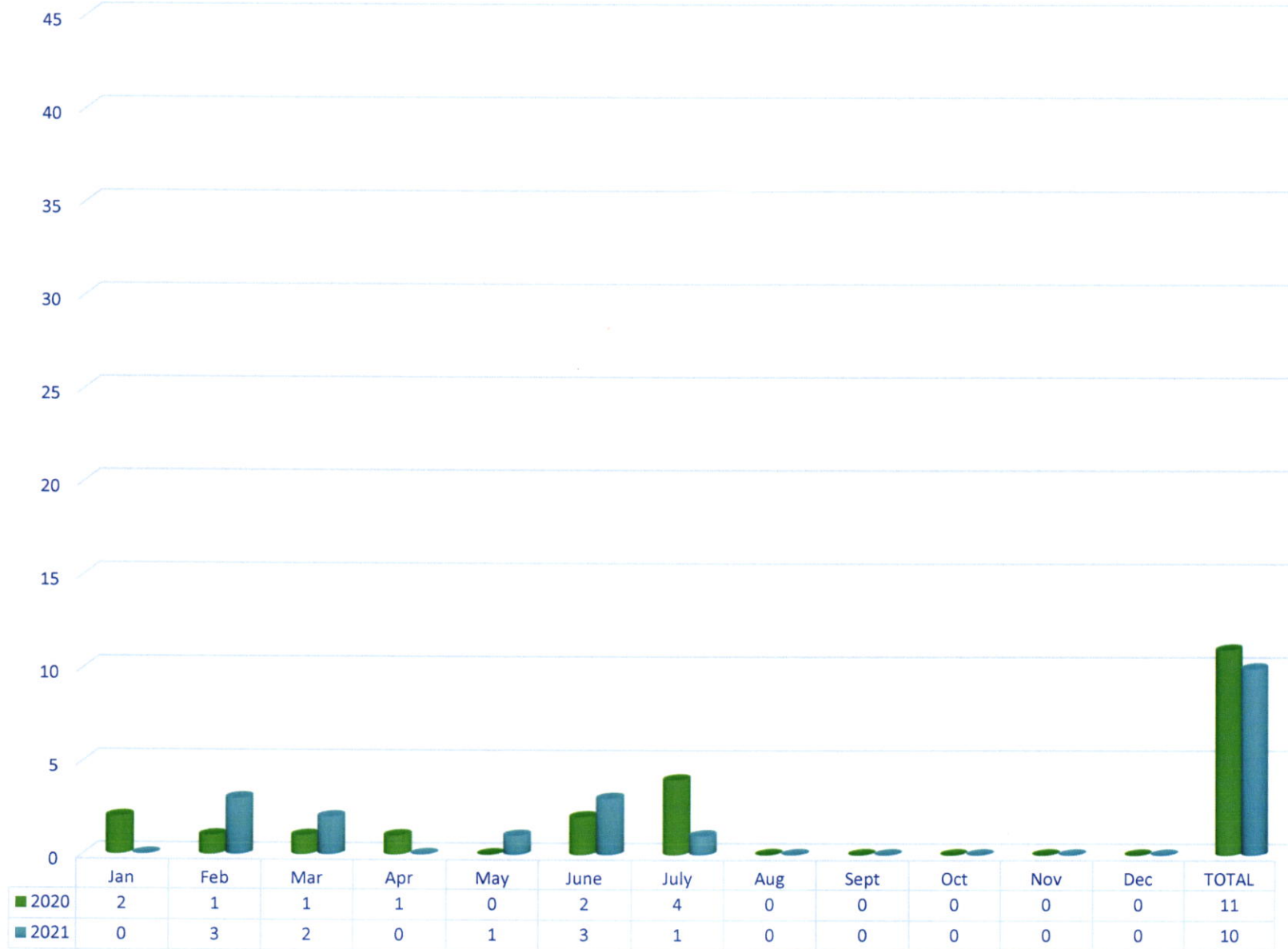

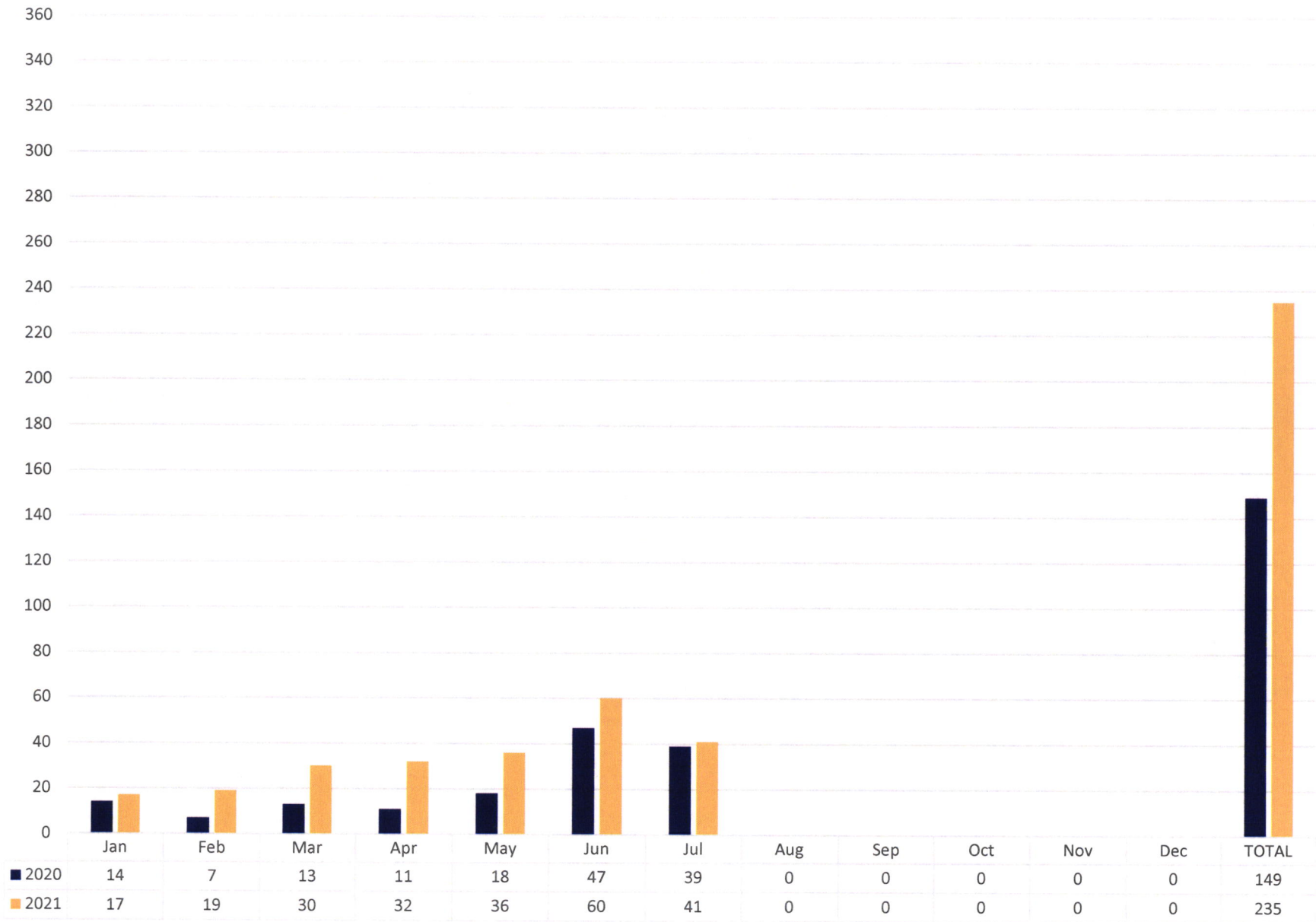

Village of Burr Ridge New Housing Permits 2020 Compared to 2021

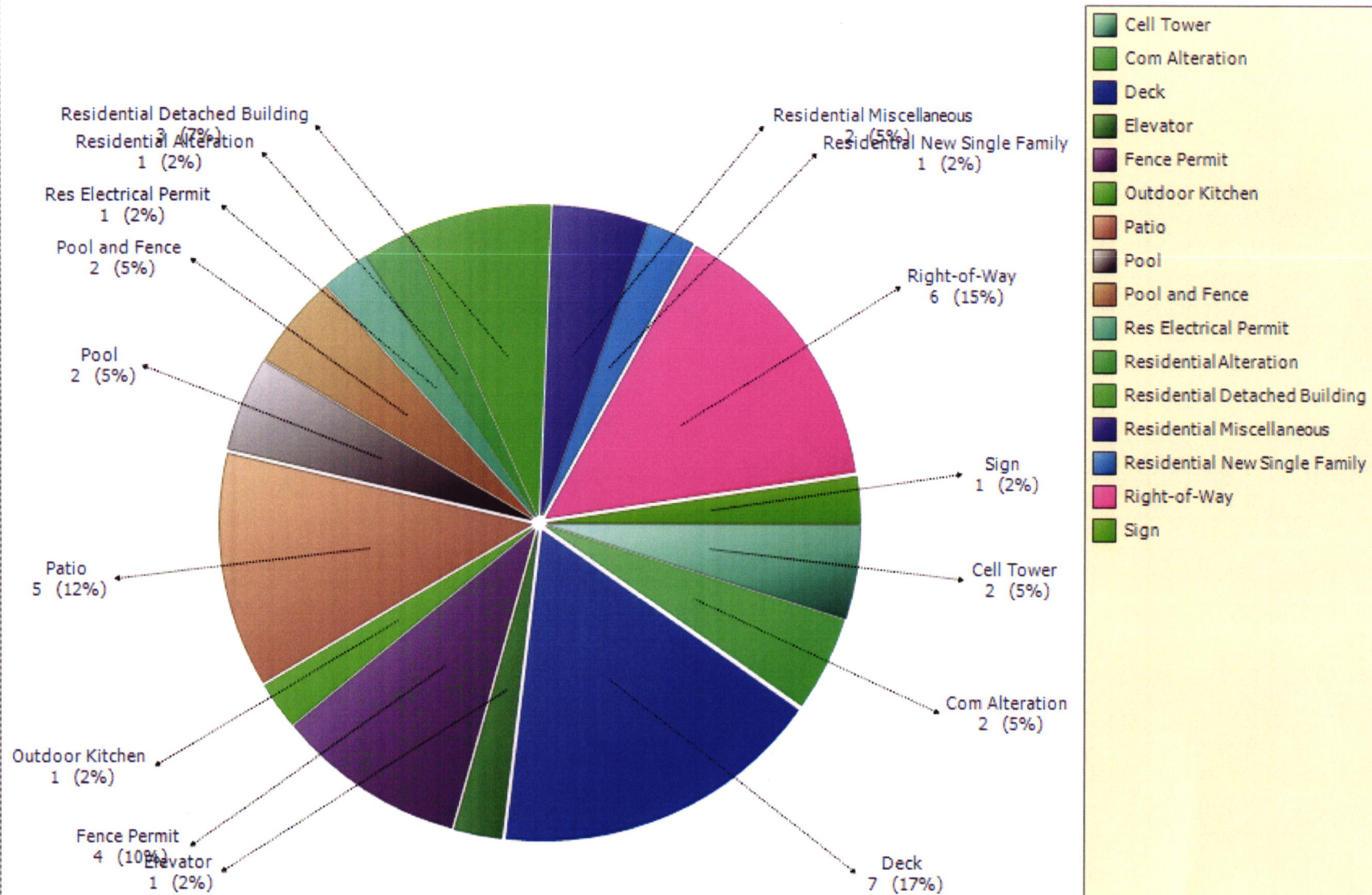


Village of Burr Ridge Building Permits Issued 2020 Compared to 2021

This edition of the *Statehouse Briefing* provides the release of redistricting data from the U.S. Census Bureau, a new resource guide regarding the U.S. Department of the Treasury's reporting portal for funds received under the *American Rescue Plan Act (ARPA) of 2021*, a new resource from the Illinois Department of Public Health (IDPH) for Illinois residents to access their recent vaccination records and information from the Illinois Environmental Protection Agency (IEPA) regarding Nitrification Action Plans.

U.S. Census Bureau Releases Redistricting Data

On August 12, the U.S. Census Bureau released redistricting data, which includes municipal population counts, from the 2020 Census in their "legacy" format. Governor JB Pritzker will be taking action on legislation that was approved by the General Assembly during its 2021 spring legislative session. Many pieces of legislation were approved by both chambers

When Governor Pritzker signs legislation of municipal interest into law, the Illinois Municipal League (IML) incorporates that information into our [New Laws Taking Effect in 2021 report \(available via this link\)](#). This report highlights each bill enacted into law and the effective date of each new law. If a bill is vetoed, it will be reflected in the *2021 Legislation of Municipal Interest Approved by Both Chambers*.

U.S. Treasury Releases User Guide For ARPA Reporting Portal

On Monday, August 9, the Treasury Department released a [user guide \(available via this link\)](#) regarding utilizing the Department's reporting portal for ARPA funding. The guide contains guidance for submitting the required reports through the portal. IML encourages all municipalities to review the user guide and determine the required steps that will have to be taken locally to comply with federal reporting requirements.

IDPH Launes Online 'Vax Verify' System

On Wednesday, August 11, IDPH launched a new immunization portal, [Vax Verify \(available via this link\)](#), that will allow Illinois residents 18 years and older to check their COVID-19 vaccination record.

The verification system follows best practices to protect confidential health information. In order to download proof of vaccination, residents will go through a brief, one-time identity verification process to gain access to their immunization history. The State of Illinois utilizes Experian as its identity verification service provider. Individuals who have placed a freeze on their credit will need to unfreeze their credit with Experian and wait 24 hours before completing the registration process.

After the verification process, individuals can see their own records in the Illinois Comprehensive Automated Immunization Registry Exchange (I-CARE). Immunization records are kept confidential, and only the individual can access their vaccination history.

IEPA Provides Information Regarding Required Nitrification Action Plans

IML has been in conversations with IEPA regarding the agency's required Nitrification Action Plan due to reports from municipalities that received communications from IEPA indicating their proposed plans were deficient.

The Nitrification Action Plan became a requirement for community water supplies in Illinois with the regulatory revisions adopted by the Illinois Pollution Control Board in August 2019. Specifically, [Subtitle F, 604.140](#) requires that any community water supply distributing water without a free chlorine residual must create a Nitrification Action Plan that includes monitoring of various parameters. These monitoring results can then be used to optimize the chloramination process and minimize the risk of nitrification in the distribution system.

IEPA's Division of Public Water Supplies has included a chapter in the Sample Collector's Handbook that provides background information related to the chloramination process and guidance for the implementation of a Nitrification Action Plan. ICC Announces New Area Code for 708 Region

On August 16, the Illinois Commerce Commission (ICC) announced that the region of the state served by the 708 area code will be receiving a new 464 area code. The new 464 area code will be available for assignment when all assignable prefixes with the 708 area code have been exhausted, which is not expected to occur until January 2022.

With the new 464 area code, current 708 area code customers will keep their numbers.
