### Village Highlights and Updates

**Safe Routes to School Grant Received:** The Village has been working with Pleasantdale Middle School and Pleasantdale Park District over the years to identify a funding solution to install a flashing pedestrian signal and related crossing improvements between Walker Park and the Middle School on Wolf Road. This safety upgrade is necessary due to the amount of mid-block pedestrian traffic which circulates between these two community assets. To this end, the Village has been awarded \$130,000 through the ComEd Safe Routes to School grant program to the Village. The Village will act as the coordinating agency on behalf of the three public agencies to manage the project, reimbursing ourselves through this grant for staff time and other expenses we may incur through said management. We look forward to this important safety upgrade being installed in the community!

**Burr Ridge Named Tree City USA:** The Village has once again been recognized as a Tree City USA for its commitment to urban forestry. See the attached letter from the Arbor Day Foundation. Arbor Day Week begins this Sunday, April 24 and runs through April 30. The Village will hold a tree planting ceremony on Friday, April 29 at 10AM at the Veterans Memorial. A Show Time Crabapple tree will be planted in honor of Jack Schaus, one of the founding members of the Veteran's Memorial Committee. All are invited to attend the festivities.

**Run the Ridge 5K:** The race is on! Visit the <u>website</u> or see the attached flyer for the schedule, route, and registration information. Elected officials and staff receive free registration to participate as well as a free race t-shirt if you register by April 27. Whether you plan to run or walk, we hope to see you there.

This edition of the *Statehouse Briefing* includes a legislative update video, the release of the Illinois Municipal League's (IML) *2022 Legislation of Municipal Interest Approved by Both Chambers Report*, updates to additional IML resources, an upcoming *Illinois Municipal Policy Journal* (IMPJ) webinar, an online Commercial Driver's License (CDL) training event hosted by the Illinois Department of Transportation (IDOT) and an announcement regarding submissions for the 2022 Governor's Hometown Awards.

#### **Legislative Update**

On April 14, IML Director of Legislative Affairs Mitchell Remmert posted a legislative update video, which may be viewed on IML's Education Resources page, available via this link.

#### IML Releases Legislation of Municipal Interest Approved by Both Chambers Report

On April 15, IML released its <u>2022 Legislation of Municipal Interest Approved by Both Chambers</u> <u>Report (available via this link)</u> which includes legislation from the 102nd General Assembly that may be of interest to or impact municipal governments.

The legislation included in this report will now be sent to Governor JB Pritzker for further consideration. It is recommended that the bills be read in their entirety for a full understanding of the content. The full text of bills can be found at <u>iml.org/legislative</u>.

#### **Updated IML Resources**

On April 15, IML updated its <u>2022 Proposed State Mandates Report (available via this link)</u> to include additional unfunded mandates proposed during the 2022 Spring Legislative Session and the status of each proposal as of the General Assembly's April 9, adjournment. During this spring session, members of the General Assembly introduced 150 proposals that would impose unfunded state mandates on municipalities, 29 of which passed both chambers.

On April 15, IML also updated its <u>2022 Proposed Legislation Imposing Local Preemption Report</u> (available via this link) to include additional preemption proposals and the status of each proposal as of the General Assembly's April 9, adjournment. During this spring session, the General Assembly introduced 61 proposals that would preempt municipal authority, seven of which passed both chambers.

IML will continue to advocate against unfunded state mandates and preemptions of municipal authority, which is a constant effort as indicated by these reports.

#### IMPJ Webinar Regarding Municipal Responses to COVID-19

On April 22, the University of Illinois Springfield's (UIS) College of Public Affairs, in partnership with IML, is hosting a webinar as part of the *Illinois Municipal Policy Journal* (IMPJ) Webinar series. The one-hour webinar will discuss municipal responses to the COVID-19 pandemic. <u>More information</u> and registration is available via this link.

#### **IDOT Solicits Applications for Projects**

IDOT is requesting projects for the Highway Safety Improvement Program (HSIP) that will be initiated in State Fiscal Year (SFY) 2024. Applications for this funding program will be received through June 17. The announcement of the selected projects for funding will be made this fall.

On April 12, <u>IDOT released Circular Letter 2022-11 (available via this link)</u> with information on HSIP. Applicants are also encouraged to visit the <u>HSIP website (available via this link)</u>.

#### IDOT Hosting Online CDL Training Event

On April 27, IDOT will be hosting an online Commercial Driver's License (CDL) training event. The training will focus on two new rules introduced by the Federal Motor Carrier Safety Administration (FMCSA) that impact agencies employing anyone operating a vehicle that requires a CDL.

The first rule that will be covered is the Drug and Alcohol Clearinghouse (DACH). DACH contains information about holders of CDLs and Commercial Learner's Permits (CLPs) who are covered by FMCSA's Drug and Alcohol Program. The second rule to be covered is the Entry-Level Driver Training rule, which requires all persons wanting to obtain a CDL and CLP for the first time, to complete minimum training. <u>Registration for the event is available via this link</u>.

#### Governor's Hometown Awards 2022 Announcement

The Serve Illinois Commission on Volunteerism and Community Service, in partnership with the Governor's Office, has announced the Governor's Hometown Awards (GHTA) has officially opened and is now accepting Letters of intent (LOI) from communities, programs and units of local government interested in competing for the Governor's Cup.

GHTA gives formal recognition to those who contributed to projects that improved their community's quality of life. Only projects completed between January 1, 2021, and December 31, 2021, will be considered. All nominations must be received no later than May 1, 2022.

#### **U.S. DOT Announces Upcoming Funding Opportunities**

The United States Department of Transportation (U.S. DOT) has published a list of anticipated dates for Notice of Funding Opportunities (NOFOs) for key programs in the Bipartisan Infrastructure Law passed by Congress and signed by President Biden in 2021. The list provided by U.S. DOT is not comprehensive and will be updated periodically with new programs and dates. <u>The anticipated dates for NOFOs are available via this link.</u>

This month's *Federal Focus* includes information for governmental units requesting a review of their official 2020 Census results by the U.S. Census Bureau, an announcement from the Federal Highway Administration (FHWA) on new guidance and funding, an upcoming grant schedule from the U.S. Department of Transportation (DOT), a competitive grant program from the U.S. Department of Justice (DOJ) for hiring and rehiring law enforcement officers and a federal ruling lifting the mask mandate for public transportation.

#### U.S. Census Bureau's 2020 Census Count Question Resolution

The U.S. Census Bureau has begun accepting 2020 Census Count Question Resolution (CQR) cases for processing from eligible local, state and tribal governments. <u>The 2020 Census CQR</u> <u>Participant Guide, that provides instructions on how to prepare and submit a case, is available via this link.</u>

The purpose of the 2020 CQR is to provide a mechanism for governmental units to request a review of their official 2020 Census results and to help ensure that housing and population counts are correctly allocated to 2020 Census tabulation blocks. The deadline for eligible local, state and tribal governments to submit a CQR case for review is June 30, 2023.

Communities with questions about their counts can request a CQR review in the following situations:

- Boundary cases. CQR can review the legal boundaries in effect for governmental units as of January 1, 2020. It can also review the associated addresses affected by the boundaries.
- Housing count cases. CQR can review the geographic location or placement of housing and its associated population. It can also review 2020 Census results to determine whether census processing error(s) excluded valid housing and associated population data.
- Both boundary and housing count cases.

#### FHWA Announces Funding for Safer Streets

FHWA has announced new guidance and increased funding to help state and local governments carry out projects that create safer, more walkable streets. The 2021 Bipartisan Infrastructure Law, passed by Congress and signed by President Biden, nearly doubled funding for the Transportation Alternatives (TA) Set-Aside, from \$850 million annually for fiscal years (FY) 2018 to 2020 to an average annual amount of \$1.44 billion from FY 2022 to 2026.

The TA Set-Aside program can be used for a variety of projects including pedestrian and bicycle facilities, recreational trails, Safe Routes to School projects, road safety assessments, community improvements such as historic preservation and vegetation management and environmental

mitigation related to storm water and habitat connectivity.

#### **DOT Releases Upcoming Grant Schedule**

DOT has published a list of anticipated dates for Notice of Funding Opportunities (NOFOs) for key programs in the 2021 Bipartisan Infrastructure Law. The list provided by DOT is not comprehensive and will be updated periodically with new programs and dates. <u>The anticipated dates for NOFOs are available via this link.</u>

#### DOJ's 2022 COPS Hiring Program

DOJ has announced the opening of the 2022 COPS Hiring Program (CHP), a competitive grant program designed to provide funds directly to law enforcement agencies to hire new, or rehire existing, career law enforcement officers to increase their community policing capacity and crime prevention efforts. Anticipated outcomes of CHP awards include engagement in planned community partnerships, implementation of projects to analyze and assess problems, implementation of changes to personnel and agency management in support of community policing and increased capacity of agencies to engage in community policing activities.

All local, state, territorial and tribal law enforcement agencies that have primary law enforcement authority are eligible to apply. Applications are due by June 16, 2022.

#### Federal Court Ruling Lifts Mask Mandate on Public Transportation

On April 18, 2022, the U.S. District Court for the Middle District of Florida vacated the U.S. Centers for Disease Control and Prevention (CDC) mandate that required wearing masks in airports, train stations and other transportation hubs, as well as on airplanes, buses, trains and most other public conveyances throughout the United States. A copy of the ruling is available via this link.

District Court Judge Kathryn Kimball Mizelle held that the CDC exceeded its statutory authority in issuing the mandate, improperly invoked the good cause exception to notice and comment rulemaking and failed to adequately explain its decision to impose the mandate.

On April 19, 2022, Governor JB Pritzker announced his intention to revise his <u>Executive Order 2022-</u> <u>06 (available via this link)</u> to align with the federal court ruling. Municipalities retain the authority to establish their own mitigations, including masking requirements on public transportation.
