## **Village Highlights and Updates**

**Armed Forces Day:** The [Armed Forces Day Celebration](#) at the Veterans Memorial is Saturday, May 21. All are welcome to join this celebration to honor and show appreciation for those who serve across all branches of the United States military. The celebration will begin at 10a.m. and will feature a keynote speech by Captain Scott Smith and the presentation of the Jack Schaus Patriot Award to Robert "Bob" Grember.

**In-Service Day Scheduled:** Village Hall will be closed to the public on Friday, May 27, as we are in process of removing old furniture and moving in replacement furniture for the Front Office staff. Staff in Village Hall will be working to the extent possible. All other departments and buildings will be open as normal on this date.

**Memorial Day Holiday:** The Village Hall be closed all day Monday, May 30 in observance of the Memorial Day Holiday.

**Watering Restrictions:** Seasonal watering restrictions are now in force. Until September 15, residents and businesses are reminded to please conserve water and follow these lawn and landscaping irrigation restrictions:

- North of 83rd Street: watering allowed Monday, Thursday, and Saturday from midnight to noon and 6pm to midnight.
- South of 83rd Street: watering allowed Tuesday, Friday and Sunday during same times.
- No watering is permitted on Wednesdays, or any day between noon and 6pm.

**IRMA IMAP Report:** On Monday, staff met with the Village's risk management agency, IRMA, to complete a six-month process and procedure audit. The audit, called IMAP, is standard for all IRMA members. The hard work of Village staff, who spent numerous hours completing an extensive questionnaire, paid off in dividends, as the Village received zero issues to correct on a Village-wide basis. The Village received an exemplary letter from IRMA (attached) which praised the Village's commitment to workplace safety. All of the efforts by staff to ensure proper training, procedures, and policies are current and of high quality along with the diligent follow-through by other staff to internalize and adhere to their training and current procedures to ensure a proper working environment are thoroughly appreciated!

**Staff Moves:** On Monday May 16, we welcomed two new part-time assistants. Annette Nyenhuis comes to the Village with excellent customer service credentials, making her a valuable addition to our Front Office staff. Crystal Beach has been hired to assist the Community Development staff, where her attention to detail will be put to good use. We welcome Annette and Crystal and wish them success in their new positions.

On Friday, May 20, Police Chief Madden announced that, after a stringent and thorough assessment process, Sergeant Ryan Husarik will be appointed to the role of Deputy Police Chief later this summer after two academy enrollees return from training. Sgt. Husarik is a 17-year member of the Police Department, serving in a variety of roles as part of his duties, as well as a graduate of the prestigious Northwestern Staff and Command management training program. We look forward to Sgt. Husarik's promotion!

**Media Debuts:** Two new exciting publications are scheduled to launch on June 1; the Village's new website will go live and the annual Oak Leaf newsletter will be both e-mailed and mailed to all residents. Stay tuned!

**Board Room Ramp:** We expect construction on the Board Room ADA ramp to begin in the next few weeks and conclude in the next 30 days. This ramp is necessary to ensure safe and legal access to the dais for all in the community who use the facility. No public meetings will be affected by said construction.

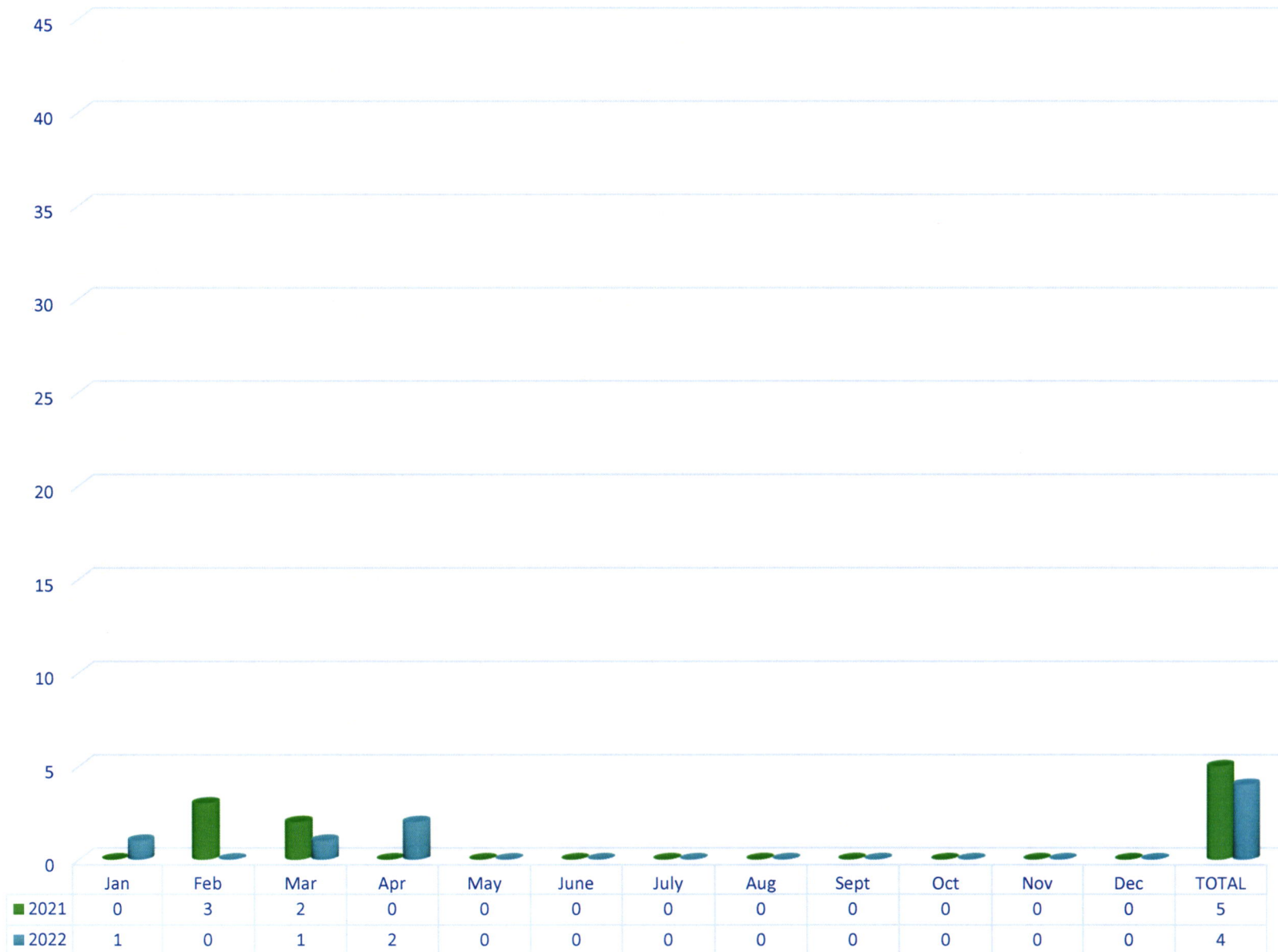

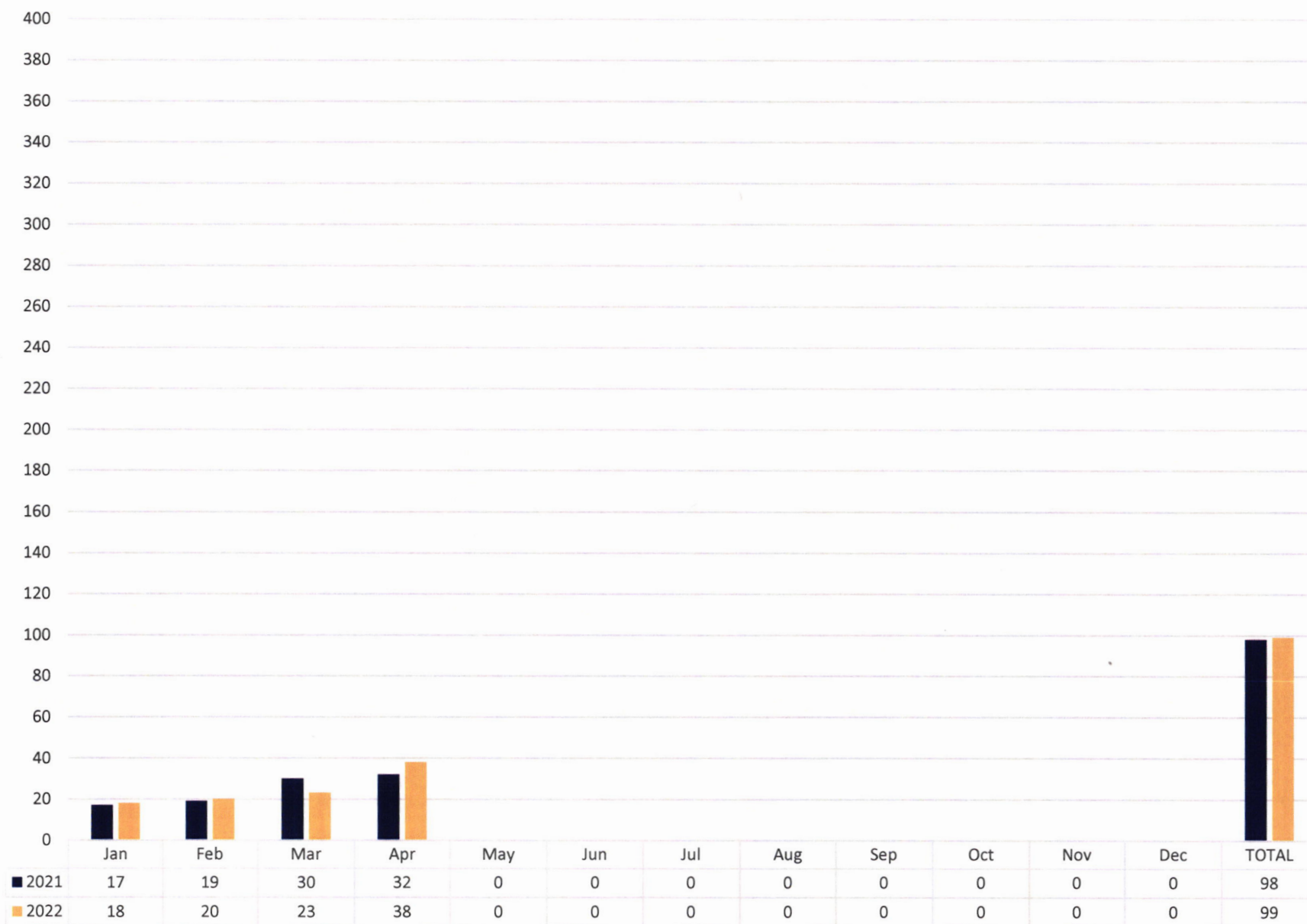

## Village of Burr Ridge New Housing Permits 2021 Compared to 2022



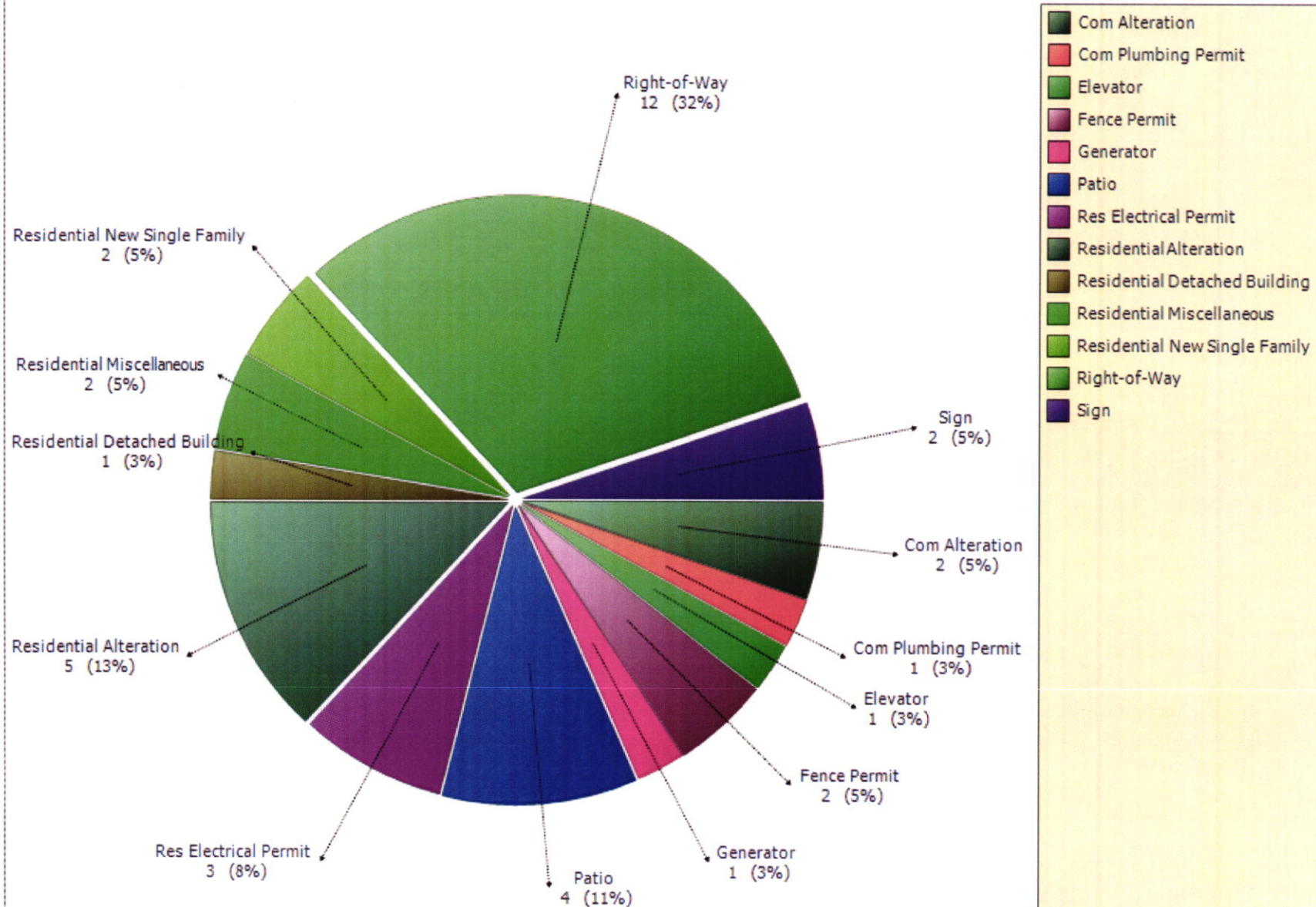


## Village of Burr Ridge Building Permits Issued 2021 Compared to 2022

#### **Statewide 9-1-1 Fund Update**

On April 19, Governor JB Pritzker signed [the State Fiscal Year \(SFY\) 2023 budget implementation \(BIMP\) bill \(available via this link\)](#). A portion of the BIMP contains a one-time, \$5 million fund transfer from the Statewide 9-1-1 Fund to the Statewide 9-8-8 Trust Fund.

The Statewide 9-8-8 Trust Fund is a result of the Community Emergency Services and Supports Act, which requires emergency response operators to refer calls seeking mental and behavioral health support to a new service that can dispatch a team of mental health professionals instead of police. Illinois Municipal League (IML) staff has been in contact with the Governor's Office of Management and Budget regarding this issue in order to determine details of this transfer and what the impact will be to 9-1-1 centers now and going forward. It is our understanding that the Statewide 9-1-1 Fund will have a significant balance at the end of SFY 2023, meaning 9-1-1 centers will remain fully funded if this transfer is made. A remaining question is whether or not this one-time appropriation jeopardizes any federal regulations or funding opportunities. IML will continue to update our members on this



issue as more information is made available.

### **Biden Administration Announces Affordable Connectivity Program (ACP)**

Today, President Joseph R. Biden, Jr. announced the Affordable Connectivity Program (ACP), which is part of the Bipartisan Infrastructure Law. [The Administration's fact sheet on the program is available via this link.](#)

ACP allows tens of millions of American households to reduce their Internet service costs by up to \$30/month. To ensure the most efficient use of those public dollars and to deliver maximum cost savings to families, the Biden-Harris Administration has secured commitments from 20 leading Internet providers—covering more than 80% of the U.S. population across urban, suburban, and rural areas—to either increase speeds or cut prices, making sure they all offer ACP-eligible households high-speed, high-quality Internet plans for no more than \$30/month.

### **Illinois Department of Human Services (IDHS) Anti-Violence Funding Available**

Governor Pritzker and IDHS recently announced that \$113 million in funding is now available for community organizations working on violence prevention and interruption throughout the state. In SFY 2022, the IDHS distributed \$73 million to organizations, along with \$71.8 million currently in the process of being distributed.

The anti-violence funds available through IDHS are designated for neighborhoods that have experienced concentrated firearm violence, including 42 areas throughout the state. Community-based organizations that provide anti-violence services in any of the eligible communities and follow the Grant Accountability and Transparency Act (GATA) guidelines are eligible to apply. Applications will be accepted and reviewed on a rolling basis to expedite funding.

### **Update on Pending Medicaid Changes**

The Illinois Department of Healthcare and Family Services (IHFS) is seeking assistance from municipal officials in informing residents of pending changes to the Illinois Medicaid program.

Specifically, IHFS is taking steps to prepare for the eventual end of the Federal COVID-19 Public Health Emergency (PHE). When the PHE ends, the federal Centers for Medicare and Medicaid Services will end its continuous coverage provision. This provision has allowed IHFS to keep Medicaid customers insured without confirming all eligibility requirements. As a result of this continuous eligibility, Medicaid customers have not been asked to update their information for the past two years. That new information is now critical for their continued coverage.

IHFS is seeking assistance in reminding Medicaid enrollees to update their addresses in order to start the renewal process. Medicaid enrollees can use the [IL Medicaid Toolkit \(available via this link\)](#) to update their addresses with the state.

IHFS is recommending that municipal officials create a list of the places where community members who use Medicaid are most likely to go or receive services, and work with those local organizations to implement concrete plans for how their customer-facing staff will integrate this messaging into their daily interactions with Medicaid customers. ### **President Biden Visits Illinois**

On May 11, President Joseph R. Biden Jr. traveled to Kankakee to tour a farm and provided remarks on his administration's efforts to support the agricultural industry amidst increasing inflation across the nation.

### **DOT Announces Funding for Roadway Safety**

The application process is now open for communities of all sizes to apply for Federal Fiscal Year 2022 funding to help ensure safe streets and roads and to address the national roadway safety crisis.

The Bipartisan Infrastructure Law, passed by Congress and signed by President Biden in 2021, established the Safe Streets and Roads for All (SS4A) discretionary grant program. SS4A provides dedicated funding to support regional, local and tribal plans, projects and strategies that will reduce and prevent serious injuries and deaths on highways, roads and streets.

The primary goal of SS4A grants is to improve roadway safety by supporting communities in developing comprehensive safety action plans based on a Safety System Approach, and implementing projects and strategies that significantly reduce or eliminate transportation-related fatalities and serious injuries involving pedestrians, bicyclists, public transportation, personal conveyance and micromobility users, commercial vehicle operators and motorists. Funding can also be used to support stakeholder engagement in order to ensure that all community members have a voice in developing plans, projects and strategies.

### **DOT Announces New Grade Crossing Elimination Program**

The Bipartisan Infrastructure Law established the Grade Crossing Elimination Program, which will provide \$5.5 billion over five years to state and local governments for grade crossing projects that improve the safety and mobility of people and goods. Eligible projects include grade crossing elimination or separation, track relocation, improvement or installation of protective devices or other means to improve safety. The program also includes a 3% set-aside for planning projects and a 0.25% set-aside for crossing safety and education programs.
