Village Highlights and Updates

Memorial Day Holiday: The Village Hall be closed all day Monday, May 30 in observance of the Memorial Day Holiday.

Memorial Day Ceremony: There will be a brief ceremony at 9am on Memorial Day at the Veterans Memorial, located in front of the Village Hall, to commemorate the sacrifice of our veterans. The ceremony will include the laying of a wreath. Please join us!

Watering Restrictions: Seasonal watering restrictions are now in force. Until September 15, residents and businesses are reminded to please conserve water and follow these lawn and landscaping irrigation restrictions:

- North of 83rd Street: watering allowed Monday, Thursday, and Saturday from midnight to noon and 6pm to midnight.
- South of 83rd Street: watering allowed Tuesday, Friday and Sunday during same times.
- No watering is permitted on Wednesdays, or any day between noon and 6pm.

Media Debuts: Two new exciting publications are scheduled to launch on June 1; the Village's new website will go live and the annual Oak Leaf newsletter will be both e-mailed and mailed to all residents. Staff has attached an advance digital copy of the Oak Leaf newsletter to the memo. Stay tuned!

Staff Resignation: Accounting Analyst Preeti Goel has announced her resignation from the Village, effective June 3. Her resignation and a staffing plan will be on the June 13 Board agenda for consideration. MAYOR'S WELCOME



Weather has fully changed from winter to spring to summer and residents can now enjoy the outdoors. Let's get out and enjoy all the outdoor activities we love — walking, jogging, and bicycling the new pathways soon to be installed around town, playing baseball, and planting the beautiful flowers and trees we see in our community. With the change in season, I am so pleased to be able to provide to you an update regarding the many great things accomplished by the Village in the past year.

Job one of government is the protection of persons and property; to this end, the Village has approved a balanced budget with several investments in public safety included, such as the installation of cameras along some of our busier roads and shopping areas, new security upgrades for our Police Station, and body worn cameras to be worn by our sworn officers when they interact with those in the community. Each of these will ensure our terrific CALEA-certified Police Department remains effective and accountable in their enforcement of public safety.

Continuing with the budget, the Village became part of a group of a select few communities in Illinois who are debt free: On December 14, 2021, the Village officially retired its remaining \$6 million of debt (related to the construction of the Police Station), making us a debt-free community. Additionally, the budget also approved significant surpluses in major funds, kept our property tax levy flat, and contributed additional funds to our Police Pension and capital funds. The Village's finances are in terrific shape!

Finally, as Chair of the Street Policy Committee, the Village committed to another significant investment in our Road Program in 2022 — over ten streets and several miles of roadway will be completely resurfaced. Additionally, the Village has received over \$800,000 in grants to rebuild and expand the Elm Street culvert near Elm School. This money, along with our allotment of American Rescue Plan Act (ARPA) funds, will provide a 500% increase in stormwater capacity and streambank conveyance in this area — a terrific win for our area residents and school attendees!

It is truly my honor to serve as the Mayor of Burr Ridge. Please feel free to contact me with any concerns, questions, or ideas for improvement. I wish all the very best to you and your family in the coming year!

LETTER FROM THE ADMINISTRATOR



I am pleased to write to you with the good news of a successful year past and a positive vision of the future. From processing over 400 building permits, 30,000 water bills, and participating in innumerable interactions between staff and the community, I believe the Village has upheld the community's motto of "A Very Special Place."

Thank you for reading this annual edition of the Oak Leaf as we explore the highlights from the past year!

The Village Board approved a budget that tells a story of recovery and investment. The budget carries a \$350,000 General Fund surplus while becoming debt-free (read the Mayor's Message for more on this!) while investing \$4 million in critical infrastructure and public safety improvements. More information is available in our Budget in Brief. Additionally, the Village returned to a new normal with our community events, including the new Car Show & Taste of Burr Ridge. Turn to page 4 to see and learn more about these terrific offerings — all of which return in 2022! Did you interact with the Village over the past year? You may have noticed changes in the look and feel of our communications platforms, including the all-new Village website and the monthly Oak Leaf newsletter. We have made an effort to modernize our community engagement platforms for your betterment.

We're always looking for ways to help our residents and had several chances to demonstrate our preparedness this past year. On Father's Day 2021, the Village was hit by an F3 tornado around 83rd Street, which resulted in significant damage to the urban forest and homes in this area. In partnership with several external public and private agencies, Public Works performed exemplary work cleaning up the damage. We also saw the need for well-trained Police officers during several notable public safety incidents, including a shooting at Oakbrook Center (our officers were among the first on the scene to aid our neighbors) and a shooting at a business on South Frontage Road. Thank you to our brave and dedicated public servants who do not hesitate to assist the community!

It is my privilege to serve as your Village Administrator. I look forward to working with staff and the Board to maintain and strengthen our community's standing, and I look forward to meeting you!

LAWN SPRINKLING RESTRICTIONS

Lawn sprinkling restrictions are in effect for all communities receiving Lake Michigan water from **May 15th to September 15th.**

- Residents north of 83rd Street may sprinkle Monday, Thursday and Saturday from midnight to noon and 6 p.m. to midnight.
- Residents south of 83rd Street may sprinkle Tuesday, Friday and Sunday during the same times.
- No sprinkling is permitted on Wednesdays or any day from Noon to 6 p.m.
- Residents using private wells are not subject to restricted hours but should notify the police that a well is in use.
- Residents can obtain permits for more frequent lawn sprinkling only in the case of new sod installations.



BRUSH PICKUPS

Yard waste collection runs through November 30th. Don't forget to separate yard and general waste.

New Groot Contract Approved – Prices for Groot's services will go up 2.5% effective

August 1 after the Village approved a seven-year contract extension with Groot Industries for residential trash services. The new contract includes all of the services that residents are accustomed to, including unlimited yard waste collection, the 4.5% senior discount, several can size options, and optional white good haul-away services. Prices will go up between 2.5% and 4.5% depending on the rate of inflation during the contract extension.

WATER BILLING

We have a new, convenient water bill drop box located in front of the Village Hall. Payments can be dropped off any time and will be processed the same day if made before 3:30 p.m. You can also pay



your water bill using InvoiceCloud, through the Village website burr-ridge.gov.

MOBILE DMV

The Secretary of State's Mobile Driver Services Facility is scheduled to return to the Burr Ridge Village Hall (7660 County Line Road) on **June 15th, August 17th and November 16th.** The mobile facility offers duplicate and/or corrected drivers' licenses, new ID cards, and vehicle renewal stickers. "Real ID" licenses must still be obtained at a regular driver's facility location. To learn more, visit the Secretary of State's website at www.ilsos.gov.

Community Investment and Development



The Village was pleased to host Senator Tammy Duckworth on a tour of the Elm Street Culvert site in support of environmental and stormwater initiatives brought forward by ARPA.

Elm Street Culvert

THE VILLAGE HAS BEEN AWARDED a \$785,000 Community Project Funding grant for the Elm Street Culvert project from Congressman Casten's office and a \$50,000 grant from DuPage County towards replacing the Elm Street culvert stormwater facility. These grants, along with some of the Village's share of American Rescue Plan Act (ARPA) monies, will allow the Village to construct the largest culvert replacement possible under Elm Street, with 500% more capacity becoming available at the new pipe compared to the present pipe.

Edgewood Valley Annexation

ON MARCH 28TH, the Village voluntarily annexed Edgewood Valley Country Club (EVCC), located at 7500 South Willow Springs Road. Established in 1910, the 170-acre private country club was previously located in unincorporated Cook County. EVCC is planning renovations to their grounds and buildings in the future and wanted to perform this work under the jurisdiction of a local municipality that would be responsive to their needs. EVCC will continue as a private club, providing a wide variety of activities, such as golf, tennis, and pools to their membership, the majority of whom live in Burr Ridge. Welcome to Burr Ridge, Edgewood Valley!

Safe Routes to School Grant

FOR MANY YEARS, the Village has worked with Pleasantdale Middle School and Pleasantdale Park District to identify a funding solution to install a flashing pedestrian signal and related crossing improvements between Walker Park and Pleasantdale Middle School on Wolf Road. This safety upgrade is necessary due to the amount of mid-block pedestrian traffic that circulates between these two community assets. We are pleased to report that the Village was awarded \$130,000 through the ComEd Safe Routes to School grant to fund these improvements.



June 2021 Tornado and Extra Expenses

AT ABOUT MIDNIGHT on Sunday, June 20th into Monday, June 21st, a major tornado hit Woodridge, Darien, and Burr Ridge, causing extensive damage to trees and property in the community. The area four blocks north and south of 83rd Street throughout the width of the Village was the most significantly impacted. The Village, with the assistance of the State of Illinois, DuPage County, along with neighboring municipalities and contractors, collected about 6,000 cubic yards of natural debris on Commerce Street. No significant injuries or uninhabitable homes were reported in Burr Ridge. As part of the response to the tornado, the Village entered into a partnership with Team Rubicon. This veteran-led disaster response organization provided clean-up services, free of charge, to the communities of Burr Ridge, Darien, and Woodridge. Team Rubicon's volunteers stayed at Hinsdale South High School. A special thank you to D86 Superintendent Tammy Prentiss for her assistance in accommodating these volunteers.

Sidewalk Projects

The Village has received much positive community input regarding the need for well-maintained sidewalks and pathways throughout the Village.

The Board has responded to these requests from residents and has approved the construction or replacement of sidewalks in the following locations:

County Line Road

A new sidewalk is nearly complete on the east side of County Line Road, connecting residents to King-Bruwaert and Katherine Legge Park. We anticipate the final stages of construction on this project, including installation of steel guardrail, form and pouring of the concrete sidewalk, and upgrading the flashing pedestrian beacon to be completed this summer and opened for public use shortly after that.

Garfield Street

In partnership with the Village of Willowbrook, a new sidewalk will be constructed on the east side of Garfield Street north of Plainfield Road, which connects the existing Garfield Street sidewalk to other area sidewalk connections, thus completing all regional connections in the area. Construction is anticipated to be completed by year-end.

Kraml Drive and 79th Street

Existing pathways (one near Kraml Drive along Madison Street and 87th Street and another along the south side of 79th Street near Burr Oaks Glen South) are scheduled to be replaced in 2022 and 2023, respectively. The existing pathways will be upgraded to concrete, which has a longer lifespan and fewer maintenance requirements.

BUDGET IN BRIEF FISCAL YEAR 2023

Village of Burr Ridge Fiscal Year 2023 Budget

WE ARE PLEASED TO PRESENT the Fiscal Year 2023 Budget, effective May 1, 2022, through April 30, 2023. The Board has established a commitment to exceptional service delivery for its resident and business community; this budget preserves and enhances that commitment. The budget reflects an improving local economy, modernizing organization, and a strong financial footing, using the village's resources prudently to address a broad spectrum of services and important investments. Zerobased budgeting techniques are employed to drive priority, value, and accuracy throughout all budget elements.

In summary, the village's financial position and architecture are strong. Each budget tells a story; the story of this budget is one of return on investment: investment in our business community throughout the pandemic, investment in the thoughtful implementation of alternative service delivery models, and investment in core infrastructure which staff, residents, and businesses use every day to improve the lives of themselves and others. Our business community continues to thrive while the local real estate market resurges in property values. Revenues are trending upward, while reorganization, consolidation, and alternative service delivery have resulted in some of the lowest operating costs by percentage in many years.

No Property Tax Increase

At the December 13th Board meeting, the Board of Trustees passed the annual property tax without any rate increase for Village property owners. Any increases in property taxes would be due to increased or reassessed property values, which local assessors control and are not under the jurisdiction of the Village. The Village's share of the average property tax bill represents about 1.5% of the total bill.


Debt Free Community

Utilizing reserves available in the Village's Debt Service Fund and General Fund, the Village retired \$6 million in outstanding bond debt (originating from the construction of the Police Station in 2010) in December 2021. As of Fiscal Year 2023, the Village is entirely debt-free, making us one of few Illinois municipalities without outstanding debt.

Fiscal Year 2023 Budgeted Revenue

REVENUE AT A GLANCE

REVENUES ARE TRENDING UPWARD, while reorganization, consolidation, and alternative service delivery has resulted in some of the lowest operating costs by overall percentage in many years. Based upon combined projected FY2022 and proposed FY2023 revenues and expenditures, the General Fund is projected to generate a combined surplus. In addition, despite an FY2022 draw on fund balance in the General Fund to retire the Village's police facility debt in full, the fund balance within the General Fund increases by approximately \$350,00 when comparing FY2022 to FY2023.



REVENUE HIGHLIGHTS

Sales Tax

Sales tax is the largest General Fund revenue source for the Village, representing approximately 24% of total FY2023 General Fund revenues. The Village's sales tax revenue consists of a 1% sales tax received from the State of Illinois, as well as a .25% sales tax imposed through the Village's non-home rule status. Sales and non-home rule sales tax distributions are received each month, generally lagging two months behind the State's collection month. While the Village receives a significant amount of sales tax from downtown retail establishments, many businesses at our industrial parks also contribute heavily to this revenue source.

Property Tax

The Village's total property tax levy was approved with no rate increase for FY2023. The property tax primarily pays for the Village's Police Pension contribution. While the statutorily required contribution to the Police Pension Fund decreased by approximately \$11,000 as compared to the prior year due to position investment gains, the Village increased its contribution for FY2023 by approximately \$24,000 due to naturally increasing property values. Even with this additional contribution. Village's share of the average property tax bill is expected to drop to approximately 1.5% of the resident's total property tax bill.

Places of Eating Tax

As part of its overall revenue structure, the Village imposes a 1% Places of Eating Tax (POET) at all businesses where food is prepared and eaten on site (restaurants, etc.). The Village is projecting to generate a record amount of POET revenue due to its thriving restaurant scene: Several new restaurants have opened or will open soon (Yolk, Jonny Cab's, Olive Tree); many have expanded (Are We Live, Patti's, Topaz), and a new restaurant has been annexed (Edgewood Valley Country Club). While other sources of revenue may generate more income for the Village, this particular revenue source is a good indicator of the positive small business climate present in Burr Ridge.


State Income Tax

The State levies income taxes on all persons living in Illinois. A portion of these taxes are remitted to local municipalities, such as Burr Ridge, on a per capita basis. As a result of responsible growth over the past ten years and a highly successful 2020 Census, the Village's population increased by over 600 people from 2010. Because of this increase, the Village will receive an additional \$240,000 per year from the State over the next ten years. In total, the Village now receives over \$1.4 million per year in State Income Tax. This additional revenue comes at no direct cost to any local taxpayer.

Fiscal Year 2023 Budgeted Expenses

SPENDING AT A GLANCE

THE VILLAGE ALWAYS MAKES an effort to anticipate expenses and plan for them within the budget document. Overall, the Village's expenses can be broken down into the categories defined below.



EXPENDITURE HIGHLIGHTS

Personnel

Personnel costs are the most significant cost driver within the Village, exceeding 65% of total General Fund spending. Despite its majority share of total expenditures, personnel costs are projected to be the lowest since the Great Recession; conversely, the organization continues to deepen and broaden its talent pool and experience through new organizational models and service delivery options. For example, when two vacancies occurred in the Finance Department, the Village outsourced these positions, saving over \$150,000 per year with no loss of service to the organization or our constituents.

Capital

Nearly \$4 million in capital spending is planned for FY2023, including \$1 million in water system improvements (repainting of the South Water Tower and establishing several new transmission main connections to other communities), \$950,000 in street and pathway maintenance, and \$775,000 in fleet, technology, and machinery upgrades. The Village takes great care in understanding how its capital investments provide services to the community. The Village has over \$20 million in capital investments planned over the next five years - get in touch to learn more about some of the great upgrades planned for your area of town!

Public Safety

Protection of persons and property is the first priority of any government; in FY2023, the Village plans to make several critical investments to ensure that priority remains upheld. The Village will hire a second Deputy Chief in the Police Department to assist with the growing number of State laws and programs to which we must comply while procuring new body cameras to keep our officers accountable and the public safe. The Village also plans to install more cameras in major traffic corridors and downtown to enhance Police responsiveness. We are proud of the tangible benefits that our Police Department provides the community.

American Rescue Plan Act

In September 2021, the Village received the first of two installments from the American Rescue Plan Act (ARPA) in the amount of \$731,999. The second installment is estimated to be received in September 2022. Projects funded with these grant revenues include sidewalk improvements along 79th Street and Kraml Drive, investments in the Police Station and Police Department designed to create more pro-active public safety programs, several new Public Works vehicles, as well as the Village's local share of the Elm Street Culvert construction project.



The Village's five-year Capital Improvement Plan (CIP) identifies capital projects that support the Village's strategic goals and includes projects such as the purchase, construction, and improvement of land, buildings, streets, water and sewer infrastructure, vehicles, machinery, and equipment. The Village's Capital Asset Policy provides a framework for capital planning and financial reporting in conformance with best practices.

Foundation Burr Ridge is a standalone Capital Improvement Plan (CIP) that will be created by the start of the FY2024 budget process. This plan will specify all Village capital needs on a rolling 20-year basis. A growing percentage of the Village's overall expenditures are capital-related, and it is critical to have a keen understanding of our needs over the long term.



FY 2022 HIGHLIGHTS & ACCOMPLISHMENTS

COVID-19 Response: Managed continued operational oversight of the Village's ongoing COVID-19 pandemic response and risk management.

New Community Events: In partnership with the Village Center, staff created and executed a new combined Car Show / Taste of Burr Ridge as well as a reimagined holiday event called Deck the Green, with both attracting thousands of residents and visitors.

New Village Website: A new Village website will go live in 2022, migrating many Village services to this modern platform and providing a clear and effective communication tool for both the Village and community members.

Established the Innovation Committee: Established a new staff working group to design and implement new Village technologies and other concepts which will ultimately deliver both external and internal business process benefits.

Downtown Economic Development: Staff assisted in the creation of the Downtown Business Development District, a first-of-its-kind Village tool which will spur new development and redevelopment in the community's core.

Created New Communications Portfolio: A new partnership was established with Kaleidoscope Management Group leading to a twice-monthly Village e-newsletter called The Oak Leaf, a significantly increased social media presence, and new internal communications such as Inner Workings.



This edition of the *Statehouse Briefing* includes legislation of municipal interest enacted into law by Governor JB Pritzker, information concerning 2020 Census undercounts, an update on Local Government Distributive Fund (LGDF) distributions, updates to the One Day Rest in Seven Act, information on two court cases concerning video gaming, a local government workshop being hosted by the Illinois Department of Revenue (IDOR), an Illinois Department of Public Health (IDPH) COVID-19 grant opportunity and information on the federal Infrastructure Investment and Jobs Act.

The following bills have been enacted by the Governor and are of interest to municipalities:

- HB 4369 (now P.A. 102-0771) Lead Poisoning Prevention (Effective January 1, 2023)
- HB 4924 (now P.A. 102-0787) Pension Downstate Firefighter Treasurer Bond (Effective May 13, 2022)
- <u>HB 5447 (now P.A. 102-0811) Pension Code Downstate Police Survivors Benefit</u> (Effective January 1, 2023)
- SB 658 (now P.A. 102-0818) TIF Contiguity/Extension Omnibus (Effective May 13, 2022)
- SB 3146 (now P.A. 102-0828) One Day Rest in Seven Collective Bargaining (Effective January 1, 2023)
- SB 3930 (now P.A. 102-0868) Home Grown Business Opportunity (Effective January 1, 2023)

When Governor Pritzker signs legislation of municipal interest into law, IML incorporates that information into our *New Laws Taking Effect in 2022* report (available via this link).

All bills that passed both chambers of the General Assembly during the Spring Legislative Session have been sent to Governor Pritzker for his consideration. U.S. Census Bureau Releases 2020 Undercount Rates

On May 19, the U.S. Census Bureau released the <u>2020 Post Enumeration Survey Estimation</u> <u>Report (available via this link)</u>, which indicates that Illinois was undercounted by nearly 2%. This means that Illinois' population grew by nearly 250,000 people.

On May 23, IML Executive Director Brad Cole sent <u>a letter to Governor Pritzker (available via this link)</u> seeking to ensure that each municipality receives their correct allocations of state-shared revenues distributed on a per-capita basis.

April Local Government Distributive Fund (LGDF) Disbursements

IML is aware that disbursements of LGDF for the month of April are coming in extremely high when compared to previous months. We are working with the Illinois Department of Revenue (IDOR) in order to determine the cause of these high disbursements.

Updates to the One Day Rest in Seven Act

On May 16, Governor Pritzker signed <u>SB 3146, now Public Act (P.A.) 102-0828 (available via this link)</u>, which amends the One Day Rest in Seven Act and takes effect on January 1, 2023. The Act applies to municipalities in their capacity as employers.

P.A. 102-0828 clarifies that the Act applies to any consecutive seven-day work period, requires an additional 20-minute break for workers during a 12-hour shift, clarifies penalties per offense depending on the size of the employer and requires each employer to post a notice at the workplace that notifies employees of their rights under the Act.

Video Gaming Push Tax Update

On May 18, 2022, the Circuit Court of Lake County entered a judgment in favor of the City of Waukegan (City), finding that the City's ordinance imposing a penny-per-play fee (also called a "push tax") on individual users of video gaming terminals is a valid exercise of the City's home rule authority. On May 20, 2022, IML provided an update on this issue (available via this link).

It is recommended that any action to implement a push tax be delayed until it is known if an appeal will be filed in Lake County and/or until a decision is issued in Cook County.

Communities that did not impose such a fee prior to November 1, 2021, may no longer do so pursuant to a recent amendment to the Illinois Video Gaming Act enacted through Public Act 102-0689 (available via this link).

It is our understanding that some gaming operators are contacting local officials asking them to rescind their home rule push tax ordinance due to uncertainty in these cases; it is not recommended that any municipality rescind their push tax ordinance at this time, if the ordinance was properly adopted prior to November 1, 2021. Communities that have adopted such a fee and choose to rescind their ordinance will not be able to adopt the fee again at a later date.

Illinois Department of Revenue (IDOR) Hosting Virtual Local Government Workshop

The Local Tax Allocation Division (LTAD) of IDOR will be holding its annual Local Government Workshop virtually on June 15 from 9:00 a.m. to 12:00 p.m. This year's workshop will focus on correspondence sent by IDOR and how local government officials should respond, reports that LTAD makes available and how local officials can access them and information that is available on IDOR's website to assist local officials. Illinois Department of Public Health (IDPH) COVID-19 Grant Opportunity

IDPH recently announced up to \$3.7 million in grants will be available for communities outside of Cook County to address and implement COVID-19 health equity strategies.

This federally-funded program, Activating Relationships in Illinois for Systemic Equity (ARISE), is a joint initiative of IDPH and the Center for Rural Health intended to help organizations address health inequities in their communities that have been exacerbated by the COVID-19 pandemic.

Up to 15 community collaborations of three or more partners and their local health departments will be awarded up to \$235,000 to address and implement a health equity strategy in the context of COVID-19. Up to 25 additional communities will receive \$10,000 microgrants to advance health equity.

White House Releases Technical Assistance Guide for Bipartisan Infrastructure Law

This week, the White House released a Bipartisan Infrastructure Law technical assistance guide (available via this link) to help state, local, tribal and territorial governments navigate, access and deploy resources related to the 2021 Infrastructure Investment and Jobs Act. The Biden Administration has identified over \$700 million in dedicated funding across more than 65 technical assistance programs.

Since the signing of the Bipartisan Infrastructure Law, more than \$110 billion has been announced and allocated to states and communities from formula and competitive programs for roads and highways, bridges, ports, airports and water systems, with another \$100 billion in notices of funding opportunity availability for competitive grants underway.
