Village of Tekonsha **recall petition** language:

Nov. 8 2021 ON meeting Agenda, Potential sAle of M-60 property, Without the owners Knowledge or consent Mr Rigg involved himself with potentiAl buyer. A few days Later owner was told her SAle was TerminAteD. Dec. 15 2021 . Mr Rigg walked into the post office with questions for the Post master without making Appointment for her Time, He quickly got Angry Raising his voice, cAusing concerns from customers in the building. He WAS told LeAve

**Number of signatures required:** (The petitions shall be signed by registered and qualified electors equal to not less than 25% of the number of votes cast for all candidates for the office of governor at the last preceding general election in the district the officer is sought to be recalled. This is a calculated number based on the ratio using the number of Tekonsha Village voters compared to the total Tekonsha Township Precinct 1 voters in the November 6, 2018 election.)

Tekonsha Village Trustee recall: **62 valid signatures** are needed to recall Howard Rigg.  
250 Tekonsha Village 11/06/2018 voters divided by 656 Total Tekonsha Township Precinct 1  
11/06/2018 voters equals a ratio of .38110%. This ratio applied to 641 (Tekonsha Township votes cast for all Governor candidates) equals 244. 25% of the 244 ratio of votes cast for all Governor candidates in the 11/06/18 Gubernatorial Election in Tekonsha is 61.07088415, rounded up to **62**.

**The Clarity/Factual Review Hearing** is scheduled for Monday, February 14, 2022 (20<sup>th</sup> day after filing), 2:00pm, at the Calhoun County Building, 315 W. Green Street, Marshall, MI 49068, Boardroom 3-C08 (the Board of Commissioner's Chambers on the third floor).

- The sponsor Rose Bush and the officeholder Howard Rigg will have an opportunity to speak to the Election Commission to express their concerns as to the petition language being clear and factual.
- The County Election Commission will discuss and vote to approve or disapprove the recall petition as clear and factual in nature; to determine if the petition meets statutory criteria.
