As of Noon, Wednesday, Sept. 30:

There are **1324** positive cases of COVID-19 in Calhoun County

There are **45** deaths reported

There are **9** persons currently hospitalized in Calhoun County

975 persons have been released from isolation orders



- Family gatherings, such as weddings, funerals, birthday parties
- Religious services

Changes to CCPHD Services

Beginning Thursday, the CCPHD will focus clinical services on Flu Vaccinations, Immunizations, and TB Testing.

Revised Clinic schedules are as follows:

- **Albion:** Monday and Tuesday, 8-12:30 & 1-4:30 (last appointment at 3:30); and Friday 8am - Noon
- **Battle Creek:** Monday - Thursday, 8-12:30 & 1-4:30 (last appointment at 3:30), and Friday 8am-Noon

Executive Orders Update

- EO 183 takes effect 12:01 a.m. on Oct. 9
 - Indoor theaters, cinemas, performance venues may open
 - Facilities like amusement parks, arcades, bingo halls, bowling centers, roller/ice rinks, water parks may open
- Residential venue gatherings - 10 or fewer indoors; 100 or fewer outdoors
- Non-residential indoor/outdoor gatherings limit attendance to a percentage of capacity or square footage
- Organized sports - Live audience limited to 2 guests per athlete; no concessions may be sold at indoor venues

Full Blast Update

- City's **Full Blast Recreation Center reopens Monday, Oct. 5**
- Hours are 7 a.m.-7 p.m. Monday-Friday, 9 a.m.-5 p.m. Saturday, closed Sunday
- Visitor COVID screening & temperature taken
- Masks required; follow distancing guides
- Fitness Center open - equipment spaced further apart
- Courts open - two spectators per athlete for organized sports
- 25 percent capacity
- Front desk will sell Battle Creek Transit passes
- Fall programs pending

Food/Supply Distribution Continues

- Good work continues across Calhoun County communities
- Restoration Life Church - food distribution by Faith-Based Coalition and CareWell Services
- Northside families/Washington Heights UMC - 150 boxes distributed by Faith-Based Coalition & RISE
- Eastside families/St. Mark CME - 100 boxes distributed by Faith-Based Coalition & RISE



Food/Supply Distribution - CareWell

- CareWell Services still purchasing groceries, delivering medications, meeting other needs for COVID-positive families, or those isolated/quarantined
- Distributing 150 food boxes per week with Food Bank to Senior High Rises (rotating, so each gets monthly delivery), with extra boxes to Haven/SHARE Center
- Weekly food distribution in Homer
- Transitioning to work with PHD to increase flu vaccinations in older adults
