RE: Updated 2024 Bail Bondspersons Listing, **Effective July 1, 2024**

The attached is an updated listing of bail bondspersons engaged in the business of becoming surety upon bonds for compensation in **CRIMINAL CASES** within Calhoun County as required by MCLA 750.167b(4). The law provides that the list shall be posted in a conspicuous place in each police precinct, jail, prisoners= dock and house of detention, and in every other place in which persons in custody of the law are detained and one or more copies, thereof, shall be kept on hand.


Any person detained in custody in any place of detention requesting a bondsperson must be given a copy of the list **WITHOUT RECOMMENDATION**. After selecting a bondsperson, the detainee must be put in communication with the bondsperson. Further, the law requires that a place of detention must keep a permanent record showing the name of the detainee, the charged offense, the time at which the bondsperson was requested, the bondsperson requested, and the name of the person actually contacting the bondsperson.

Bond in **CIVIL MATTERS** (FOC warrants, PPO violations) must be cash, unless otherwise specifically directed by the issuing Court.
