PLEASE TAKE NOTICE that any qualified elector of Calhoun and Jackson Counties in the Marshall Public Schools district who is not already registered, may register to vote at the office of their City or Township Clerk, the office of the County Clerk, a Secretary of State branch office or other designated state agency; or may use the Online Voter Registration System at www.Michigan.gov/vote. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **MONDAY, APRIL 17, 2023**.

After Monday, April 17, 2023, anyone who qualifies as an elector may register to vote in-person with proof of residency (MCL 168.492) at their City or Township Clerk's office at the following times. All offices will be open Election Day from 7:00a until 8:00p.
