Shall the previous voted increase in the authorized charter millage for the Charter Township of Emmett which expired at the end of 2020 and established at 1.699 mills (\$1.699 per \$1,000 of taxable value), and unchanged by the required millage rollbacks, be renewed at 1.699 mills (\$1.699 per \$1,000 of taxable value) and levied for 10 years, 2021 through 2030 inclusive, for the specific purpose of retaining eight (8) public safety officer positions (police and fire), raising an estimated \$607,594.00 in the first year the millage is levied?
