This proposal will allow the school district to continue to levy the building and site sinking fund millage that expires with the 2019 tax levy.

Shall the currently authorized millage rate of 0.9977 mill (\$0.9977 on each \$1,000 of taxable valuation) which may be assessed against all property in Tekonsha Community Schools, Calhoun and Branch Counties, Michigan, be renewed for a period of 8 years, 2020 to 2027, inclusive, to continue to provide for a sinking fund for the purchase of real estate for sites for and the construction or repair of school buildings and all other purposes authorized by law; the estimate of the revenue the school district will collect if the millage is approved and levied in 2020 is approximately \$68,212 (this is a renewal of millage that will expire with the 2019 tax levy)?

The whole number of votes given for and against the Tekonsha Community Schools Sinking Fund Millage Renewal Proposal was three hundred seventy-three 373
of which number two hundred fifty-six votes were marked YES 256
and one hundred seventeen votes were marked NO 117
