C&C Landfill Recycling Center Program

In June, the landfill recycling center was relocated to the new landfill entrance. There is now a paved road leading to the scale house and a compactor for the recycling. Residents can continue to request passes from the Solid Waste Program or their local unit of government to use the recycling center for free. This center is single stream and open 6 days a week.

Pounds of Appliances Collected

Calhoun County collected appliances during two events in 2022. All appliances and scrap metal are collected during our April event at Bailey Park. The Albion event is limited to appliances without refrigerant and scrap metal.

Air conditioners, dehumidifiers, freezers, refrigerators had their refrigerant removed, so the items could be recycled with the scrap metal collected during our Battle Creek event.

Scrap Tire Collections

Calhoun County received an EGLE Scrap Tire Cleanup Grant to hold collection events and cleanup an illegal tire accumulation in a neighborhood in Battle Creek. The Hamblin Avenue Neighborhood Cleanup was a collaborative effort between Calhoun County (Park, Sheriff, Solid Waste, and Treasurer), the Calhoun County Landbank Authority, the City of Battle Creek, EGLE, and neighborhood property owners.
