Don't forget these important deadline dates:

- Hardship Extension due by February 14, 2022
- Delinquent Property Taxes come over to County from Local Unit on March 1, 2022
- Forfeited Property Tax for 2020 taxes will happen on March 1st.
- Last Day to pay 2019 taxes to prevent Foreclosure will be March 31st.

## FINANCIAL HARDSHIP EXTENSION

Hardship Extensions are designed to delay foreclosure deadlines by one year for owners who are actively working to catch up their delinquent property taxes. Hardship Extensions are aimed at homeowners but may be granted for businesses that are the primary source of the owner's income.

The person requesting an extension must occupy the property as a primary residence and hold title to the property, or be a legal guardian, conservator or have power of attorney over the owner/resident or represent the estate of the title holder, if deceased. In addition, the property cannot have outstanding code violations or any recorded income tax liens.

## FREQUENTLY ASKED QUESTIONS ABOUT THE MARCH 31 DEADLINE

### **What's the importance of the March 31 deadline?**

To be compliant with the Michigan law, the last day to pay your forfeited taxes at the Calhoun County Treasurer's Office will be March 31, 2022. We can no longer extend the property tax redemption period.

### **How do I prevent foreclosure?**

You must pay delinquent 2019 and/or prior year taxes before March 31st.

### **What should I do if I cannot pay my property taxes?**

Contact our office to speak with Katie or Heather about applying for a hardship extension. If you agree to the terms of a hardship extension payment plan, you can have more time to complete the payment of your 2019 taxes.

## TAXPAYER ASSISTANCE

### **Poverty Exemptions**

A reduction in property taxes is possible for eligible low-income homeowners from the local assessor.

### **Property Tax Deferment**

Seniors and certain disabled homeowners may be eligible for a delayed payment deadline at their local city or township.

### **Appeal Your Assessment**

Don't agree with the valuation of your property? You can appeal in March with local assessor.

### **Disabled Veterans Exemption**

Qualifying disabled Veterans are entitled to an exemption from paying real property tax on their principle residence.

### **Principle Residence Exemption**

Qualifying homeowners can claim an exemption on their primary residence.

# 2019 PROPERTY TAX TIMELINE

**March 1, 2020:** Unpaid 2019 property taxes became delinquent and were forwarded to the county treasurer for collections. State law requires a 4% administration fee and 1% per month interest.

**October 1, 2020:** A \$15 fee is added.

**March 1, 2021:** Property is forfeited to county treasurer. Minimum of \$285 in fees added. Interest increases from 1% per month to 1.5% per month, back to the date the taxes became delinquent.

**June 2021:** Foreclosure petition filed in Circuit Court and a \$10 fee is added.

**June-October 2021:** Notice of Show Cause Hearing and Judicial Foreclosure Hearing are personally served upon a property occupant or posted on the property.

**December 2021-January 2022:** A \$50 legal fee is added and forfeiture list is published in newspaper.

**January 2022:** Show Cause Hearing held.

**February 2022:** Judicial Foreclosure Hearing held.

**March 31, 2022:** Redemption rights expire if taxes are not paid and property ownership transfers to the Calhoun County Treasurer. Evictions can begin as early as April 1.

**Late August/September 2022:** Property sold at auction.
