#### MINUTES – REGULAR MEETING CITY OF CAMILLA, GEORGIA NOVEMBER 8, 2021

The regular meeting of the Mayor and City Council of the City of Camilla was called to order at 6:30 p.m. on Monday, November 8, 2021 by Mayor Owens.

Roll call indicated the following present: Councilman Campbell, Councilwoman Willingham, Councilman Morgan, Councilman Twitty, Councilman Pollard, and Councilman Palmer.

City Manager Steve Sykes, City Attorney Tommy Coleman, and City Clerk Cheryl Ford were also present.

#### **OPENING PRAYER AND PLEDGE**

Councilman Pollard gave the invocation and the Mayor and Council led the Pledge of Allegiance to the Flag.

#### APPROVAL OF AGENDA

On motion by Councilman Pollard, seconded by Councilman Morgan, the November 8, 2021 agenda was approved as presented by a unanimous vote.

#### **APPROVAL OF MINUTES**

On motion by Councilman Campbell, seconded by Councilwoman Willingham, the minutes from the October 11, 2021 City Council Meeting were approved as presented by a unanimous vote.

#### SPEAKER APPEARANCES

Mayor Owens stated Mr. Eddie C. Toombs and Bonnie Odoms are scheduled as agenda item speakers. Ms. Bonnie Toombs Odoms introduced herself and stated Eddie C. Toombs is her brother. Their concern is in reference to Oakview Circle. It is located at Peachtree Street going north in the curve and if you turn left their residence is the black and white house in the middle of two other houses. With reference to resurfacing, since 2020 she has called several times and talked to Tammy, Carla, Cheryl, and Councilman Pollard about resurfacing. She cannot remember the last time the street was resurfaced but the house was built in 1968 and resurfaced maybe one time. The last time it was resurfaced it was in the very center of the street and gravel placed on the sides of the street, causing a problem with gravel getting stuck in the car tires and they would like for the street to be repaved. When it rains water runs into the yard. The house has a lower level on the ground and on the lower level is a garage, den, and bedroom. Water runs into the garage and they have to sweep it out. Water also settles in the yard and two times vehicles have gotten stuck in the yard and had to be towed out. She commented they would like for the items to be addressed and are good law abiding citizens, pay their taxes and keep their neighborhood clean and they hope the Council can do something. Mayor Owens and Councilman Pollard thanked Ms. Odoms for being present tonight.

#### **ACTION ITEMS**

#### 2022 ALCOHOL RENEWALS – BEER/WINE/LIQUOR POURING

The Council reviewed a list of applicants for calendar year 2022 for on-premises and offpremises alcohol license renewals (beer/wine/liquor pouring). Police Chief Hendricks performed background checks as required and approved the applications as presented. The Council recommends approval of the list of 2022 applicants for beer/wine/liquor pouring license renewals.

On motion by Councilman Campbell and seconded by Councilman Pollard, the motion to approve the list of alcohol license renewals for 2022 passed by a unanimous vote.

#### ORDINANCE NO. 2021-11-8-1 – FOUR-WAY STOP SIGN AT ELLIS STREET/ BEACON STREET

The Council reviewed Ordinance No. 2021-11-8-1 authorizing the placement of a four-way STOP sign at the intersection of Ellis Street at Beacon Street. A traffic study investigation based on traffic volume, traffic speed and roadway geometrics was conducted and results warranted installation of a traffic device. The Council recommends adoption of the Ordinance, to waive the second reading, and authorization for the Mayor to sign.

On motion by Councilman Campbell, seconded by Councilman Pollard, the motion to adopt Ordinance 2021-11-8-1, waive the second reading, and authorize the Mayor to sign passed by a unanimous vote.

## 2022 LOCAL MAINTENANCE IMPROVEMENT GRANT AND TRANSPORTATION SPECIAL PURPOSE LOCAL OPTION SALES TAX PAVING PROJECTS

The Council reviewed the 2022 Local Maintenance Improvement Grant (LMIG) and Transportation Special Purpose Local Option Sales Tax (TSPLOST) street paving project lists. Recommended LMIG streets for paving include N. Harney Street and S. Underwood Street. Recommended TSPLOST streets include Cedar Lane, North Butler, Perry Street, Lincoln Street, Azalea Drive, Barrow Street, and Thomas Avenue. The Council recommends approval of the two paving projects and streets as presented and authorizes the Mayor to execute the Local Government Affidavit and Certification for the City's Fiscal Year 2022 LMIG application.

A motion was made by Councilman Campbell and seconded by Councilwoman Willingham. Councilman Twitty asked for a brief explanation from the City Manager. City Manager Sykes stated the approval of the list tonight allows them to prepare construction plans, bid documents and advertise for 30 days both on the State Registry and local newspaper. Anticipation is bids will be opened in the early part of 2022 and improvements will begin in April. This is the first of two projects planned for 2022 and the second project is using both TSPLOST and SPLOST funds and anticipated for October. Councilman Morgan commented he was sure they have seen the passing of the large infrastructure bill and asked if any communication had come down when the funds would be received. He further commented we have large plans on doing more resurfacing. City Manager Sykes stated nothing official and just a lot of speculation you would

see around the excitement of a lot of money coming toward local government. Through GMA and our Public Works Associations they will stay on top on any announcements made. As soon as funds are identified and released he will bring back to Council. They may receive information from other sources they get and they can discuss how to best identify and utilize those funds. The motion to approve the paving projects and streets as presented and authorize the Mayor to execute the Local Government Affidavit and Certification for the City's Fiscal Year 2022 LMIG application passed by a unanimous vote.

#### **RESOLUTION NO. 2021-11-8-1 – CERTIFIED CITY OF ETHICS RECERTIFICATION**

The Council reviewed Resolution No. 2021-11-8-1 expressing the City's desire to recertify as a Certified City of Ethics under the Georgia Municipal Association's program. The Resolution includes the following ethics principles and pledges the Council, as a group and as individuals, subscribes to in conducting its affairs: serve others, not ourselves; use resources with efficiency and economy; treat all people fairly; use the power of our position for the well-being of our constituents; and create an environment of honesty, openness and integrity. The Council recommends approval of the Resolution and authorizes the Mayor to sign.

On motion by Councilman Campbell, seconded by Councilman Pollard, the motion to approve Resolution No. 2021-11-8-1 and authorization for the Mayor to sign passed by a unanimous vote.

#### CITY COUNCIL CHAMBER RENOVATIONS BUDGET APPROVAL

City Manager Sykes provided a report on a proposed interior renovation project for the Council Chamber located on the first floor of City Hall. The project includes installation of a new Council table, glass top, plank flooring, picture molding, window shutters, wiring/ microphones/sound/electrical, extension of Council area platform, and painting of walls and trim. The preliminary estimated total for the project is \$21,300. The Council recommends approval of the project with a budget to not exceed \$25,000.

A motion by Councilman Campbell and seconded by Councilman Pollard. City Manager Sykes commented the Mayor asked about monitors earlier and with Councilmembers sitting further apart there will not be the ability to share monitors. They would like to come back after the project is finished and spec and bid out a monitor AV system that will allow each councilmember a monitor. His plan is to present the information they currently have in front of them [agenda packet] on the monitor. PowerPoint presentations will be also be presented on the monitors. The monitors are not included in the budget and will be brought back as a separate item. Councilman Campbell asked if anything will be done with the pulldown screen and City Manager Sykes stated we could and will look at that. An option is it could be replaced with a large flat screen monitor. Mayor Owens stated the reason he asked the question related to the monitors is the pulldown screen. If they are sitting at the Council table they all have the ability to see the same thing in real time. Once they get the other items in place, with the budget at \$25,000 in conjunction with these items, if there is money left he could get the monitors at the same time.

City Manager Sykes stated he believes funds will be available in the current budget for this. The motion to approve the Council Chamber renovation project with a budget not to exceed \$25,000 passed by a unanimous vote.

#### **ORDINANCE NO. 2021-12-13-1 – NAME SELECTION FOR SPLASH PARK**

The Council discussed the name of the new splash park located on Oakland Avenue and scheduled for completion in December 2021. The City currently does not have a policy to govern the naming of parks. At the completion of the Committee Meeting discussion on November 1, 2021, the park name offered for consideration in ordinance form will be Camilla Splash Park with first reading tonight. A 30-day period will be made available for community feedback on the proposed name. After reviewing and discussing the feedback, Ordinance No. 2021-12-13-1 will be considered for adoption on second reading at the December 13, 2021 council meeting. Mayor Owens read the Ordinance for the record and commented as the Ordinance signifies, for the next 30 days the public can feel free to reach out and have their thoughts known on the name for the splash park.

#### **CITY MANAGER'S REPORT**

City Manager Sykes stated he would highlight items in his report: the splash park is near completion and the building completed with the parking lot under construction. Once the parking lot is complete, the landscaping and fencing will begin. Toombs Park playground equipment is ordered and being manufactured. He has a preliminary plan where to place the equipment and plans to bring to the December Committee Meeting for their thoughts. He wants to fence in the playground area for the children's safety. Part of the Toombs Park installation was public Wi-Fi and as the splash park on Oakland nears completion they will begin the design and installation of a Wi-Fi system. The TSPLOST paving and sidewalk bids were received and awarded last month, they had a pre-construction meeting with the contractor and are preparing to resurface streets previously approved. The two locations for gateway signs are both on Highway 19, one coming in from Albany and one from Thomasville. For the Albany parcel we have an agreement with the property owner and he has put in his hand a quitclaim deed which will deed the property to us and construction easements allowing us to clear in front of the sign so it is fully visible. For the sign to the south he has a verbal agreement and our attorney is working with the Catholic Church. Once they have both signed quitclaim deeds the City will own the properties. He is collecting bid information to build the signs and will bring to Council for approval. Councilman Pollard asked about the sign near the church and City Manager Sykes stated the location is where MacArthur takes off at an angle to the right and the triangle property. The property is located there and owned by the Catholic Church. Councilman Campbell stated the COVID update looks good and City Manager Sykes stated the new numbers look good with no new positive cases, hospitalizations or deaths.

#### MAYOR'S COMMENTS

Mayor Owens stated he wanted to acknowledge Veterans Day, which is later this week. As they approach Veterans Day they honor those who served and continue to serve our country and thank them. On behalf of the City Council and the citizens of Camilla they express their gratitude for the sacrifices they, and their families, make and have made in combat and in peace. As elected

officials celebrating Veterans Day, service members teach them how to explore ways to find commonality and work as a team, transcending politics and recognizing there is strength in unity, even when they disagree. On Veterans Day they not only honor service members but also what they represent. On Veterans Day and beyond we can all practice empathy, unselfishness, courage, honor and commitment. May God bless our veterans and continue to bless our beautiful city.

The budget for the project is estimated at \$250,000 and total construction cost including design and construction inspection services is \$389,974. Funding for the project will

consist of federal funds in the amount of \$333,333 during construction and \$50,976 from NPE (Non-Primary Entitlements) funding reimbursable in 2022. The project cost for the City of Camilla is \$5,665. The Council recommends awarding the bid to Drummond Construction of Hawkinsville, Georgia in the amount of \$296,462 and authorizing the City Manager to sign contract documents.

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CAMILLA REAFFIRMING THE EXISTING ELECTION DISTRICTS; REPEALING ALL RESOLUTIONS IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

WHEREAS, the City of Camilla elects members to the City Council from two election districts; and

WHEREAS, members are elected from Post 1 and Post 2 from each respective district; and

WHEREAS, in order to comply with the United States Supreme Court decision and all the laws and regulations promulgated by the United States Justice Department it is necessary to maintain the population of the election districts relatively equal; and

WHEREAS, the accepted deviation of the United States Justice Department and the Office of Legislative Reapportionment for the State of Georgia, the standard deviation can be no more than five percent from the ideal population in a district; and

WHEREAS, after the diennial census, the City of Camilla did receive assistance from the Reapportionment Office as created by the Georgia General Assembly; and

WHEREAS, the districts as presently constituted show a deviation of less than two percent for each district; and

WHEREAS, after careful study and deliberation, the Mayor and City Council have determined that the districts as currently drawn meet the requirements of the United States Justice Department; and

WHEREAS, the Mayor and City Council have determined that reaffirming the current election districts would be less disruptive to the election process in Camilla and prevent confusion by certain electors who would be required to change election districts unnecessarily.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Camilla as follows:

<u>Section 1.</u> The election districts as currently constituted in the City of Camilla are found to be in reasonable compliance with the concept of one man one vote and within the deviation utilized by the United States Justice Department to comply with this requirement.

<u>Section 2.</u> The current election districts attached hereto as Exhibit "A" together with the population summary are hereby reaffirmed by the Mayor and City Council and shall be used for elections to the Camilla City Council and shall remain in place until

changed by the Mayor and Council by the adoption of an ordinance utilizing procedures in O.C.G.A. § 36-35-4.1.

Section 3. All resolutions or parts of resolutions in conflict herewith are repealed.
