

**MINUTES – CALLED MEETING

The Called Meeting of the Mayor and City Council of the City of Camilla was called to order at 1:00 p.m. on Tuesday, March 1, 2022 by Mayor Owens.

APPROVAL OF AGENDA

On motion by Councilman Twitty, seconded by Councilmember Tucker, the motion to approve the Called Meeting agenda for March 1, 2022 passed by a 5-0 vote.

EXECUTIVE SESSION - PERSONNEL


