The Carbon County Coroner's office requires all hospice and COVID-19 deaths to be reported to our office, as well as all hospital deaths when occurring within 24 hours of admission or deaths that fall under the notification guidelines.

Notification of death should be completed by filling out the [Death Advisory/Reporting Form](#) and either fax the form to 570-215-0594 or 570-386-4769 or email to depcor761@gmail.com within 24 hours after the death occurs.

It should be noted that when completing the cause of death: respiratory arrest, cardiac arrest, sepsis, Alzheimer's and dementia are not sufficient by themselves. Please list the underlying conditions the decedent has. (Example: Sepsis due to a urinary tract infection or respiratory arrest due to COPD)

When the death occurs under the following circumstances, notification should be made - Immediately to the coroner at 570-249-4992 or 570-233-2816.

- ‡ Deaths that occur under suspicious circumstances.
- ‡ Deaths suspected to be the result of suicide, homicide, poisonings (overdose)
- ‡ Deaths which take place in the Emergency Department
- ‡ Deaths which take place in the Operating Room following a traumatic event causing injury.
- ‡ Deaths which are known or suspected to be due to contagious disease and constituting a public hazard (this includes COVID-19)
