

Official Notice of Election for Military and Overseas Voters

County of Carbon

2023 Municipal Primary (May 16, 2023)

This is an official notice of an election to be conducted on May 16, 2023, in Carbon County. You may register to vote and request an official absentee ballot by using the Federal Postcard Application (FPCA), available at www.vote.pa.gov or www.fvap.gov. You may apply for an absentee ballot by submitting your FPCA by fax to (570) 732-0040, or by email to jketchledge@carboncounty.net

You may request an absentee ballot from this office at any time prior to a primary or election. However, if time does not permit you to receive and return an official absentee ballot, you are also entitled to vote using the Federal Write-in Absentee Ballot (FWAB). Military electors may also use the FWAB to register to vote and vote simultaneously.

You may use the FWAB to vote for **all** state and local offices, and ballot initiatives.

To vote, refer to page 3 of the FWAB.

To vote for state and local offices or for ballot initiatives, write the names of candidates or ballot initiatives in the Addendum section of the FWAB. Under the **Office/Ballot Initiative** heading, enter the office the candidate is running for or the title of the Ballot Initiative (referendum). Under the **Candidate Name, Party Affiliation or Initiative Vote** heading, list the name of the candidate you wish to vote for, or if you are voting on a Retention or Referendum question write “yes” or “no.”

If you submitted an FPCA, you must (1) affirm that you mailed your ballot no later than 11:59 PM on May 15, 2023, and (2) the County Elections Office must receive your ballot no later than May 23, 2023, by 5 PM prevailing time. Regular mail-in and absentee ballots submitted by voters must be received by the Board of Elections by 8:00 PM on November 8th.
