#### RESOLUTION

Juneteenth

WHEREAS, News of the end of slavery did not reach the frontier areas of the United States, particularly the State of Texas and other Southwestern States, until months after the conclusion of the Civil War – more than 2 ½ years after President Abraham Lincoln issued the

WHEREAS, On June 19, 1865, Union soldiers, led by Major General Gordon Granger, arrived in Galveston, Texas with news that the Civil War had ended and the enslaved were free; and

WHEREAS, African Americans who had been slaves in the Southwest celebrated June 19, commonly known as "Juneteenth Independence Day", as inspiration and encouragement for future generations; and

WHEREAS, Juneteenth Independence Day began as a holiday in the State of Texas, with official observations taking place in the Cities of Austin and Houston by 1867; and

WHEREAS, Celebrations of Juneteenth declined after many states began passing Jim Crow Laws, disenfranchising African Americans and restricting their ability to participate in the political process; and

WHEREAS, Texas became the first state to make Juneteenth a paid state holiday in 1979; and

WHEREAS, Local activist Ben Haith – the founder of the National Juneteenth Celebration Foundation – created the Juneteenth flag in 1997, later revising the design in 2000, with a star representing the State of Texas, a star burst representing all 50 states, an arc representing a new horizon, and the colors representing the American flag; and

WHEREAS, Congress passed a Resolution declaring Juneteenth a Federal holiday on June 15, 2021; and

WHEREAS, The City of Chelsea will hold its annual Juneteenth Celebration in Washington Park on Saturday, June 19, 2023, at 12 PM;

**NOW THEREFORE BE IT RESOLVED,** that the Chelsea City Council recognizes June 19, 2023 as "Juneteenth" and continues to support the nationwide celebration of Juneteenth to provide an opportunity for the people of the United States of America to better understand the experiences that have shaped our Nation.

Pursuant to Charter Section 9-5, Multiple Member Bodies, the City Council may approve a waiver of residency for a board or commission member, upon the recommendation of the City Manager. In accord with this provision, I am writing to recommend and request a waiver from the residency requirement for a member of the Conservation Commission.

Devan Braun has served on the Commission since September of 2020 and her term expires on February 28. 2024. Ms. Braun has recently informed the City that she is moving out of the City in order to be closer to family for assistance with her own growing family. She has stated that she would very much like to continue as a member of the Commission.

#### Dear Councilors:

I am writing to request approval of both the PEG Access Budget and the Community Preservation Act Budget for Fiscal Year 2024.

#### PEG Access FY24 Budget

Pursuant to M.G.L. c. 44, Section 53F3/4, all Comcast payments required by the 10 year Comcast Renewal License are paid into our PEG Access and Cable Related Fund. In order to expend monies from this Fund on behalf of the three entities that rely upon this source (Chelsea Community Cable Television 62.22%, the School Department 22.22% and the City 15.56%), the City Council must approve an annual budget for each of these entities.

I am writing now to request approval of the FY23 Budgets for each of these three entities The requested FY24 Budgets are: Chelsea Community Cable Television \$213,045; School Dept. \$85,000; and City \$130,000. Details on these budgets are attached. The City will utilize its funding for translation services, internet and telecommunications access to City Hall services, to support Year 2 of the MAPC-City Hall-CHA Prattville Internet Access Project and improvements to the City's fiber network.

#### Community Preservation Act FY24 Budget

Each year, the City Council also must approve the Community Preservation Act budget as adopted by the Chelsea Community Preservation Committee. The FY24 Budget proposed by the Community Preservation Act Committee is attached.

As you will see, the proposed CPA FY23 Budget reserves for appropriation 95% of the estimated revenues, with 10% allocated to each of the three statutory reserve accounts and the remaining 65% being allocated to the Budgeted Reserve Account. All of these accounts are subject to further appropriation by the City Council based upon recommendations from the Community Preservation Committee to fund specific projects.

For the remaining 5% of the estimated revenues, the Committee is requesting an appropriation for administrative expenses, which are expressly allowed by statute. The CPA Committee expects to utilize the majority of these funds to continue to pay its part-time administrator. In addition, the Committee will use some funds to pay dues to the Community Preservation Coalition and to create outreach materials to inform residents about the fund and the use of their tax dollars.

Please note that administrative funds can be used only in the fiscal year for which they are appropriated. At the end of the fiscal year, any unspent administrative funds will be transferred to the Budgeted Reserve Account and available in the following year for funding of specific projects.

I respectfully request your approval of both the PEG Access and CPA Budgets. The necessary Budget Orders are attached.

Re: Opioid Stabilization Fund

#### Dear Councilors:

The Office of the Massachusetts Attorney General settled lawsuits against opioid manufacturers, distributors, and retailers for their role in contributing to the devastation caused by the opioid crisis in the Commonwealth. The settlements provide that the defendants pay states and municipalities billions of dollars annually, with a current end date of 2038 to supplement and strengthen resources for opioid prevention, harm reduction, treatment, and recovery. Massachusetts is anticipated to receive approximately \$90 million for abatement of the opioid epidemic.

Under the terms of the Commonwealth's approved State-Subdivision Agreement, forty percent (40%) of the funds will be directly allocated to the state's municipalities to be spent on abatement strategies informed from the Opioid Recovery and Remediation Fund Advisory Council.

Chelsea received its first payment on or about July 15, 2022 (FY23), the second payment in September 2022 (FY23), and an additional payment in November 2020 (FY23), for a total of \$231,524.36. In order to "deposit" and therefore have access to these funds for the purposes for which they are intended, they must first be "appropriated" by the City Council. Here I propose to assign the opioid settlement proceeds to Miscellaneous Revenue in FY'23 and appropriate the same amount from FY'23 Certified Free Cash, in order to allocate the FY'23 equivalent value of the opioid proceeds to the below referenced special purpose Opioid Settlement Stabilization Fund.

The City Council can create a stabilization fund for the special purpose of holding and spending the opioid settlement proceedings by creating an opioid settlement stabilization fund and dedicating the settlement proceeds directly to the fund.

In order to accomplish this, the City Council would need to do the following:

- i.) Vote to accept the provisions of M.G.L. c. 40, Section 5B, paragraph 4, whereby it may dedicate, without further appropriation, certain receipts to any stabilization fund established pursuant to this section; then
- ii.) Vote to create the Opioid Settlement Stabilization Fund and dedicate the proceeds pursuant to M.G.L. c. 40, Section 5B. A two-thirds majority vote is required to create this fund.

Acceptance of these two actions will allow for opioid settlement proceeds to flow directly to the Opioid Settlement Stabilization Fund. Appropriations from this fund requires a two-thirds majority vote annually by the City Council. The fund will remain in existence until it is terminated.

I respectfully ask that the City Council approve all of these requested actions. The required Orders to effectuate these requests are attached.

Dear Councilors:

I'm writing at the request of the Chelsea Public Schools to seek Council authorization for the Chelsea School Superintendent with the approval of the City Manager to enter into a Memorandum of Understanding for the purpose of Title IV-E partial reimbursement for costs of providing foster care transportation.

The CPS provides transportation services to students placed under foster care in order to facilitate their continued education in Chelsea regardless of their placement location.

With this MOU authorization, the Chelsea Public Schools may annually claim the costs expended for foster care transportation – FY23 claim costs of \$220,000 – at an estimated reimbursement rate of 20% of reported claims, which is allowed under the Every Student Succeeds Act (ESSA).

Re: Year-End Financial Requests

Dear Councilors:

I am writing to request some final votes to address some end-of-year financial matters, including the need for some supplemental appropriations to cover deficits. The details are as follows:

#### 1.) Fires/Displaced Families - \$60,000

The Office of Emergency Management has led the rapid response initiative to house families displaced by fires in hotels and then transfer oversight and service to these families under the Department of Housing and Community Development. Five residential fires in the 1<sup>st</sup> half of the year caused 51 families to be displaced. The unbudgeted hotel costs for these events is \$60,000 to meet these outstanding obligations in FY23. The Department's FY24 proposed budget includes funds to provide this essential service. See attached summary from Director Staffier.

## 2.) Marginal Street Erosion/Undermining Stabilization Project - \$301,000

The Chelsea DPW has identified substantial erosion of the shoreline at 215 Marginal Street that must be addressed in order to prevent damage to the roadway and interruption of a major transportation corridor. The developing erosion condition has fully undermined the sidewalk with portions closed due to collapse, and the erosion process will continue and impact the roadway. Please see the Summary Report provided by Commissioner Fox-Lent and the proposed approach to place gravel as a temporary measure from further erosion and retain an engineering firm to perform further investigation, alternative analysis, and design and permitting for a broader protection plan. The current cost estimate is based upon one possible construction alternative, with an estimated cost of \$301,000, but the final solution and cost will likely not be known until later this year.

## 3.) CPD Body Camera Software Contract (June 2023 - June 2024) - \$126,209

The Department requires funding for the Year 2 (beginning June 2023) if the body camera software and support contract. All equipment, software support and training is complete. The Department will deploy the body cameras across the entire uniformed force (Patrol and Supervisor) during June 2023. In May 2022, the City Council approved a five-year contract for body cameras that included city funding (\$225,000) and grant funds (\$106,900) for equipment, software and training for Year 1.

## 4.) Continuation of the Employee Tuition Program - \$50,000

The City would like to continue its employee tuition benefit program. That program reimburses City Hall employees for undergraduate and graduate degree courses that are related to an employee's work in the City. The program is a well-received benefit and morale booster for our employees. The City Council originally appropriated \$50,000 for this program in 2018, and provided an additional \$50,000 in April 2021. Based upon anticipated usage by employees over the next fifteen months, the City anticipates that \$50,000 will be sufficient to cover all costs through the end of Fiscal Year 2024.

## 5.) Salary Deficits - Funded by Salary Reserve Transfers - \$30,000

There are some salary accounts that have inadequate funding. The specific amounts are:

- a.) Auditing Department Regular Salary \$6,859.00
- b.) Auditing Department -Overtime \$2,433.00
- c.) Purchasing Department Regular Salary \$3,453.00

- d.) Treasurer Department Regular Salary \$10,528.00
- e.) Treasurer Department Overtime \$1,579.00
- f.) Treasurer Department Longevity \$300.00
- g.) City Clerk Department Regular Salary \$4,848.00

The amount required to fund these salary deficits is \$30,000. There are sufficient funds remaining in the FY23 Salary Reserve Account to cover these deficits. There are other deficits where funding will be requested from Free Cash (noted below), as the above transfers have exhausted the Salary Reserve balance.

### 6.) Salary Deficits - Funded by Free Cash - \$153,002

There are additional salary accounts that have inadequate funding. The specific amounts are:

- a.) City Clerk Department Regular Salary \$12,839.00
- b.) City Clerk Department Overtime \$15,800.00
- c.) Licensing Department Regular Salary \$3,283.00
- d.) Housing/Community Development Department Regular salary \$15,824.00
- e.) Emergency Management Department Regular Salary \$17,224.00
- f.) Emergency Management Department Overtime \$43,933.00
- g.) Emergency Management Department Language Stipend \$5,625.00
- h.) DPW Snow Removal Overtime \$12,489.00
- i.) Elder Affairs Department Regular Salary \$6,285.00
- j.) Employee Benefits Medicare \$19,700.00 (payroll expense)

## 7.) Other Deficits Funded by Free Cash - \$243,273

There are seven operating accounts that are running deficits. As is typical in most years, we have deficits in our snow removal accounts. The specific shortages are: DPW Snow Removal Contract Services - \$102,647.00; DPW Snow Removal Salt - \$96,426.00, totaling \$199,073.00; as well as DPW Snow Removal Overtime - \$12,489.00 which I've requested be funded as a Salary Deficit from Free Cash (above), for an overall Snow Operations deficit of \$211,562.00.

Our Public Works Building and Grounds Division Telephones Line item is short \$18,000, due to expansion of business cell phone use among field and program staff.

There are two deficits in the Fire Department Operating lines – Gasoline for \$10,000 and Building Lighting for \$15,000.

Finally, we have small deficits in a couple of the Legislative Operating lines – Advertising for \$700 and Printing for \$500.

## 8.) Payment of Prior Year Invoices - Funded by Free Cash - \$24,530

Pursuant to M.G.L. c. 44, section 64, the City Council must approve payment of bills from a previous fiscal year from a current year appropriation. This is a revote of a FY22 Council Order, as these expenses were not advanced for payment in FY22 before the

books were closed. Our Personnel Department has unpaid invoices from prior fiscal year totaling \$24,530 to be paid from the Medical Services Account. These are costs associated with random drug testing for Police, Fire and DPW employees, and other medical costs in FY22. Council authorization to pay these prior year invoices is needed.

## 9.) Reauthorization of Revolving Funds - No Funding Required

Previously, the Chelsea City Council adopted an Ordinance establishing six revolving funds that allow certain Departments in the City to retain revenues raised by the Department and to use them departmental expenditures. However, the Ordinance requires that, each fiscal year, the City Council vote the expenditure limits for these accounts. The accounts established by Ordinance that need new limits for FY24 are as follows:

- a.) Elder Affairs (Senior Center) Revolving Account \$1,000
- b.) Housing/Community Development Tax Title Foreclosure Revolving Account \$100,000
- c.) Public Library Revolving Account \$20,000
- d.) Emergency Management Revolving Account \$30,000
- e.) Inspectional Services Revolving Account \$30,000
- f.) Community Schools Revolving Account \$100,000

In addition to these six revolving funds created by City Ordinance, there is one additional School Department revolving fund that requires annual reauthorization. That is the School Department Non-Resident Student Tuition Revolving Account. We are requesting an expenditure limit of \$250,000 for that account. This account contains tuition payments from other public school systems which use the CPS special education program. The funds are expended for program delivery.

#### 10.) Donations - No Funding Required

Pursuant to M.G.L. c. 44 section 53A, the City Council must approve acceptance of any gifts to the City.

Recently, the Chelsea Public Library has received gifts as follows: donations totaling \$750.00 for Literacy Day, donations totaling \$325.00 in memory of Ann Marie Leonard, and donations totaling \$225.00 in memory of Francis J. Zecha, Jr. in support of Library Operations. These donations require City Council approval.

In addition, the Chelsea Senior Center has received a donation in the amount of \$5,000 from Cohen-Freidberg Associates in support of the Senior Center programs. This donation requires City Council approval.

#### 11.) Grant Acceptance - No Funding Required

The Public Library has received a grant award from The Mass Center for the Book in the amount of \$2,750.00 to support the Gateways to Reading Program for Family Literacy in Chelsea. The City Council is required to accept and approve this grant.

For the reasons set forth in detail above, I respectfully ask that the City Council approve all of these requested actions. The required Orders to effectuate these requests are attached.

#### **Energy Management Services Agreement**

WHEREAS, the City Administration, through the North Suffolk Office of Resilience and Sustainability, has procured and conducted an Investment Grade Audit through MGL c.25A §11i and 225 CMR 19.00 for the purposes of installing and operating battery energy storage systems, solar photovoltaics, and identifying further energy conservation measures; and

- WHEREAS, the City's Investment Grade Audit of city-owned properties was performed by Ameresco Inc., and Ameresco, Inc. has identified the aforementioned measures to provide cost savings to the City; and,
- WHEREAS, the City Administration procured a Tax-Exempt Lease/Purchase Financing Proposal to finance such energy conservation measures through a Tax-Exempt Equipment Lease/Purchase Agreement with Banc of America Public Capital Corp to realize such cost savings; and,
- WHEREAS, the City Administration desires to enter into a Tax-Exempt Equipment Lease/Purchase Agreement with Banc of America Public Capital Corp, or one of its affiliates, to finance such energy conservation measures for a period of 15 years, and said Tax-Exempt Lease/Purchase Financing Proposal has been shared with the City Council; and,
- WHEREAS, the City Administration desires to enter into an Energy Services Management Agreement with Ameresco, Inc. to manage the installation of such energy conservation measures for a period of 20 years, and said agreement has been shared with the City Council;

**NOW THEREFORE BE IT HEREBY ORDERED,** that the City Council of the City of Chelsea authorizes the City Manager to enter into the Energy Management Services Agreement with Ameresco, Inc. for the duration of 20 years.

#### **EQUIPMENT LEASE/PURCHASE AGREEMENT**

- WHEREAS, the City Council of the City of Chelsea, a duly organized and existing as a political subdivision, municipal corporation or similar public entity of the Commonwealth of Massachusetts, is authorized by the laws of the Commonwealth to acquire, finance and lease personal property for the benefit of the City of Chelsea and its inhabitants and to enter into contracts with respect thereto;
- WHEREAS, the City Council pursuant to Mass. General Laws c. 44, Section 21C, the City Manager recommends a lease purchase financing agreement for the acquisition of equipment that may be acquired through the issuance of debt under G.L. c. 44. Said equipment is for the improvement of the City's utility and energy services, a capital asset, and that the term of such agreement shall not to exceed 15 years; and,
- WHEREAS, the City of Chelsea Administration desires to acquire, finance and lease certain equipment with a cost not to exceed \$ 3,615,699.00 constituting personal property necessary for the City to perform essential governmental functions; and

- WHEREAS, in order to acquire such Equipment, the City proposes to enter into that certain Equipment Lease/Purchase Agreement (the "Agreement") with Banc of America Public Capital Corp (or one of its affiliates) and the City Council has had the opportunity to review the Agreement; and,
- WHEREAS, the City Council deems it for the benefit of the residents of the City of Chelsea and for the efficient and effective administration thereof to enter into the Agreement and the other documentation relating to the acquisition, financing and leasing of the Equipment to be therein described on the terms and conditions therein and herein provided;

**NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED** by the City Council of the City of Chelsea as follows:

It is hereby, found and determined that the terms of the Agreement, are in the best interests of the City of Chelsea for the acquisition, financing and leasing of the Equipment and that the form, terms and provisions of the Agreement are hereby approved in substantially the forms presented with such insertions, omissions and changes as shall be approved by the City Manager and/or the City Solicitor of the City of Chelsea;

It is hereby further ordered that the City of Chelsea, pursuant to General Laws Chapter 44, Section 21C, and upon the recommendation of the City Manager, authorizes the lease purchase financing agreements with the Banc of America, for the acquisition of equipment that may be acquired through the issuance of debt under G.L. c. 44 or improvement of a capital asset the improvement of which may be financed by the issuance of debt under G.L. c. 44, the term of such agreement not to exceed the useful life of the equipment or improvement as determined by the City Manager.

It is further hereby ordered, that the City Manager is hereby authorized and directed to execute, and the City Solicitor of the City of Chelsea is hereby authorized and directed to attest, the Agreement and any related Exhibits attached thereto and to deliver the Agreement (including such Exhibits) to the respective parties thereto, and the City Clerk of the City of Chelsea is hereby authorized to affix the seal of the City of Chelsea to such documents.

It is further ordered, that the City Administration shall take all action necessary or reasonably required by the parties to the Agreement to carry out, give effect to and consummate the transactions contemplated thereby including the execution and delivery of a Final Acceptance Certificate, an Escrow Agreement, Disbursement Requests and any tax certificate and agreement, as contemplated in the Agreement and to take all action necessary in conformity therewith, including, without limitation, the execution and delivery of any closing and other documents required to be delivered in connection with the Agreement.

It is further ordered, that the City of Chelsea appropriate the sum of \$249,855.89 from Free Cash for the payments required in the first fiscal year of the lease purchase financing agreement authorized by the City under General Laws Chapter 44, Section 21C, for equipment acquisition to improve the City's utility and energy services.
