The regular monthly meeting of the CHELSEA RETIREMENT BOARD will be held on Thursday, August 18, 2016 at 9:00 a.m. in the Conference Room of the Chelsea City Council.

## **Tentative Agenda:**

Discussion of resumes and interviews to be conducted for the Executive Director position.

Approval of the minutes from the Special Meeting held on July 13, 2016 and Regular and Executive Session minutes from the July 21, 2016 meeting.

Robert Belanger, Jr., Chelsea Police Sergeant, previously received permission to purchase prior police service, when retirement deductions were not taken (2/23/90 – 11/4/90). He believes payment, which includes accrued interest, is unfair and would like to appeal this decision to the board.

Strephon Treadway, Asst. City Solicitor, has requested to purchase prior service from 12/2/14 – 7/20/16, when he was not a member of the Chelsea Retirement System. He entered our system on July 1, 2016. He will be using his funds from VOYA for the buyback. The total cost would be \$4,707.92.

Ana Romero, School Department Clerk, has requested to purchase prior service from 9/2/90 -3/27/91, seven months when she was not a member of the Chelsea Retirement System. She started working 3/2/90 and was on a probationary period for six months. Her paperwork was not received in the retirement office until April 4, 1991. The total cost would be \$787.12.

The MTRS is asking how much liability Chelsea will accept for Maureen (Perkins) Thompson, a former paraprofessional with the Chelsea School Department from 9/3/96 – 12/5/97. Total creditable service would be one year and three months.

Request of Lieutenant Martin Conley to purchase his Massachusetts Army National Guard service from 6/6/75 – 11/26/80 and U.S. Army Reserve time 11/11/80 – 07/92 for retirement purposes.


