Background:

On February 12th, 2021, Texas Governor Greg Abbot issued a disaster declaration for all 254 counties in the State in response to the pending winter storm. On February 14, 2021, President Biden approved the Governor's request for a Federal Emergency Declaration. Burnet County, on February 13th, declared a local disaster declaration followed by Mayor Bentley's declaration on the 15th.

Mayor Bentley's disaster declaration is only good for seven days by State statute unless the Council confirms it. The existing declaration will expire on the 22nd, and at this time, I see no need to extend it. Declaring a local disaster may provide an opportunity for the City to recover expenses related to the disaster from FEMA.

In addition to the power issues we all suffered, it appears that we do have some freeze-related damages. However, it is still too early to determine the extent of the recent winter storm's effects on our facilities. I will give you a live update at your Council meeting.

PROCLAMATION DECLARING A LOCAL STATE OF DISASTER

WHEREAS, Meadowlakes, Texas has suffered widespread and severe damage and the loss of property and the imminent threat continues, including the potential for injury and loss of life as a result of heavy snow, prolonged freezing temperatures and impassable roads;

WHEREAS, the full impact of this event is still evolving and local resources have reached their limits and;

WHEREAS, the Mayor of Meadowlakes has determined that extraordinary measures must be taken to alleviate suffering of the people, protect life and property;

NOW, THEREFORE, BE IT PROCLAIMED, PURSUANT TO CHAPTER 418.108 OF THE TEXAS GOVERNMENT CODE, BY THE MAYOR OF MEADOWLAKES, TEXAS:

- 1. That a state of disaster has been declared for Meadowlakes, Texas.
- 2. That the Burnet County Emergency Management Plan has been implemented.
- 3. That this state of disaster shall continue for a period of not more than seven days of the date hereof, unless same is continued by consent of the City of Meadowlakes City Council.
- 4. That this proclamation shall take effect immediately from and after its issuance.

Councilmembers Peskin and Wise are running unopposed. All Candidate applications can be found on the City's website.

The filing period for candidates began on January 13th and ended on February 12th. The election will be held on May 1st with early voting beginning April 19th and ending April 27th.

As in the past, the Burnet County Elections Administrator will serve as our election administrator and is responsible for conducting the election. Our election will be held in conjunction with other entities.

Resolution No. 2021-01 February 23, 2021

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MEADOWLAKES CALLING FOR AND ORDERING A GENERAL MUNICIPAL ELECTION TO BE HELD ON MAY 1, 2021 FOR THE PURPOSE OF ELECTING THREE COUNCIL MEMBERS FOR TWO (2) YEAR TERMS EACH; PROVIDING FOR CONDUCT OF THE ELECTION AND AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MEADOWLAKES, TEXAS, THAT:

- Section 1. <u>General Election Ordered</u>. A general municipal election is hereby ordered to be held on the 1st day of May, 2021 for the purpose of electing (3) council members to two (2) year terms each by the qualified voters of the City of Meadowlakes to be conducted as prescribed herein.
- Section 2. Filing Period. The filing period for Candidates to file their application began at 8:00 a.m., Wednesday, January 13, 2021 and ended at 5:00 p.m., Friday, February 12, 2021. Applications were filed with the City Secretary, at Meadowlakes City Hall, 177 Broadmoor, Suite A, Meadowlakes, Texas, during normal business hours which are from 8:00 a.m. to 12:00 noon, and 1:00 p.m. to 4:00 p.m., and 5:00 p.m. on February 12, 2021. Applications submitted were on a form provided by the City Secretary.
- Section 3. <u>Drawing</u>. The order in which the names of the candidates are to be printed on the general election ballot was determined by a drawing that was conducted by the City Secretary at 3:30 p.m. at Meadowlakes City Hall on Monday, February 22, 2021.
- Section 4. <u>Contract Agent to Hold City Election</u>. The Mayor of the City of Meadowlakes is authorized to enter into a contractual agreement with the Elections Administrator of Burnet County, Burnet, Texas, to serve as the Elections Administrator for the City and to conduct said election in accordance with the rules and regulations set out in the Texas Election Code.

- Section 5. <u>Election Judge and Alternate</u>. As contained in the contractual agreement, the Burnet County Elections Administrator will recruit the presiding election judges and the alternate presiding judges and workers for the polling places and for the early voting ballot board.
- Section 6. <u>Early Voting</u>. Early voting by personal appearance shall begin Monday, April 19, 2021 and end Tuesday, April 27, 2021 and shall be conducted at the:

Marble Falls Courthouse Annex ~ or ~ AgriLife Auditorium 810 Steve Hawkins Pkwy. 607 N. Vandeveer St. Marble Falls, Texas 78654 Burnet, Texas 78611

Early Voting shall remain open for eight (8) hours each day that is not a Saturday, a Sunday, or an official holiday, between the hours of 8:00 a.m. and 5:00 p.m. from April 19th through April 27th, 2021. Early voting shall be conducted for 12 hours on Thursday, April 22, 2021 and Monday, April 26, 2021, from 7:00 a.m. to 7:00 p.m. each day.

- Section 7. <u>Ballot by Mail</u>. Applications for ballot by mail can be requested from the Elections Administrator and shall be mailed to and received by the Burnet County Elections Administrator, 220 S. Pierce, Burnet, Texas 78611 no later than April 20, 2021.
- Section 8. <u>Election Day</u>. Election Day voting shall be on May 1, 2021 from 7:00 a.m. to 7:00 p.m and shall be held at the Marble Falls Courthouse Annex, 810 Steve Hawkins Pkwy, Marble Falls, Texas 78654.
- Section 9. <u>Voting System</u>. In accordance with state law, the Hart Intercivic Verity Touch 2.0.3. with Access Direct Record Electronic (DRE) and Verity Controller Voting System, approved by the Secretary of State, shall be used for the general election. Each polling place must provide at least one accessible voting station for voters with physical disabilities to cast a ballot.
- Section 10. Ballots. Ballots shall be electronic except paper ballots for ballots by mail.
- Section 11. <u>Notice of Election</u>. Notice of said election as provided in the attached "Order of Election" shall be issued by the Mayor and posted by the City Secretary.
- Section 12. <u>General</u>. Qualified resident voters of the City shall be eligible to vote at the election. Votes shall be tabulated at the central counting station designated by the Burnet County Elections Administrator in the contractual agreement.

Returns of said election shall be made known as soon as possible after the closing of the polls and as upon contractually agreed.

Section 13. <u>Severability</u>. Should any part, section, subsection, paragraph, sentence, clause or phrase contained in this resolution be held to be unconstitutional or of no force and effect, such holding shall not affect the validity of the remaining portion of this resolution, but in all respects said remaining portion shall be and remain in full force and effect.

Section 14. Effective Date. This Resolution shall be effective upon approval and passage.
