**A RESOLUTION TO SUPPORT
A HOUSEHOLD HAZARDOUS WASTE
& SPECIAL RECYCLABLES COLLECTION PROGRAM
FOR THE CITIZENS OF BURNET COUNTY.**

WHEREAS, the County of Burnet, with the City of Bertram, City of Burnet, City of Cottonwood Shores, City of Granite Shoals, City of Highland Haven, City of Horseshoe Bay, the City of Marble Falls, and the City of Meadowlakes hereinafter known as the Burnet County Household Hazardous Waste (HHW) Committee want a regional HHW & Special Recyclables collection and education program for the citizens of Burnet County, and

WHEREAS, the Burnet County HHW Committee is aware that improper management and disposal of Household Hazardous Waste and other waste is a potential threat to public, health and safety, and

WHEREAS, the Burnet County HHW Committee is aware that improper disposal of Household Hazardous Waste and other waste is a potential threat to ground and surface water resources, and

WHEREAS, the HHW Collection and Education program will support efforts to prevent HHW and other waste materials from entering surface or ground water through municipal waste streams, sanitary or storm sewers, and illegal dumping, and

WHEREAS, the HHW Collection and Education program will support efforts to minimize HHW generation by promoting waste minimization practices such as the reuse of good quality household chemical products and special items recycling, and

WHEREAS, the HHW & Special Items Collection and Education program will help Burnet County residents, and their children understand the importance of proper natural resource conservation and management to a healthy and vibrant community.


NOW, THEREFORE, BE IT RESOLVED by the governing bodies of the County of Burnet, the City of Bertram, City of Burnet, City of Cottonwood Shores, City of Granite Shoals, City of Highland Haven, City of Horseshoe Bay, the City of Marble Falls, and the City of Meadowlakes that they do hereby approve and support a Household Hazardous Waste & Special Items Collection and Education program benefitting of the residents of Burnet County.


