

RESOLUTION NO. 11-008

A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE MAY 14, 2011, GENERAL ELECTION OF THE CITY OF MEADOWLAKES, TEXAS

Whereas, pursuant to the Texas Election Code, the City Council of the City of Meadowlakes, Texas, convened on this the 24th day of May 2011, at 5:00 P.M. for the purpose of canvassing the vote in the general election held on May 14, 2011;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MEADOWLAKES, TEXAS, THAT:

Section One. Canvass of Vote – General Election.

(a) There came to be considered the returns of the general election held on the 14th day of May, 2011, for the purpose of electing Councilmembers for Places 2, 4, and 5, and appearing from said returns, duly and legally made; that each of the candidates in said election received the following votes:



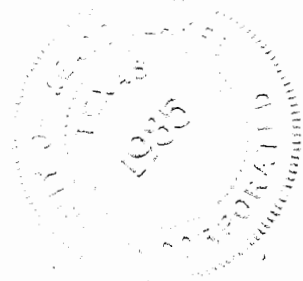
