#### Re: Historic District Signage – Catch Fire Creations – 230 Main Street (Parcel 1-00250-00)

Melissa Jensen has submitted an application for installation of window signs in a historic district located at 230 Main Street (Parcel 1-00250-00). The Applicant has executed a lease with the property owner to

occupy this space as Catch Fire Creations, LLC.

Prior to doing any renovations to the building Melissa contacted the city to ask questions about any permits needed for renovating the building. unfortunately There was а misunderstanding by both individuals about what permits were needed and the specific work that was being done and which lead to the installation of window signs to the property prior to approval by the Landmark Commission and staff. Staff later noticed the signs and contacted Melissa to fill out a Historic District Sign Application. The



installed signs are window signs with the company name and logo on two front windows facing Main St. and an additional window sign on the back entrance door. Being within a historical district, this would require review by the Landmarks Commission following Section 2-4-8(j)(1) and the Downtown Menasha Sign Design Guidelines for the C-2 Central Business District. The window signs would not require a permit.

Windows signs shall not exceed 30% of the window area so that visibility into and out of the window is not obscured, the sign copy should not exceed 8 inches in height, window sign copy shall be applied directly to glassed area, window signs should be created from high quality materials, window signs should be applied directly to the interior face of the glazing or hung inside the window, and well designed graphics should be used to attract attention but still allow pedestrians to view store interiors.

# Staff recommends the Landmarks Commission approve the signage as presented for 230 Main Street (Parcel 1-00250-00).
