

We, the undersigned municipal leaders, write to jointly express our interest in incorporating Green Bay and the greater Fox Valley region in the FRA's Corridor Identification and Development Program. This extension would build on Amtrak's highly successful Hiawatha Line from Chicago to Milwaukee.

The Fox Valley is the third largest metropolitan area in Wisconsin. Currently these communities are serviced by Amtrak Thruway I-41 Bus Service. This new passenger rail corridor would provide residents of Green Bay and the greater Fox Valley region with increased mobility options to the state's largest city, as well as service to Chicago.

A Green Bay — Milwaukee — Chicago Amtrak service would create new connections between major metropolitan cities, medium-sized cities, and colleges and universities. Students, their families, faculty, and staff will be able to take advantage of frequent Amtrak service to avoid traffic between destinations and to enjoy greater productivity or relaxation while they travel.

All seven cities along this corridor that would be served by the Hiawatha Extension strongly advocate for incorporating the project in the Corridor Identification and Development program. We strongly believe that this corridor satisfies the Selection Criteria outlined in the Federal Register Notice.

#### **ORDINANCE O-XX-23**

### AN ORDINANCE AMENDING TITLE 7, CHAPTER 1, SEC. 7-1-13 OF THE CODE OF ORDINANCES

INTRODUCED BY: Ald. Tom Grade and Ald. Austin Hammond

The Common Council of the City of Menasha does hereby ordain as follows:

SECTION 1: Amend Title 7, Chapter 1, SEC 7-1-13 of the Code of Ordinances of the City of Menasha, Wisconsin, creating subsection (D) KEEPING OF CHICKENS IN THE CITY as follows:

Title 7 - Licensing and Regulation

#### Chapter 1

Licensing of Dog, Cat, or Ferret and Regulation of Animals

..

### SEC 7-1-13 PROHIBITED AND PROTECTED ANIMALS, FOWL, REPTILES, AND INSECTS

• •

- (D) **KEEPING OF CHICKENS IN THE CITY**. In addition to all other regulations in this Chapter, the following shall apply to the keeping of chickens within the City.
  - (1) **<u>Definitions.</u>** The following terms, when used in this section, shall have the meanings set forth below:
    - a. **Chicken**—a domestic chicken of the sub-species Gallus gallus domesticus.
    - b. **Keep**—the owning, keeping, possessing, or harboring of a chicken.
    - c. **Rooster**—a male chicken of any age, including a capon or otherwise neutered male chicken.
    - d. **Coop**—a new or existing enclosed accessory structure designed or modified for the keeping of chickens and meeting the requirements of this section.
    - e. Chicken Run—a fenced cage attached to a coop.
    - f. **Hen**—a female chicken of any age.
    - g. **Front Yard** —A front yard shall be as defined by the City of Menasha Zoning Code under Title 13.

#### (2) **Permit Required.**

- a. Any person who keeps chickens on land in the City which the person owns, occupies, or controls shall first obtain an initial zoning permit issued by the Community Development Department. A permit application shall be accompanied by an application, an application fee as established by resolution of the Common Council, specification of the proposed coop/run, and a site plan. Upon the issuance of an initial zoning permit, an initial inspection of the coop shall be certified by the Health Officer and/or designee prior to the occupancy of chickens.
- b. All permit applications shall be accompanied by satisfactory evidence that the applicant has registered the proposed location with the Wisconsin Department of Agricultural Trade and Consumer Protection pursuant to Wis. Stats. §95.51 and ATCP 17 Wis. Admin. Code.
- c. One permit shall be permitted per R-1 Single Family Residence District, R-1A Low Density Single Family Residential District and R-2 Two-Family Residence District zoned parcel.
- d. Any person other than the recorded title owner looking to permit chickens shall first provide written consent of the property owner with the zoning review application.
- e. Following the initial approval of a permit, any person who continues to own, harbor, or keep chickens, shall annually prior to January 1, of each year, pay a license fee and obtain an annual license. The annual fee shall be as established by resolution of the Common Council.

#### (3) Keeping of Chickens Allowed.

- a. Up to six (6) chickens are allowed per parcel with a permit.
- b. No person shall keep any rooster.
- c. Chickens shall be provided with fresh water at all times and adequate amounts of feed.
- d. Coops shall be constructed in a workmanlike manner, be moisture-resistant, shall either be raised up off the ground or placed on a hard surface, and be adequately weather proofed and insulated to allow the comfortable living of chickens within the coop year-round.
- e. Coops with or without a chicken run shall be constructed and maintained to reasonably prevent the collection of standing water and shall be cleaned of hen droppings, uneaten feed, feathers, and other waste daily and as is necessary to ensure the coop and yard do not become a health, odor, or other nuisance. All feed containers shall be vermin-proof.

- f. Coops shall be large enough to provide at least three (3) square feet per chicken. Coops and chicken runs shall have an aggregate maximum of sixty-four (64) square feet and the height of the coop shall not exceed seven (7) linear feet as measured from the ground.
- g. No chicken coop shall be located closer than twenty (20) feet to any principal residential structure on an adjacent lot. All coops and runs shall be located at least three (3) feet off of the side and back yard property line.
- h. No chicken coop shall be located in the Front Yard of a property as defined herein.
- i. In addition to compliance with the requirements of this section, no person shall keep chickens that cause any other public nuisance as defined by Title 11 of the Menasha Code.

#### (4) Public Health Requirements.

- a. Upon the Health Officer and/or designee having reasonable suspicion of any coop or run having unhealthy or unsanitary conditions, any permit or license holder shall allow the Health Officer and/or designee to inspect the conditions of the coop and/or chickens upon reasonable notice (no less than 24 hours' notice). The Health Officer and/or designee shall provide notice to the permit or license holder to cure any violations found. Failure to correct said violations may result in the revocation of the permit per Section (5) below.
- b. Chickens shall be kept and handled in a sanitary manner to prevent the spread of communicable diseases among birds or to humans.
- c. Any person keeping chickens shall immediately report any unusual or sudden death or illness of chickens to the City of Menasha Health Department.
- d. The Health Officer may order testing, quarantine, isolation, vaccination, or humane euthanasia of ill chickens or chickens believed to be a carrier of a communicable disease. The owner of the chicken shall be responsible for all costs associated with the procedures ordered hereunder.
- e. No person may slaughter any chickens within the City.
- f. <u>Sale of Eggs and Baby Chicks Prohibited.</u> No person may offer to sell eggs or chicks accumulated from the activities permitted hereunder.
- g. The breeding of any chickens is strictly prohibited.
- (5) <u>Permit Revocation.</u> A permit is subject to revocation by the Health Officer and/or designee upon failure to comply with any provisions of sub. (3) or (4). Such revocation is subject to appeal by the Board of Health, upon the aggrieved filing an appeal request within thirty (30) days of the revocation with the Board of Health. Once a permit is revoked, a permit shall not be reissued.

SECTION 2: This amending Ordinance shall take effect upon passage and publication as provided by law.

#### **Background**

The City, School District, and Menasha Utilities have done extensive work to identify areas to reduce energy use and receiving grants to assist in those efforts. Last year the City, School District, and Utility applied for an energy planning grant through the Office of Energy Independence unsuccessfully. This year we are working with a consultant that has been successful in receiving grants to do similar projects. The outline for the project includes: Community Outreach, Benchmarking, Goal Analysis, Tracking Tools (see attached for more detail). The grant application is due at the end of January.

#### **Fiscal Impact**

The City, School District, and Menasha Utilities would contribute staff time for data collection, the grant would cover the costs of the consultant.

#### **Draft Project Tasks**

#### Task 1: Community outreach and stakeholder facilitated discussions

- Task 1A: Survey deployment to community members and businesses
  - o Survey will ask about residents and businesses viewpoint on sustainability
  - o Will be deployed through newsletters at school district and through utility, social media, community organizations and libraries, Sustainability Commission
  - o Work with Sustainability Commission to help draft questions for the survey
- Task 1B: Facilitated stakeholder discussions
  - o Series of discussions throughout planning process to discuss community-wide goals for energy reductions and strategies to be included in community energy plan
  - o Would include energy planning team, Sustainability Commission and any other internal stakeholders
  - o Would hold at least 4 stakeholder discussions throughout the planning process

#### Task 2: Benchmarking and baseline energy use

Note: The city of Menasha and the school district have already started the process of data collection and benchmarking buildings. This would expand on that work.

- Task 2A: Collect building energy data and benchmark energy use (most of this work is done for schools)
  - o Collect building data for each city building and utility facility
  - o Benchmark in EnergyStar Portfolio Manager or a similar tool
  - o For buildings without 'comparable' options in Portfolio Manager, use outside data sources to establish relevant benchmark comparisons (includes fire stations, police, etc.)
- Task 2B: Create an energy profile for each partner
  - o Includes all energy data for buildings, operations, and fleet
  - o Establish dashboard and/or spreadsheet for ongoing tracking of energy baseline and benchmarked buildings
- Task 2C: Audits of buildings
  - o Audit up to 4 buildings across city, fire department, and utility (school district has already done this)
    - Audits include BAS review and walkthrough of buildings to identify HVAC, lighting, and other energy opportunities
  - o Choose buildings based on benchmarking data review and conversations with staff

#### Task 3: Goal analysis

- Task 3A: Specific opportunities for city, school district, utility and NM Fire Rescue
  - o Building energy opportunities:
    - Electrification opportunities: explore ways to integrate heat pumps in capital planning
    - Energy efficiency opportunities: explore potential savings from EE
  - o Renewable energy opportunities
    - Solar
    - Battery storage
  - o Fleet
    - Analysis of near-term opportunities for fleet light-duty vehicles, school buses, fire trucks
- Task 3B: Policies
  - o **Internal policies:** provide policy options to institutionalize progress, including operational policies, purchasing policies
  - Community policies: through discussion will identify which policies make the most sense to evaluate. Will definitely include EV charging locations and may include voluntary options for development/benchmarking

#### Task 4: Final report and tracking tool deliverable

- Task 4A: Development of tool for ongoing assessment
  - o Evaluate and recommend tools for tracking progress after planning process ends
  - o Will include review of what other communities have done
  - o Will build on Slipstream's previous work on tools to develop a spreadsheet or dashboard for ongoing tracking
