Wisconsin State Park Campgrounds opening June 10th

The Wisconsin Department of Natural Resources will reopen state campgrounds on Wednesday, June 10th with special conditions to ensure the safety of staff and visitors.

Some of the changes that campers and park visitors will experience beginning June 10th include:

- Automatic touchless check-in.
- New signs to educate visitors on recreating responsibly.
- Park offices will remain closed to the public.
- Group camping, shelters, and amphitheaters will be closed through June 30th.
- Most restrooms are now open.
- Some water fountains may be closed in the day use area of the park or have the bubbler turned off and have access to the water spigot only.
- All other facilities will remain closed, including towers, shelters, playgrounds, nature centers, headquarters, contact stations, and concessions.

Where can I find guidance about mass gatherings?

Interim guidance on large gatherings can be found on the [DHS COVID-19 Avoid Illness Page](#). At this time, DHS does not advise large gatherings, and there is no projected timeframe available as to when this advisory would change. Public health experts agree that large gatherings of people in sustained, close contact greatly increases the risk for spread of the virus among those who attend the events and to the communities these individuals return to after the event. The communal nature of such events makes it especially challenging to accommodate the physical distancing and sanitation recommendations required to slow the spread of disease. This includes but is not limited to fairs, festivals, parades, and conferences.

2. Education
3. Social and community context
4. Health and health care
5. Neighborhood and built environment
