



City of Menasha COVID-19 Pandemic Resilient Plan

Date: November 11, 2021

Summary/What's New

- Last week, the CDC accepted the Advisory Committee on Immunization Practices' (ACIP) recommendation that children ages 5-11 years be vaccinated against COVID-19. Parents and guardians of children in this age group can schedule vaccinations using a variety of methods, including: their primary healthcare provider, community vaccination clinics, local and tribal health departments, or pharmacies. Check <u>vaccines.gov</u> to see which providers in the community are vaccinating children in this age group.
- WI DHS adopted recommendations from the FDA and CDC authorizing booster doses of the Moderna and Johnson & Johnson vaccines. All 3 COVID-19 vaccines are now authorized for booster doses. Eligible individuals may choose any of the 3 authorized COVID-19 vaccines as their booster, as long as time requirements are met.  - People who have completed their initial mRNA (Pfizer or Moderna) series are eligible for a booster dose at least 6 months after the 2nd dose in the primary series. People ages 18 years or older who received their first dose of the Johnson & Johnson vaccine at least 2 months ago are eligible for a booster. Not all vaccinators have all vaccine types on hand. Please check with your vaccinator or <u>vaccines.gov</u> for available inventory.
- The City of Menasha is currently experiencing a high level of community transmission and strongly recommends ALL individuals follow the <u>CDC guidance</u> to wear a mask in indoor public settings.
- Vaccination is still the best tool to prevent serious disease, hospitalization, and death due to COVID-19 and its variants, including the Delta Variant. View the WI DHS <u>COVID-19</u>: Illness after <u>Vaccination website</u> for data showing the rates of cases, hospitalizations, and deaths are all higher for people who are not fully vaccinated than for people who are fully vaccinated.
- Wisconsin residents age 5 and older are eligible to receive the COVID-19 vaccine. Only the Pfizer-BioNTech vaccine is currently authorized to be used for those ages 5-17. The Pfizer-BioNTech COVID-19 has full approval from the FDA for people ages 16 years and older. Visit the Menasha Health Department's <u>COVID-19 vaccine webpage</u> for vaccine clinic information.

 - 211 Wisconsin provides a special directory to find to find <u>pop-up vaccine clinics</u> in the state.
- Testing is available if you have symptoms of COVID-19, if you believe you were exposed to the virus, attended a large social gathering, or if you think you need a test even though you don't have symptoms. Visit our <u>COVID-19 testing sites webpage</u> for information about testing sites.
- As of November 5, 56.3% of City of Menasha residents have received at least one dose of the vaccine and 53.7% are fully vaccinated. *Due to a lag in data reporting at the state level, the most up to date vaccine information is not available this week.* To read more about vaccine data, see this dashboard.
- Currently in the City of Menasha the burden of confirmed and probable COVID-19 cases is very high and the activity level is very high. The combined case rate for this 2-week period (Oct 27 – Nov 9) is 640.4 cases per 100,000 population, which is an increase from the case rate of 530.0 from the previous 2-week period (Oct 20 – Nov 2).





Background

This data summary provides preliminary data on the cases of COVID-19 in the City of Menasha from Oct 27, 2021 – Nov 9, 2021. Most data included in this report is for laboratory confirmed cases of COVID-19 (lab-confirmed). Some data is available for probable cases of COVID-19. A person is counted as a probable case of COVID-19 if they are <u>not</u> positive by a confirmatory laboratory test method (PCR/molecular test), but has a positive antigen test OR has symptoms of COVID-19 AND has a known exposure to COVID-19. Case counts utilized for all graphs and tables are based on the date public health staff received and recorded the test results. Numbers here may not represent final case counts for this reporting period.




