

CR-05 - Goals and Outcomes

Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a) This could be an overview that includes major initiatives and highlights that were proposed and executed throughout the program year.

10,618 children participated in CDBG funded youth programs. 39 homeowners were assisted with housing repairs in an effort to maintain affordability. The City was awarded additional CDBG funds through the CARES Act which could be used to prevent, prepare for or respond to the Covid-19 crisis. A program was created to help businesses survive the pandemic. 74 businesses in the City were assisted with these funds. Teh Saginaw Housing Commission was assisted with an upgrade to its fire alarm system benefitting 250 residnets of their rental properties. The Community Policing Program continues to be successful although with the pandemic there was an increase in crime which was a notional trend. The Community Police work in a proactive manner to educate and work with residents of low and moderate income areas of the City on crime prevention and safety. The Community Police work with all of our neighborhood associations and community partners to promote safety awareness with events like Light Up The City and Arson Watch. A total of 448 persons were served with Emergency Shelter funds.



Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

Demolition is a high priority for the City of Saginaw. CDBG funds were used to clear 26 properties. Economic Development is a high priority for the City of Saginaw. CDBG funds were used to fund the Saginaw Economic Development Corporation and Downtown Development Authority which assists businesses in the City of Saginaw with a jobs created or retained requirement. The addition of CARES Act funds helped the City provide 74 businesses with assistance. Homeowner occupied housing rehabilitation is high priority for the City of Saginaw and the City was able to assist 39 homeowners with housing repairs to maintain affordability for their homes. Supporting emergency shelters is also a high priority. The City uses its ESG dollars to fund 4 homeless shelters with services to victims of domestic violence, homeless children and chronically homeless males.



Due to the Covid-19 pandemic there was an eviction moratorium that resulted in fewer people seeking assistance. Although three new contractors were recruited to work in the program during the previous program year the inflation in the construction industry has caused new issues. The price of supplies along with the age and disrepair of the properties has made it challenging to identify candidates that fall within the program constraints. We continue to have issues with insurance in certain areas of our community.

Future annual action plans needs to include assistance to contractor development. There needs to be more programs focused on rental housing assistance or a tenant based rental assistance program. Future annual plans need to have more goals to move homeless to persons into housing.

Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

City staff works with the Saginaw County Consortium of Homeless Assistance Providers (SC-CHAP) to assist in the fight against homelessness. City staff from the Inspections Division and the Police Department are referring individuals that may be displaced due to condemnation or eviction to the County's 211 system to avoid homelessness. City staff attends monthly and quarterly meetings of SC-CHAP where the goals are to reduce homelessness in Saginaw by using a coordinated effort to disseminate information and provide services. Due to the pandemic the City was unable to participate in the point in time count this year.

Addressing the emergency shelter and transitional housing needs of homeless persons

With its ESG and ESG-CV funding the City has supported area shelters that service men, women, children and victims of domestic violence.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

The City is working with the Saginaw County Consortium of Homeless Assistance Providers and its ongoing "Community Conversation". Social service agencies along with public and private institutions are meeting to layer resources, reduce redundancy and guide individuals through a comprehensive coordinated process. The Community Conversation is designed to streamline the application process for any family in need. Officials from the City who are in contact with residents in need of services have been given information cards to keep in their possession and give to those residents whenever possible. The City allocates funds to

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The City is working with the Saginaw County Consortium of Homeless Assistance Providers and its ongoing "Community Conversation". Social service agencies along with public and private institutions are meeting to layer resources, reduce redundancy and guide individuals through a comprehensive coordinated process. The Community Conversation is designed to streamline the application process for individuals in need and reduce the amount of time spent waiting for assistance. Officials from the City who are in contact with residents in need of services have been given information cards to keep in their possession and give to those residents whenever possible. Officials from the City participated in the point in time counts to help identify and help chronically homeless persons. The City participates in community events aimed at making residents aware of available services.

Actions taken to address the needs of public housing

CDBG funds were awarded to the Saginaw Housing Commission to upgrade its fire alarm systems in their mulit unit buildings. In addition to assistance provided from the City's funds the Saginaw Housing Commission was awarded funding as authorized by the CARES Act of the Public Housing Program and the Housing Choice Voucher Program.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

Participants of the Family Self Sufficiency Program receive resources and housing assistance to transition to homeownership. Three participants graduated last year from the program receiving \$36,568 in escrow funds as a result of increased rent portion and wages.

Actions taken to provide assistance to troubled PHAs

The Saginaw Housing Commission has been removed from the list of troubled PHAs.

The City has adopted a form based zoning code. The form based zoning code is designed to remove restrictive and exclusionary controls. The City is working with property owners of vacant properties to make sure fees are charged when reasonable and necessary and not excessive or contradictory to the overall growth goals of the City.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

CDBG funds are used to fund housing rehabilitation programs and public service programs for underserved needs. CDBG funds were used to fund recreation and educational programs for primarily low income persons. The City works with other housing service providers in the community to maximize resources and provide the most essential services to the residents. The City has created a group called the Neighborhood Association Action Group. This group meets on a monthly basis to take and discuss needs of the community.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

The City requires lead safe practices in all of our housing rehabilitation programs. All recipients with children in the home are given information regarding lead based paint. The City does complete abatement in its HOME funded owner occupied housing rehabilitation program. As funds are available the City works with the County Health Department to identify homes for their healthy homes projects.

Due to the pandemic the City was unable to coordinate the ususal meetings to enhance the coordination between agencies. The plan is to reunite the service providers and banks once we are futher along in the pandemic and can encourage participation in a group setting.

The City supports Legal Services of Eastern Michigan and their activities designed to disseminate information about fair housing laws in the City. Due to the pandemic the City unable to host their information booth at City Hall but will continue to do that annually post pandemic.

The City of Saginaw's Community Services Division desk monitors every request for reimbursement received. The City also visits the sub-recipients either annually or bi annually to review all supporting documentation for compliance. Visits were conducted virtually during program year 2020 due to the pandemic. Sub recipients are invited to attend all public hearings and informational sessions to discuss their program needs. The Community Services Division did not hold their annual contractor meeting aimed at the recruitment of minority and women owned businesses this year due to the pandemic but notifications were sent to contractors in the area inviting them to bid on projects. The Community Services Division through the Saginaw Economic Development Corporation also had to cancel its annual business event where minority businesses are encouraged to participate due to Covid-19.but there were several classes held virtually to help businesses find resources and tips to help their business the pandemic. The City has a long standing relationship with Legal Services of Eastern Michigan that is used to further educate the community on matters related to fair housing and discrimination.
