



# Expectations

### **High-Level Expectations**





Determine community needs, not specific projects

10 out of 15 committee members are needed for a meeting to occur

Plans may change. We will stay flexible.

### **Tentative Timeline**



#### March – April

- Identify major buckets
- Define how projects will be reviewed
- Develop submission standards



#### May

- Open up a submission portal for project review
- Engage, educate, and assist community to submit ideas

Everyone takes 3 sticky notes and writes 3 different things that they think are important





**Eligibility Overview** 

## **Policy and Framework**



### **Final Rule**

- ➢ Guidance effective April 1, 2022
- Replaces May 2021 Interim Final Rule
- Recipients can choose to comply w/ Final Rule <u>before</u> April 1, 2022



### Timeframe

- Costs incurred on/after March 3, 2021, unless stated otherwise in guidance
- > **Obligate** by December 31, 2024
- **Expend** by December 31, 2026

### **Eligibility Framework**

#### **Beneficiaries**

Eligible uses may target those **"impacted"** directly by the pandemic and its negative economic consequences, or those **"disproportionately impacted"** who experience disproportionate public health or economic outcomes from the pandemic

#### **Reasonable and Proportional Response**

Uses must **reasonably benefit the individual or class** experiencing the impact. Must be **related and reasonably proportional** to impact extent and type experienced

For disproportionately impacted communities, interventions addressing broader pre-existing disparities which contributed to more severe health and economic outcomes during the pandemic are allowed


### **Qualified Census Tracts**

Anything in purple is eligible for additional programming within the grant.

This is one of many ways to define 'disproportionate impact'

# **Support the Public Health Response**

### **Meet & Address Public Health Needs**

COVID-19 Mitigation & Containment

- > Vaccine programs,
- > Testing & contact tracing,
- Capital improvements to public facilities for pandemic operation



- Disparities in Public Health Outcomes
- Community health workers
- > Public benefits navigators
- Housing services
- > Lead remediation
- Community violence prevention



# Public Health & Safety Staff

Covers 100% of payroll for staff devoted to responding /mitigating COVID-19



#### Public Health Program Improvements

- Improvement to data or technology infrastructure
- Planning and analysis to improve programs responding to COVID-19




#### Medical Expenses

Care and services to address near and long-term medical needs



#### **Behavioral Health Care**

- > Mental health treatment
- Substance misuse treatment
- > Crisis prevention
- Outreach to promote access to primary care and preventative medicine



### Investments

- Programs addressing homelessness
- Affordable housing development
- Housing navigators and voucher programs

#### **Disparities**

- > Early learning programs
- Assistance to high-poverty districts
- Evidence-based educational practices and  $\geq$ student well-being initiatives

### **Environments**

- High quality childcare and home visit services for new parents
- Enhanced services for child welfare and foster youth programs

# **Premium Pay for Essential Workers**

**Additional Pay for Essential Workers for Essential Work** 

#### Eligible Professions Sample

Staff at nursing homes, hospitals, and home-care settings || Workers at farms, food production facilities, grocery stores, and restaurants || Janitors and sanitation workers || Truck drivers, transit staff, and warehouse workers || Public health and safety staff || Childcare workers, educators, and school staff || Social service and human services staff

#### **Premium Pay Eligibility**

Up-to \$13/hr additional wages, not to exceed \$25,000 per worker

- Include positions requiring regular in-person or regular physical handling of items also handled by others
- Additional sectors at recipient's discretion
- Must not increase total compensation above 150% of Stateor-Local average income for FLSA overtime exempt employees
- Should prioritize low- and moderate-income workers facing greatest mismatch between employment-related health risks and compensation
- > Compensation can be retroactive to January 31, 2020



### **Revenue Loss**

### **Providing Government Services**



#### **New Standard Allowance**

- Introduces \$10M revenue loss standard allowance
- Alternative to full revenue loss calculation



"Generally include any service traditionally provided by a government."

### **Government Services Test**

Is this an entity that your government owns or runs?


If not, is this a non-governmental entity that you have supported financially in the past?

If neither of the above, is this something that similar governments spend funds on?



### **Investments in Infrastructure**

### **Critical Needs to Provide Improvements**



- Includes improvements to infrastructure (i.e. <u>building or upgrading facilities</u> and transmission, distribution, and storage systems)
- Eligible uses aligned to EPA Project Categories across Clean Water State Revolving Fund and Drinking Water State Revolving Fund



#### **Broadband**

- Focus on households & businesses without reliable wireline connection (25 Mbps download/3 Mbps upload)
- Funded projects required minimum 100 <u>Mbps download / 100 Mbps upload</u> (unless impracticable)
- Complements <u>broadband investments</u> through Capital Projects Fund
- Can be used as the 25% requirement matching funds to any broadband grant in the Bipartisan Infrastructure Bill

# **Additional Considerations**

### **Administrative Expenses**

- Costs related to disbursing payments of SLFRF & managing new grants programs established under SLFRF
- Portion of payroll & benefits corresponding to time spent on administrative work necessary due to COVID-19

### **Restrictions on Use**

- > Deposit to pension funds
- Non-federal match for other federal programs whose statute or regulations bar the use of Federal funds to meet matching requirements unless specifically called out in the Final Rule
- Offset a reduction in net tax revenue resulting from change in law, regulation, or administrative interpretation
  - During the covered period
  - Reducing any tax or delays the imposition of any tax or tax increase


