Call to Order

- Finance Director Burton welcomed Chelan Meyer to the Finance Department.
- IT Director Chambers welcomed Woody Tovar-Cano to the IT Department and gave an update on projects.
- City Administrator Merriman discussed recruitment for open staff positions and labor negotiations with AFSCME, beginning the annual review on the utility rates, closing of the library project, and the Public Works/Wastewater building project.

Councilmember and Mayor's Reports

- Councilmember mentioned improving the downtown perhaps by adding trees.
- Councilmembers spoke about how fast the City is growing, and that our residents like the small town feel.
- Councilmembers discussed COVID and vaccination concerns.

- 3. City Council Compensation: Ordinance 1992-21
 City Administrator Merriman presented information regarding establishing City Council compensation. City Administrator Merriman and City Attorney Thompson explained elected official's compensation laws and the formation and role of a salary commission to set salaries for elected officials.

A motion to form a salary commission with members appointed by the Mayor and confirmed by the City Council was made by Councilmember de Jong and seconded by Councilmember McGoffin. Motion carried (7-0).
