A ORDINANCE ADOPTED PURSUANT TO SECTION 9(G) OF SECTIONS 10-7C-1 ET SEQ.NMSA 1978, THE RETIREE HEALTH CARE ACT, EXERCISING THE IRREVOCABLE OPTION TO DETERMINE TO BE INCLUDED IN COVERAGE UNDER THE RETIREE HEALTH CARE ACT

WHEREAS, the governing body has reconsidered the issue of retiree health care for its employees, retirees, their spouses and dependents; and

WHEREAS, the governing body has considered the opportunity afforded by the Retiree Health Care Act ("Act"), Sections 10-7C et. Seq. NMSA 1978 to provide retiree health coverages at the single basic plan of benefits rate which may be adjusted from time to time pursuant to Section 13 of the Act. The current single basic plan of benefits rate is \$50.00 – \$55.00 per month with a maximum of 3% annual increases; and

WHEREAS, the governing body has considered that pursuant to Section 15 of the Act, Retiree Health Care Authority participation requires participating employer contributions to the Retiree Health Care Authority fund in the amount of one percent of each participating employee's salary and that each participating employee must contribute an amount equal to one-half of one percent of the employee's salary with said contributions to be made to the RHCA on a monthly basis; and

WHEREAS, the governing body revokes its previous decision to be excluded from coverage by the Retiree Health Care Act and now determines to irrevocably include Colfax County, its governing body members, employees and retirees in the requirements of the employer/employee contributions and retiree benefits under the Act.

NOW, THEREFORE, BE IT ORDAINED by the governing body of the County of Colfax:

Section 1. Thirty days prior to public hearing on this Ordinance on the Retiree Health Care Authority was notified by certified mail of the public hearing on this Ordinance.

Section 2. Pursuant to Section 9 (G) of the Retiree Health Act the County of Colfax determines to be included in coverage under the Retirees Health Care Act.

Section 3. Passed, adopted and approved this 13TH day of June, 2000.
