WHEREAS, the Board of Commissioners of Colfax County, New Mexico is designated as a committee of three officials to oversee and dispose of the aforesaid property, pursuant to NMSA 1978, Section 13-6-1; and

WHEREAS, the Colfax County Commission has determined that none of the aforesaid items of tangible personal property has a resale value of more than \$5,000.00; and

WHEREAS, the Colfax County Commission has determined that the aforesaid items of tangible personal property are worn-out, unusable or obsolete to the extent that such items are no longer economical or safe for continued use for their intended purpose by Colfax County;

THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Colfax County, New Mexico, as follows:

- A. That the Colfax County Commission hereby designates the Board of Commissioners as the authorized committee to approve and oversee disposition of the aforesaid items of tangible personal property, pursuant to NMSA 1978, Section 13-6-1B(1);
- B. That the Colfax County Commission hereby finds that none of the aforesaid items of tangible personal property has a resale value of more than \$5,000.00;
- C. That the Colfax County Commission hereby finds that the aforesaid items of tangible personal property are worn-out, unusable or obsolete to the extent that such items are no longer economical or safe for continued use for their intended purpose by Colfax County;
- D. That the Colfax County Commission hereby authorizes and directs the Colfax County Manager to give notification to the State Auditor, pursuant to NMSA 1978, Section 13-6-1B(2);
- E. That, unless an objection is received from the State Auditor, the Colfax County Commission authorizes and directs the Colfax County Manager to surplus and dispose of said vehicles through transfer or donation to another governmental entity or sale by sealed bid or public auction, pursuant to NMSA 1978, Section 13-6-1D, at least thirty days after providing the State Auditor notification as directed above.
