**RESOLUTION 2018-09**

**Solid Waste Fee - FY 2018**

**WHEREAS**, Colfax County regulates the collection and disposal of refuse (Solid Waste) for the health, safety and welfare of the public; and

**WHEREAS**, Colfax County is authorized to establish, assess and collect fees to pay the necessary costs of a refuse collection and disposal system pursuant to §4-56-3, NMSA 1978 and Colfax County Ordinance 2015-04; and

**WHEREAS**, Colfax County Commissioners have reviewed Solid Waste Revenues and Expenses for FY 2017 and has determined a fee increase is necessary for FY 2017;

**THEREFORE, BE IT RESOLVED**, that the Board of County Commissioners of Colfax County, New Mexico, hereby, authorizes the annual Solid Waste Fee for FY 2018 of \$210.00 (including gross receipts tax) for all Colfax County persons, businesses and residences within Colfax County, excluding those within the boundaries of municipalities; and

**BE IT FURTHER RESOLVED**, that all commercial properties or residences that maintain dumpsters for private use only be charged \$70.00 per month per dumpster plus gross receipts tax,

**BE IT FURTHER RESOLVED**, that the Board of County Commissioners of Colfax County, New Mexico, hereby, authorized the following collection process:

Bills for Resident Solid Waste Management fee are mailed annually, in advance. Private and Commercial Billing are mailed quarterly. A 1.5% late fee will be assessed monthly beginning May 1, 2018 on delinquent amounts.

**BE IT FURTHER RESOLVED**, that the Board of Colfax County Commissioners, Colfax County, New Mexico, hereby, reserves the right to file a lien on any properties who's Solid Waste fees are past due in excess of two years. A "Lien Letter" will be sent out certified mail, the delinquent account will be charges for the letter and recording fees.
