COTTONWOOD COUNTY DIRECT PAYMENT PLAN FOR PROPERTY TAXES

Cottonwood County provides a fast, convenient, hassle-free way to pay your property taxes with our Direct Payment Plan. With this plan, you can have your property tax payment automatically deducted from your checking or savings account on an annual or semi-annual basis.

The Direct Payment Plan will help you:

- Save time writing and mailing checks
- Save money in postage and bank fees
- Eliminate the worry of late payment/lost checks and associated penalties
- Know your tax payment is always made on time—even if you're working in the fields or out of town on business or vacation

How does the Direct Payment Plan work?

You authorize payments to be made from your checking or savings account according to the following schedule:

*May 15	Full year tax payment
*May 15	½ of the annual tax payment
*October 15 (Non Ag parcels)	½ of the annual tax payment
*November 15 (Ag parcels)	½ of the annual tax payment

*Note: If due date falls on a weekend, payment will be withdrawn on the following Monday. Proof of payment will appear on your bank statement. The authority you give Cottonwood County to charge your account will remain in effect until YOU notify us **in writing** to terminate the authorization.*

If we receive this form by SEPTEMBER 15th – your first direct payment will be set up for second ½ taxes due Oct. 15th or Nov. 15th.
